Seven Hundred and Ninety-two, shall be of any Force or Effect: And His Majesty is hereby further pleased to order, That the Master, or Person having the Charge of Command of any Ship or Vessel to whom such Licence shall be granted, shall, upon the Arrival of the faid Ship or Vessel at the Port, Harbour or Place in the Island of Newfound land where he shall discharge such Bread, Flour, or Indian Corn, deliver up the faid Licence to the Collector or other proper Officer of the Castoms there, having first indersed on the Back of such Licence the Marks, Numbers and Contents of each Package of Bread, Flour, or Indian Corn, under the Penalty of the Forfeiture in the said A& mentioned. And the Collector or other proper Officer of the Customs at Newfoundland is hereby enjoined and required to give a Certificate to the Master, or Person having the Charge or Command of such Ship or Vessel, of his having received the said Licence, so indorsed as before directed, and to transmit the same to the Commissioners of His Majesty's Customs in England or Scotland, or to the Commissioners of His Majesty's Revenue in Ireland, respectively, by whom fuch Licence was granted.
