1793, directly or indirectly, export, transport, carry or convey, or cause or procure to be exported, transported, carried or conveyed, out of or from any Port or Place in Great Britain, or load or lay on Board, or cause or procure to be loaded or laid on Board of any Ship, Vessel or Boat, in order to be exported or carried out of any Port or Place in Great Britain, any Barley, Beer or Bigg, or Meal, Flour, Malt, Bread or Biscuit made of Barley, Beer or Bigg: His Majesty nevertheless, by the Advice aforesaid, hath thought fit to order, and doth hereby order, that nothing herein contained shall extend, or be construed to extend, to prohibit the Exportation of any Foreign Barley, Beer or Bigg, or Meal, Flour, Malt, Bread or Biscuit made of Barley, Beer or Bigg, which shall have been imported into this Kingdom, and warehoused in the Manner and upon the Conditions mentioned in an Act passed in the Thirtyfirst Year of His Majesty's Reign, intituled, " An " Act for regulating the Importation and Exporta-" tion of Corn, and the Payment of the Duty on " Foreign Corn imported, and of the Bounty on " British Corn exported;" nor to prohibit the carrying Coastwife, or the carrying out and exporting of Barley, Beer or Bigg, or Meal, Flour, Malt, Bread or Biscuit made of Barley, Beer or Bigg, in the Manner and in the same Proportions and Quantities, and from and to the same Ports and Places, as is by the faid Act allowed, at fuch Times as Barley, Beer or Bigg, or Meal, Flour, Malt, Bread or Biscuit made of Barley, Beer or Bigg, are prohibited to be exported, by Reafon of the Price of Barley, Beer or Bigg, or Meal, Flour, Malt, Bread or Biscuit made of Barley, Beer or Bigg, being at or above the Prices mentioned in Table B. in the faid Aft contained, subject to the like Securities, Conditions, Regulations and Restrictions, Forfeitures and Penalties as are required and imposed by the faid Act, or by any other Act now in Force, in any of the Cases aforesaid: And the Right Honorable the Lords Commissioners of His Majesty's Treasury are to give the necessary Directions herein accordingly.

Hereas an Act of Parliament was passed in the Twenty-ninth Year of the Reign of His late Majesty King George the Second, intituled, "An Act to impower His Majesty to prohibit se the Exportation of Salt Petre, and to enforce " the Law for impowering His Majesty to proof hibit the Exportation of Gunpowder, or any

in the London Gazette, until the rft Day of March, I" Sort of Arms and Ammunition; and also to " impower His Majesty to restrain the carrying a Coastwife of Salt Petre, Gunpowder, or any " Sort of Arms of Ammunition:" And His Majesty, judging it necessary to prohibit the Exportation of Gunpowder or Salt Petre, or any Sort of Arms or Ammunition, out of this Kingdom; or carrying the same Coastwife, for some Time, doth, therefore, with the Advice of His Privy Council, hereby order, require, prohibit and command, that no Person or Persons whatsoever (except the Master-General of the Ordnance, for His Majesty's Service) do at any Time, during the Space of Six Months from the Date of this Order in Council, presume to transport into any Parts out of this Kingdom, or carry Coastwife, any Gunpowder or Salt Petre, or any Sort of Arms or Ammunition, or ship or lade any Gunpowder or Salt Petre, or any Sort of Arms of Ammunition, on Board any Ship or Vessel, in order to transporting the same into any Parts beyond the Seas, or carrying the same Coastwife, without Leave of Permission in that Behalf first obtained from His Majesty, or His Privy Council, upon Pain of incurring and fuffering the respective Forseitures and Penalties inflicted by the aforementioned Act: And the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Master General of the Ordnance, and His Majesty's Secretary at War, are to give the necessary Directions herein, as to them may respectively appertain.
