Brunswick, from any Country belonging to the "United States of America;" it is, amongst other Things, enacted, That it shall and may be lawful, from and after the Tenth Day of July, 1793, to import into fuch Port or Ports in the Islands called Caicos, as shall be approved of by His Majesty in Council, Sugar and Coffee, the Produce of any Foreign Country or Plantation, in fuch Foreign Ships, and subject to such Regulations as are prescribed in the faid Three Acts, passed in the Twenty-seventh, Thirtieth, and Thirty Second Years of His profent Majesty's Reign, with respect to the Ports therein mentioned: His Majesty, by and with the Advice of His Privy Council, doth hereby approve of the Port of St. George's Harbour, in the Grand: Caicos, one of the faid Islands called Caicos, to be a Port for the Importation of Sugar and Coffee, the Produce of any Foreign Country or Plantation, in fuch Foreign Ships, and subject to such Regulasions as are prescribed in the said Acts .- And the Right Honorable the Lords Commissioners of His Majesty's Treasury, and the Lords Commissioners of the Admiralty, are to give the necessary Directions herein as to them may respectively appertain.
