P R E S E N T, The KING's Most Excellent Majesty in Council.

HEREAS by an Act of Parliament passed in the Twenty-fixth Year of His late Majesty's Reign, intituled, " An Act to oblige Ships " more effectually to perform their Quarantine, " and for the better preventing the Plague being " brought from Foreign Parts into Great Britain " or Ireland, or the Isles of Guernsey, Jersey, " Alderney, Sark or Man," it is, among many other Things, enacted, That all Ships and Veffels arriving, and all Perfons, Goods and Merchandizes whatfoever, coming or imported into any Port or Place within Great Britain, or any of the Isles beforementioned, from any Place from whence His Majesty, His Heirs or Successors, by and with the Advice of His or Their Privy Council, shall judge it probable that the Infection may be brought, shall be obliged to make their Quarantine in fuch Place and Places, for fuch Time, and in fuch Manner, as has been or shall, from Time to Time, be directed by His Majefly, His Heirs or Succeffors, by His or Their Order or Orders, made in His or Their Privy Council, and notified by Proclamation, or published in the London Gazette; and that until fuch Ships, Veffels, Perfons, Goods and Merchandizes shall have respectively per-

formed and be discharged from such Quarantine, no fuch Perfons, Goods or Merchandizes, or any of them, shall come or be brought on Shore, or go or be put on board any other Ship or Veffel, in any Place within His Majesty's Dominions, unless in fuch Manner, and in fuch Cafes, and by fuch Licence, as shall be directed or permitted by fuch Order or Orders made by His Majefty, His Heirs or Succeffors, in Council as aforefaid; and that all fuch Ships and Veffels, and the Perfons or Goods coming or imported in, or going or being put on board the fame, and all Ships, Veffels, Boats and Perfons receiving any Goods or Perfons out of the fame, shall be subject to such Orders, Rules and Directions concerning Quarantine, and the Prevention of Infection, as have been or Ihall be made by His Majesty, His Heirs and Successors, in Council, and notified by Proclamation or published in the London Gazette as aforementioned, under fuch Pains and Penalties as are inflicted by the faid Aft.

And whereas Information has been received that a malignant and epidemick Fever, of the Nature of the Plague, now prevails in the City of New York, and in the Town of Norfolk in Virginia, within the United States of America; His Majefty, by and with the Advice of His Privy Council, judging it probable that the faid Infection may be brought into this Kingdom from those Places, dota

of the Publick Health, to order, and it is hereby ordered, That all Ships, Veffels, Perfons, Goods and Merchandizes now arrived, or that fhall hereafter arrive in any Port of this Kingdom, or the Ifles of Guernfey, Jerfey Alderney, Sark or Man, from the Ports of New York and of Norfolk in Wirginia, do make their Quarantine for Fourteen Days, which is to commence and be computed from the Day each Ship or Veffel shall come to Anchor in the Place appointed for the Performance of Quarantine, and not before.

That the Places herein after named shall be and are hereby appointed to be the Places wherein fuch Ships or Veffels (not having the Infection on board) shall respectively perform Quarantine; that is to fay: All Ships or Veffels which are or shall be bound to the Port of London, or any Member, Creek, or other Parts thereof, or to the River Thames or Medway, shall perform their Quarantine in Standgate Creek ; all Ships or Veffels which are or shall be bound to the Ports of Ipfwich, Yarmouth, Lynn, Boston, Hull, Newcastle or Berwick upon Tweed, or any of them, or any Member or Creek thereof, or other Place therein, shall perform their Quarantine in Whitebooth Road, between Hull and Grimiby; all Ships or Veffels which are or shall be bound to the Posts of Carlifle and Chefter, or either of them, or any Member or Creek thereof, or other Place therein, or to any Part of the Isle of Man, shall perform wheir Quarantine in a Place called Highlake, near Liverpool, at the Well End thereof; all Ships or Veffels which are or shall be bound to the Ports of Milford, Cardiff, Gloucester, Brittol, Bridgwater, or any of them, or any Member or Creek of them, or any of them, or to Padstow or St. Ive's, being Members of the Port of Plymouth, or to Ilfracombe or Barnsteple, being Members of the Port of Exeter, or to any other Place within the faid Ports of Milford, Cardiff, Gloucester, Brittol or Bridgwater, or within the faid Members or Creeks, Shall perform their Quarantine in Kingroad and Porfhete Pill; all Ships or Veffels which are or fall be bound to the Port of Plymouth, except fuch Parts thereof as have been herein before mentioned, or to the Port of Exeter, except fuch Parts thereof as have been herein before mentioned, or to the Port of Pool, or any of the Members or Creeks or other Places within the faid Ports of Plymouth, Exeter and Pool, except as herein before excepted, or to Falmouth, a Member of the Port of Plymouth, or any Creek thereof, or any other Place therein,

doth thereupon deem it expedient, for the Safety | fhall perform their Quarantine in a Place called St. Ive's Pool, within the Mouth of the Harbour of Falmouth ; all Ships or Veffels which are or shall be bound to the Ports of Southampton, Chichester, Sandwich, or any of them, or any of the Members or Creeks thereof, or of any of them, or any other Place within the fame, shall perform their Quarantine at a Place called the Mother-Bank, near Portfmouth; all Ships or Veffels which are or fnall be bound to the Eastern Coast of Scotland, comprehending the Ports of Leith, Borrowstonefs, Alloa, Dunbar, Kirkaldy, Anstruther, Preston-Pans, Dundee, Perth, Montrofe and Aberdeen, or to any Member, Creek or other Parts thereof, shall perform their Quarantine in Inverkeithing Bay; all Ships or Veffels which are or thall be bound to the Weffern Ports of Scotland, comprehending the Ports of Port Glafgow, Greenock, Irvine, Campbeltoun, Oban, Rothfay, Fort William, Air, Port Patrick, Stranraer and Wigtoun, or to any Member, Creek or other Parts thereof, shall perform their Quarantine at Lamlash in the Island of Arran; all Ships or Vessels which are or shall be bound to the Northern Ports of Scotland, comprehending the Ports of Invernefs, Zetland, Orkney, Caithnefs and Stornaway, or to any Member, Creek or other Parts thereof, shall perform their Quarantine in Cromarty Bay in the Murray Firth; all Ships or Vessels which are or shall be bound to the South-Weft Ports of Scotland, comprehending the Ports of Dumfries and Kirkcudbright, or to any Member, Creek or other Parts thereof, shall perform their Quarantine at Carithorn, at the Mouth of the River Nich; all Ships or Veffels which are or shall be bound to the Iste of Jerfey, or any Part thereof, shall perform their Quarantine at a certain Place on the Coaft of the faid Island, called Belle Croute, or at fome Piace herein before appointed for Performance of Qua. rantine on the Coaft of England; and all Ships or Veffels which are or shall be bound to the Islands of Guernfey, Sark or Alderney, or either of them, or any Part of them, or any of them, shall perform their Quarantine in a Place near the Island of Guernley, called the Little Road, or at fome Place herein before appointed for Performance of Quarantine on the Coaft of England.

> That no Pilot shall go on board, any Ship or Veffel obliged to perform Quarantine, in order to conduct the fame into any Port or Place, but fhall perform fuch Service in fome other Boat or Veffel, which Boat or Voffel thall keep as much to the Windward of the Ship or Veffel to to be conducted

as possible; and if any Pilot or other Perfon shall go on board such Ship or Vessel, such Pilot or other Person shall perform Quarantine, in like Manner as any Person coming in such Ship or Vessel shall be obliged to perform the same.

That all Goods, Wares and Merchandizes liable to Quarantine as aforefaid, shall be opened, unpacked and aired, unlefs His Majefty shall think fit, by His Order in Council, to direct otherwife, and fo remain a Week, other than Hemp and Flax, Paper or Books, Silk raw, thrown or wrought, Linen, Cotton-Wool, Cotton-Yarn or manufactured, Wool raw or any wife wrought, Feathers, Grogram or Mohair Yarn, Human Hair, Goats Hair, Carmenia Wool, Carpets, Camblets, Burdets, or other Manufactures of Silk and Cotton, Kid-Skins, and Skins in the Wool or Hair, Sponges, Wine and Oil in Chefts, Thread Stockings, all Goods packed with Straw or Cotton, Straw Hats and Brefhes, Matting, and Artificial Flowers; which Goods and Merchandizes, fo as aforefaid enumerated, are to be opened, unpacked and aired, unless His Majefty shall think fit, by His Order in Council, to direct otherwife, and fo remain for the Space of a Fortnight.

That all Goods imported by fuch Ships and Veffels respectively shall be aired in the following Places, that is to fay : All fuch Goods as shall be imported to the Port of London, or any Member, Creek or other Parts thereof, or to the River Thames or Medway, shall be aired in Standgate Creek ; all fuch Goods as shall be imported to the Ports of Ipfwich, Yarmouth, Lynn, Bofton, Hull, Newcastle, or Berwick upon Tweed, or any of them, or any Member or Creek thereof, or other Place therein, shall be zired in Whitebooth Road, between Hull and Grimfby; all fuch Goods as shall be imported to the Ports of Carlifle and Chefler, or either of them, or any Member or Creek thereof, or other Place therein, or to any Part of the Ifle of Man, fuall be aired in a Place called Highlake, near Liverpool, at the West End thereof; all fuch Goods as shall be imported to the Ports of Milford, Cardiff, Gloucester, Briftol, Bridgwater, or any of them, or any Member or Creek of them, or any of them, or to Padstow or St. Ive's, being Members of the Port of Plymouth, or to lifracorabe or Barnstaple, being Members of che Port of Exeter, or to any other Place within the faid Ports of Milford, Cardiff, Gloucefter, Briffol or Bridgwater, or within the faid Members or Creeks, shall be aired in King Road and Forthute Pill; all fuch Goods as thall be

imported to the Port of Flymouth, except fuch Parts thereof as have been herein before mentioned, or to the Port of Exeter, except fuch Parts thereof as have been herein before mentioned, or to the Port of Pool, or any of the Members, or Creeks or other Places, within the faid Perts of Plymouth, Exeter and Pool, except as before excepted, or to Falmoath, a Member of the Port of Plymouth, or any Creek thereof, or any other Place therein, shall be aired in a Place called St. Ive's Pool, within the Mouth of the Harbour of Falmouth; all fuch Goods as shall be imported to the Ports of Southampton, Chichefter, Sandwich, or any of them, or any of the Members or Creeks thereof, or of any of them, or any other Place within the fame, shall be aired at a Place called the Motherbank, near Portfmouth; all fuch Goods as shall be imported to the Eastern Coaft of Scotland, comprehending the Ports of Leith, Borrowflonefs, Alloa, Dunbar, Kirkaldy, Anstruther, Preston-Pans, Dundee, Perth, Montrofe, and Aberdeen, or to any Member, Creek, or other Parts thereof shall be aired in Inverkeithing Bay; all fuch Goods as shall be imported to the Western Ports of Scotland, comprehending the Ports of Port Glafgow, Greenock, Irvine, Campbeltoun, Oban, Rothfay, Fort William, Air, Port Patrick, Stranraer, and Wigtoun, or to any Member, Creek, or other Pasts thereof, shall be aired at Lamlash, in the Island of Arran; all fuch Goods as shall be imported to the Northern Ports of Scotland, comprehending the Ports of Invernefs, Zetland, Orkney, Caithnefs and Stornaway, or to any Member, Creek, or other Parts thereof, shall be aired in Cromaty Bay, in the Murray Firth ; all fuch Goods as fhall be imported to the South-Weft Ports of Scotland. comprehending the Ports of Dumfries and Kirkcudbright, or to any Member, Creek or other Parts thereof, shall be zired at Cartlhorn, at the Mouth of the River Nith ; all fuch Goods as shall be imported to the Ifle of Jerfey, or any Part thereof, shall be aired at a certain Place on the-Coaft of the faid Ifland called Belle Croute, or at fuch Place hereinbefore appointed for Performance of Quarantine on the Coaft of England, where the Ships in which fuch Goods are imported fhall respectively perform their Quarantine; and all fuch Goods as shall be imported to the Islands. of Guernfey, Sark or Alderney, or either of them, or any Part of them, or any of them, shall be aired in a Place near the Island of Guernsey, called the Little Road, or at fuch Place herein before appointed for Performance of Quarantine on the-

Coaft.

Coaft of England, where the Ships in which fuch Goods are imported shall respectively perform their Quarantine.

That whatfoever Ship or Perfon shall receive any Men or Goods from on Board any Ship or Veffe under Quarantine, shall be compelled to perform the like Quarantine.

That such Persons as, after Quarantine performed, shall be employed in the Hold of any Ship or Veffel, for the taking any Goods not liable to retain Infection, from the Goods and Merchandizes before enumerated, shall be obliged to perform a new Quarantine.

That the Captains of every His Majefty's Ships of War, who shall meet any fuch Ship or Vessel coming to any of the Ports of Great Britain, or of the Isles of Guernfey, Jerfey, Alderney, Sark or Man, shall take due Care to prevent the landing any Goods, Seamen or Passengers from on Board the fame, until they shall be put under the Direction of the Officers of His Majefty's Cultoms.

That the Commissioners and other Officers of His Majesty's Customs do use their utmost Diligence and Care that the Quarantine before directed be duly performed.

That the Commanders of His Majefty's Ships of War, as likewife the Commanders of His Majefty's Forts and Garrifons lying near the Sea Coafts, and all the Juffices of the Peace, Mayors, Sheriffs, Bailiffs, Chief Magistrates, Constables, Headboroughs, Tythingmen, and all other Officers and Ministers of Justice, be aiding and affishing to the faid Officers of His Majefty's Cuftoms, and to all others that shall be concerned in stopping all such Ships as aforefaid, and in bringing them to the Places appointed for the Performance of their Quarantine, and in due Performance thereof.

And the Lords Commiffioners of His Majefty'-Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Mafter General and the reft of the Principal Officers of the Ordnance, His Majesty's Secretary at War, and the Governors or Commanders in Chief for the Time being of the faid respective Isles of Jersey, Guernfcy, Alderney, Sark and Man, are to give the neceffary Directions herein, as to them may refpectively appertain. His Majesty's Ship Fortitude, October 12, 1795, Cape Finisterre, by Account, bearing East about 16 or 17 Leugues.

SIR.

BE pleafed to acquaint my Lords Commissioners of D the Admiralty I left Gibraltar Bay the z4th cf September, taking the first Spirt of an Easterly Wird after my Letter written their Lordships of the 21st of the fame Month, when the Wind was wefterly.

In coming through the Gut in the Night His Majefly's Ships Argo and Juno, with fome of the Ships, parted Company, and, I conclude, by iteering more to the Northward than myself with the other Man of War and Body of the Convoy, it being near Dafk in the Evening before many got out of Gibraitar Bay, though the Fortitude was under Weigh with the much greater Part by Ten A. M.; but, on the whole, their Separation has turned out a most fortunate Circumstance; for, with great Regret, I am to inform their Lordships, that on the 7th Instant, Cape St. Vincent, by Account, bearing S. 83 E. 48 Leagues, the Wind N. by W. flanding on the Lar-board Tack, I difcovered Nine Sail of the Enemy's Ships, Six of the Line, Two of which I judged to be of 80 Guns, and Three large Frigates, who directly gave Chace to His Majeity's Ships under my Command and Convoy, under a Prefs of Sail. I made every pollible Difpolition for the better Security of the Convoy by divers Signals, and which, had many of them been punctually obeyed, a much greater Number would have efcaped. I then formed the Line, with the Bedford, Cenfeur and Fortitude, determined, if possible, to give them Battle, and fave as many of the Convoy as I possibly could.

Juit as the Ships under my Command had formed, the Cenfeur rolled away her Fore Topmaft; by which, having only a Frigate's Mainmaft, fihe was rendered ufelefs. The Van Line of Battle Ship of the Enemy then but long Gun-Shot off, and the refl. coming fail up, I judged it proper, with the general Opinion of my Officers, coincided with that of Captain Montgomery of the Bedford, to bear up, keeping very near together for our mutual Support, and cutting down every Part of the Stern for the Chace Guns. I ordered the Lutine Frigate directly to take the Cenfeur in tow, but, from the very heavy Fire from the Enemy's Van Ship, it could not be effected.

Captain Gore, who commanded her, though in the difabled State his Ship was in, not half manned, (and but very little Powder) made the most gallant Majesty's Chancellor of Great Britain, and the Heirs | Defence; but being overpowered at last, by Two Male of his Body lawfully begotten, the Dignity of | Sail more of the Enemy's Line coming up, I had the

The Bedford and Fortitule hopt up their mutual Fire from their Stern Chubes from all the Ducks; and about One riour allerwards the Enemy hauted their Wind on different Tacks, to fire on the Con-voy as they came up with them. The Three Frigates from the first employed themicives on that Service.

When I fift made the Enemy's Force to be of fuch Linguitude as to leave no Flopes of laving the Convoy, I unperiod them by Signal, and I believe many efc. ad; at leaft Fifteen Sait I am fure chi. For farther Particulars 1 mult refer their Lordinips to Capt ... Turner, the Bearer of these Diffatches, who, which Captain Haggert of the Lutine, I must beg Lauve to recommend to takir hordinips as very diferving Odicits.

Had the Enemy come to clofe Action with the Bedford and myfelf, I am well affared every Effort would have been uied by Captain Montgomery, his Officers and Ship's Company, and more fully to from the handforme Support he gave me while the Firing continued, for His Majefty's Service and our muta I Support.

My Outcers and Ship's Company behaved with that Cooliefs that generally attends British Scamen in fuch Cafes, and I am fare would have fought the Snip to the fait Moment, had the Enemy come up. I flatter myfolf every Thing was done, firit to fave the Convoy, and afterwards His Majerty's Ships; and I hope and truft my Conduct in this unfortunate Badaefs will meet His Majefty's and their Lordfhips Approbation.
