AT the Court at St. James's, the 30th of November, 1796,

PRESENT,

The KING's Most Excellent Majesty in Council.

HIS Day his Grace John Duke of Roxburgh,
Groom of the Stole to His Majesty, was, by
His Majesty's Command, sworn of His Majesty's
Most Honorable Privy Council, and took his Place
at the Board accordingly.

His Majesty having been pleased to appoint Charles Green, Esq; to be Captain General and Governor in Chief of His Majesty's Island of Grenada, he this Day took the Oaths appointed to be taken by the Governors of His Majesty's Plantations.

AT the Court at St. James's, the 30th of November, 1796,

PRESENT,
The KING's Most Excellent Majesty in Council.

HEREAS the Time limited by His Majesty's
Order in Council of the 1st of June last,
for prohibiting the Exportation out of this Kingdom, or carrying Coastwife, Gunpowder or Salt-Petre, or any Sort of Arms or Ammunition, will expire upon the 7th Day of December next: And
whereas it is judged expedient for His Majesty's
Service, and the Safety of this Kingdom, that the
said Prohibition should be continued for some Time
longer; His Majesty doth therefore, with the Advice of His Privy Council, hereby order, rerespectively appertain.

quire, prohibit and command, that no Person or Persons whatsoever (except the Master-General of the Ordnance for His Majesty's Service) do, at any Time during the Space of Six Months, to commence from the faid 7th Day of December next, pres fume to transport, into any Parts out of this Kingdom, or carry Coastwife, any Gunpowder or Salta Petre, or any Sort of Arms or Ammunition, or ship or lade any Gunpowder or Salt-Petre, or any Sort of Arms or Ammunition, on board any Ship or Vessel, in order to transporting the same into any Parts beyond the Seas, or carrying the same Coastwise, without Leave or Permission in that Behalf first obtained from His Majesty, or His Privy Council, upon Pain of incurring and fuffering the respective Forfeitures and Penalties inflicted by an Act passed in the Twenty ninth Year of His late Majesty's Reign, intituled, " An Act to impower His Majesty to pro-" hibit the Exportation of Salt-Petre, and to enforce " the Law for impowering His Majesty to prohibit " the Exportation of Gunpowder, or any Sort of "Arms or Ammunition; and also to empower His " Majesty to restrain the carrying Coastwise of Salt-" Petre, Gunpowder, or any Sort of Arms or Am-" munition:" - And the Right H nourable the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Master-General of the Ord. nance, and His Majesty's Secretary at War, are to give the necessary Directions herein as to them may Steph.
