I Have the Honor to acquaint you of the Capture of Le Trompeuse French Schooner Privateer, (of Morlaix) of Six Guns and Forty Men, out Five Days, and had only taken Two Pruffian Veffels belonging to Embden; one bound to Liverpool, the other to Oporto. The Spitfire was prefent Sunday last at the Recapture of a Brig by the Unité.
