Council, upon Pain of incurring the Forfeitures inflicted by an Act, passed in the Thirty-third Year of His Majesty's Reign, intituled, "An Act to enable His Majesty to restrain the Exportation of Naval Stores, and more effectually to prevent the Exportation of Salt-Petre, Arms and Ammunition, " when prohibited by Proclamation or Order in "Council." But it is, nevertheless, His Majesty's Pleasure, that nothing herein contained shall extend, or be construed to extend, to any of His Majesty's Ships of War, or any other Ships or Vessels or Boats, in the Service of His Majesty, or employed or freighted by His Majesty's Board of Ordnance, or by the Commissioners of His Majesty's Navy; nor to prevent any Ship or Vessel from taking or having on Board such Quantities of Naval Stores as may be necessary for the Use of fuch Ship or Vessel during the Course of her intended Voyage, or by Licence from the Lord High Admiral of Great Britain, or the Commissioners of the Admiralty for the Time being; nor to the Exportation of the faid several Articles to Ireland, or to His Majesty's Yards or Garrisons, or to His Majesty's Colonies or Plantations in America or the West Indies, or to Newfoundland, or to His Majesty's Forts and Settlements on the Coast of Africa, or to the Island of St. Helena, or to the British Settlements or Factories in the East Indies; provided that, upon the Exportation of any of the faid Articles, for the Purposes of Trade, to Ireland, or to His Majesty's Yards or Garrisons, or to His Majesty's Colonies and Plantations in America or the West Indies, or to the Island of Newfoundland, or to His Majesty's Forts and Settlements on the Coast of Africa, or to the Island of St. Helena, or the British Settlements or Factories in the East Indies, the Exporters of such Articles do first make Oath of the true Destination of the fame to the Places for which they shall be entered Outwards, before the Entry of the same shall be made, and do give full and sufficient Security by Bond, to the Satisfaction of the Commissioners of His Majesty's Customs, to carry the said Articles to the Places for which they are so entered Outwards, and for the Purpoles specified, and none other; and such Bond shall not be cancelled or delivered up, until Proof be made, to the Satisfaction of the faid Commissioners, by the Production, within a Time to be fixed by the faid Commifsioners, and specified in the Bond, of a Certificate or Certificates, in such Form and Manner as shall be directed by the faid Commissioners, shewing that the faid Articles have been duly landed at the Places for which they were entered Outwards. And the Right Honourable the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, and the Lord Warden of the Cinque Ports, are to give the necessary Directions herein, as to them may respectively appertain. M/E, your Majesty's most dutiful and faithful Subjects, the Gentlemen, Clergy, Merchants, Coal-Owners, Ship-Owners, and Inhabitants of the Town and County of Newcastle upon Tyne, and it's Environs, impressed with the most lively Sentiments of Loyalty and Attachment to your Majesty's Person and Government, beg Leave to approach the Throne, at the present critical and momentous Period, to express our firm Determination zealously to support our most excellent Consti-tution, from which we derive the many Blessings and Advantages we now enjoy; and to use our utmost Endeavours to render inefficient every Attempt to endanger it; and also to oppose and discourage the holtile and wicked Defigns of all our foreign and internal Foes, and whatever may tend to disturb the Peace and Order of Society in this Country.

Fully sensible that the Safety and Welfare of your Majesty's Kingdoms, especially at this important Criss, depend upon the Unanimity and strenuous Exertions of your Majesty's loving Subjects, we unfeignedly beg Leave to assure your Majesty, that we are ready and willing to aid and affift the Executive Power, and co-operate with Parliament in any Measures which they in their Wisdom shall deem necessary and expedient, for restoring Subordination and Discipline in that Part of your Majesty's Navy now in a State of Muriny and Rebellion; for maintaining Harmony and Tranquillity in our Country, and for preferving inviolate our most glorious and invaluable Constitution.

We also crave Permission to assure your Majesty that it is our earnest and united Prayer, that your Majesty may foon see Peace restored to your Kingdoms, and that you may long and happily reign over a free, loyal and obedient People.
