The KING's Most Excellent Majesty in Council.

W HEREAS His Majesty was graciously pleased, by His Royal Proclamation bearing Date the Twenty-fixth Day of December, 1792, to promife and declare, that the Bounties of Five Pounds for every Able Seaman, and Two Pounds Ten Shillings for every Ordinary Seaman, fit for His Majefly's Service, fhould be paid in the Manner thereby directed to every fuch Able and Ordinary Seaman, not above the Age of Fifty nor under the Age of Twenty Years, who fhould, on or before the Twenty-eighth Day of February then following, enter themfelves to ferve in His Majetty's Rojal Navy, either with the Captains or Lieutenants of His Majelly's Ships or Veffels, or Officers employed on Shore for raifing Men for the Service of the Koyal Navy: And whereas His Majetty was alfo gracioully pleafed, by his faid Proclamation, to declare, that all Able-bodied Landmen, not above the Age of Thirty five nor under the Age of Twenty Years, who should fo enter themfelves as aforefaid, should receive the Control of Thirty Scille Age of Thirty five nor enter themielves as alorelaid, hould receive the Sum of Thirty Shillings each Man, as His Ma-jefty's Royal Bounty: And whereas His Majefty was also graciously pleased, by His Royal Procla-mation bearing Date the Sixteenth Day of the faid Month of February, 1793, to promite and de clare, that a Reward of 1 wenty Shillings for every Able and Ordinary Scaman, fit to ferve on board His Majefty's Shins (hould be poind to board His Majesty's Ships, should be paid to any Perfon who thould difcover any Seaman or Seamen who might conceal him or themfelves, fo that such Seaman or Seamen should be taken for His Majesty's Service, on or before the Thirtieth Day of April then next, by any of His Majelfy's Sea Officers appointed to raife Men on Shore, or by the Captains or Commanders of any of His Majefty's Ships or Vessels in the Ports or on the Coafts of this Kingdom: And whereas the Time limited by the faid Proclamations for Payment of the faid Bounties and Reward, hath been prolonged

Letter, of which the following is an Extract, has been received from Peter Le Mefurier, Elq; Governor of the Island of Alderney, by the Right Honorable Henry Dundas, one of His Ma-j: ity's Principal Secretaries of State, dated Alderney, the 25th of December, 1797.

I Have the Honor of informing you, that Yelterday Asternoon, at Three o'Clock, a French Cutter Privater had the Boldners to chafe the Ann Cutter, of Haftings, clofe ander one of our Batteries, which the was juit on the Point of Boarding with her Boat, when the Battery opened and obliged the French to theer off.

Having observed that the English Veffel outsailed the Enemy whils there was a Breeze, and that the Privateer was not of great Force, I judged it pro-bable that the might of captured by the Troops of the Garrifon, and therefore ordered a Detachment, with an Officer, to embark in the fame Veffel that had been chafed, and in another, that fortunately happened to be in the Road, having previously promiled some Gratuity to the Owners, aad in a few Hours I learned, with much Satisfaction, that the Privateer was brought into our Harbour. She proves to be the Epervier, Captain Fierce,

with 24 Men, mounting 3 Guns, 2 Swivels, and Small Armis, belonging to Dunkirk, but fitted out from Cherburgh, on a Fortnight's Cruize from the the 117th Inflant; had, on the 21th, taken the Brig and extended to the Thirty-first Day of this instant | Ann, 'Le Hirrel, Matter, from Galpé to Jerley,

with Fish, and Yesterday Morning a small Vessel | bound from hence to England, both which Captures had been noticed from this Ifland.

I cannot too much praife the Readinels and Ala-crity fhewn by Major Gordon, the Officers and Soldiers of the Garrifon, in the Execution of my Orders on this Occafion; for the Day was fo far fpent that One Quarter of an Hour's Delay might have frustrated all our Exertions ; but I am in Dury bound to testify my particular Obligations to Town-Major Hainell, who folicited to be employed, and inftantaneously embarking, effected the Capture without any Lofs.

I am further happy in reporting, that our Battery was well ferved, as out of Three Shot fired within Reach, One paffed through the Enemy's Sails, and another killed a Man on Board.

Extract of a Letter from Captain Edward Griffith, Commander of His Majefty's Ship Niger, to Evan Nepean, Efq; dated at Spithead the 26th Ultimo.

YESTERDAY, the Start Point bearing North about Seven Leagues, I captured, after a few Hours Chace, the Delphine, a French Privateer Cutter, pierced for 10 Guns, 4 mounted, and 38 Men on Board. She failed from St. Maloes Six Days ago, in Company with a Lugger; had captured the Active Brigantine, of Jerfey, and had been beat off the Night before we fell in with her by an English Letter of Marque.

YOU will be pleafed to inform the Right Hon. the Lords Commissioners of the Admiralty, that on the 28th Inflant, the Spurn Point bearing W. N. W. diftant Four Leagues, I captured, after a Chace of Four Hours, the French Privateer Schoner Le Vic-toire, of 14 Guns and 74 Men. She had been out Ten Days, had captured Two Colliers, and was in Parfield of the Participation of the School of the Purfuit of an English Merchantman when I first dif-. covered her.
