For apprehending Robert Thomas Crossfield.

7HEREAS Robert Thomas Crossfield, late of Curfitor-Street, Chancery-Lane, in the County of Middlefex, Surgeon, stands charged with Sufpicion of High Treason, We have therefore thought fit, by and with the Advice of Our Privy Council, to issue this Our Royal Proclamation, hereby requiring and commanding all Our loving Subjects to discover and apprehend, and cause to be discovered and apprehended, the faid Robert Thomas Crossfield, and to carry him before some of Our Justices of the Peace, or Chief Magistrates of the County, Town or Place where he shall be apprehended, who are respectively required to secure him, and thereof to give speedy Notice unto Our Privy Council, or one of Our Principal Secretaries of State, to the End he may be forthcoming, and may be dealt withal and proceeded against according to Law: And whoever shall discover and apprehend the said Robert Thomas Crossfield, and bring him before such Justice of the Peace or Chief Magistrate, or so discover him that he may be apprehended, shall receive for Reward the Sum of TWO HUNDRED POUNDS, which faid Sum of Two Hundred Pounds the Lords Commissioners of Our Treasury are hereby required and directed to pay accordingly.

SIR,

I Take the Liberty of acquainting you, that this Morning a Convoy of the Enemy was discovered within Isle Dieu, to whom I immediately gave Chace with His Majesty's Ships under my Orders; but the Breeze dying away, I made the Signal for the Boats of my Squadron to chace, and I have the Satisfaction to inform you, that the Vessels mentioned on the inclosed List were captured by them. A Schooner

Gun Vessel and an armed Lugger escaped into the Fromentine Passage, near the Island of Normentier.

Two of the Prizes are numbered, and laden with Naval Stores for the Armamert equipping at Breft, for the intended Expedition against England; the Rest have Wine and Brandy for their Cargoes, and were bound from Rochfort to the above Port.
