Ash, without Leave or Permission being first had and obtained from His Majesty or His Privy Council, upon Pain of incurring the Forfeitures inflicted by an Act passed in the Thirty-fourth Year of His Majesty's Reign, intituled, " An Act for indemnifying all Persons who have " been concerned in advising or carrying into Exe-" cution an Order of the Lords Commissioners of " His Majesty's Treasury respecting the Exportation " of Pot-Ashes or Pearl-Ashes; for preventing Suits " in consequence of the same; for authorizing His " Majesty to prohibit the Exportation or carrying " Coastwife of Pot-Ashes or Pearl-Ashes, and for " making further Provisions relative thereto." But it is nevertheless His Majesty's Pleasure, that nothing herein contained shall extend, or be construed to extend, to prevent the Exportation of the faid Articles to Ireland, or to His Majesty's Islands of Guernsey, Jersey, Alderney, Sark or Man, or to lis Majesty's Colonies or Plantations in America or the West Indies, or to Newfoundland, or to His M 1: ty's Forts and Settlements on the Coast of Africa, or to the Island of St. Helena, or to the British Settlements or Factories in the East Indies; provided that, upon the Exportation of the faid Articles to Ireland, or to His Majesty's Islands of Guerntey, Jertey, Alderney, Sark or Man, or to His Majetty's Colonies and Plantations in America or the West Indies, or to the Island of Newfoundland, or to His Majesty's Forts and Settlements on the Coast of Africa, or to the Island of St. Helena, or the British Settlements or Factories in the East Indies, the Exporters of the faid Articles do first make Oath of the true Destination of the fame to the Places for which they shall be entered Outwards, before the Entry of the fame shall be made, and do give full and sufficient Security, by Bond, to the Satisfaction of the Commissioners of His Majesty's Customs, to carry the faid Articles to the Places for which they are fo entered Outwards, and none other; and fuch Rond shall not be cancelled or delivered up until Proof be made, to the Satisfaction of the faid Commisfioners, by the Production, within a Time to be fixed by the faid Commissioners, and specified in the Bond, of a Certificate or Certificates, in such Form and Manner as shall be directed by the said Commissioners, shewing that the said Articles have been all duly landed at the Places for which they were entered Outwards .-- And the Right Honorable the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, and the Lord Warden of the Cinque Ports, are to give the necessary Directions herein, as to them may respectively appertain.

And the Right Honourable the Lords Commissioners of His Majesty's Treasury, the Lords Commissioners of the Admiralty, and the Lord Warden of the Cinque Ports, are to give the necessary Directions herein as to them may respectively appertain.
