Plymouth, April 20. Two of the Kings Ships, the Norwich, Captain Haywood, and the Dartmouth, Captain Churebil, are at present in this Port, to repir in some Damage they had received, which so soon as they have done, they will return to Sea to Cruic.

Whitchall, April 19. The 16th Instant about 12 at night, a Letter without a Name was thrust into the Key hole of the Lodging where Edmund Warcup Esq; a Justice of the Peace. lyes, containing a Suggestion that two of the Life-Guard-men in the Kings own Troop might be justly suspected to be two of those that Assaulted John Arnold Esq; the day before, in a Barbarous manner. Mr. Warcup, next Morning by six, found out the said Life-Guard men, and brought them to Mr. Arnold, who upon hearing their Examinations, declared he remembered so well the Voices and Faces of the Persons who had assaulted him, that he knew these Gentlemen truly Innocent, and therefore did entirely acquit them of all Suspicion in this matter. They were likewise shewed to a Milliner near Mr. Arnolds Lodging, who had observed two or three Persons to skulk suspiciously near that place on that Thursday, and the Milliner upon strict view declared they were none of those suspicious persons. However Mr. Warcup took their Examination in Writing, under their hands, where and with whom they had spent that Thursday and Friday in the Morning, and delivered the same to Mr. Scudamore and Mr. Price, two Justices of Monmouthshire, and Mr. Arnolds particular Friends, that they might trace out the truth of the said Examination, where and with whom the Life-Guard-men had spent the said time; And yesterday those Gentlemen declared before His Majesty at the Committee of Foreign Intelligence, That they found all things agreeable to the Examinations of the said Life-Guard-men in every particular, and that there was not the least Suspicion that they or either of them were in the least manner concerned in the said intended Assassination upon Mr. Arnold. And it farther appeared that they had, among the rest of the Guards, taken the Oaths of Allegiance and Supremacy, received the Sacrament, and Subscribed the Test, according to the late Act of Parliament.

Whitchall, April 22. The Lieutenant of the Tower having this morning given an account to the Right Honourable the Earl of Sunderland, His Majesties principal Secretary of State, That he had secured a certain suspicious person, who had a hurt in his Leg, which one of the Officers of the Tower found him dressing in the Lord Powis his Lodgings, the said Person was this Afternoon brought hither, and Examined at the Committee of Examinations, where he owned his Name to be Joseph Cruytsvelt, That he arrived at Harwich, from Holland, in the Packet-Boat, on Monday was Sevensight, from whence he came to London the Wednesday following, and lay at the Saracens-head near Aldgate that night, That the next day being Thursday he went to the Lady Powis's house in Lincolns-Inn-fields, and stayed there that day and night; That the day following he went to the Tower, to the Lord Powis's Lodging where he stayed till he was taken: That he was recommended to the said Lord Powis to be his Servant, by two Dutch Merchants, and that he received the hurt on his Leg by a fall from a Horse; And one of the Kirg's Chirurgions being sent for, and searching his Legs in the presence of the Lords of the Committee, he certified, That there appeared no sign of a wound or peircing of the skin by any weapon,

but only a Bruise. However their Lordships thought fit to Order the Clerk of the Council in Waiting to go with the said Joseph Cruytsvelt, being in the Custody of a Messenger, to Mr. Arnold, who having seen him, declared, That one of the three persons who assaulted him was a little man, much about this persons Size, but that he could not Charge him, and that the Person who he supposes was wounded in the Leg, was a tall man. The Lords of the Committee not being satisfied with the account the said Cruytsvelt had given of himself, Ordered he should be kept in safe Custody till farther enquiry could be made concerning him.

One Richard Kavennach, a Foot-soldier, having likewise been taken upon Suspicion that he was one of the three Persons concerned in the said Barbarous Attempt upon Mr. Arnold, was Examined by their Lordships, who directed he should be carried to Mr. Arnold, to see whether he knew him, and afterwards kept in safe Custody in order to his farther Examination; And that in the meantime one of the Clerks of the Council and Mr. Warcup should go to the several places where he pretended he had been that day and night when Mr. Arnold was set upon, to enquire and to give their Lordships an account whether they found what he had said to be true.
