THIS Day the Lords being met, a Message was hent to the Honorable House of Commons by Sir Francis Molyneux, Gentleman Usher of the Black Rod, acquainting them, that The Lords, authorised by virtue of His Majesty's Commission for declaring His Royal Assent to several Assagreed upon by both Houses, do desire the immediate Attendance of the Honorable House in the House of Peers to hear the Commission read; and the Commons being come thither, the said Commission, empowering the Lord Archbishop of Canterbury, the Lord High Chancellor of Great Britain, and several other Lords therein named, to declare and notify the Royal Assent to the said Acts, was read accordingly, and the Royal Assent given to

An Act for continuing and granting to His Majesty certain Duties upon Malt, Mum, Cyder, and Perry, for the Service of the Year One thousand

eight hundred and three.

An Act for continuing and granting to His Majesty a Duty on Pensions, Offices, and Personal Estates, in England, Wales, and the Town of Berwick-upon-Tweed; and certain Duties on Sugar, Malt, Tobacco, and Snuff, for the Service of the Year One thousand eight hundred and three.

An Act for raising the Sum of Five Millions by Loans or Exchequer-Bills, on the Credit of such Aids or Supplies as have been or shall be granted by Parliament for the Service of Great Britain for the Year One thousand eight hundred and three.

An Act for further suspending, until the Expiration of Six Weeks after the Commencement of the next Session of Parliament, the Operation of Two Acts made in the Fisteenth and Seventeenth Years of the Reign of His present Majesty, for restraining the Negociation of Promissory Notes and Bills of Exchange, under a limited Sum, within that Part of Great Britain called England.

An Act to indemnify such Persons as have omitted to qualify themselves for Offices and Employments, and to indemnify Justices of the Peace, or others, who have omitted to register or deliver in their Qualifications within the Time directed by Law, and for extending the Time limited for those Purposes until the 25th Day of December 1803, to indemnify Members and Officers in Cities, Corpo-

rations, and Eorough Towns, whose Admissions have been omitted to be stamped according to Law, or having been stamped, have been lost or missaid, and for allowing them until the Twenty-sisth Day of December One thousand eight hundred and three, to provide Admissions duly stamped, and to permit such Persons as have omitted to make and sile Affidavits of the Execution of Indentures of Clerks to Attornies and Solicitors, to make and sile the same, on or before the First Day of Michaelmas Term One thousand eight hundred and three.

An Act for the more speedy and effectual Enrolument of the Militia of Ireland, and for filling up

Vacancies therein.

An Act for continuing the Term, and altering and enlarging the Powers of an Act passed in the Twenty-eighth Year of the Reign of His present Majesty, intituled An Act for amending, widening, and keeping in Repair the Road from Spann Smithy, in the County of Chester, to Talk, in the County of Stafford.

An Act for repairing, improving, and maintaining the Road leading from Thirse to Yarm, in the

County of York.
