Defigns of those desperate Men succeeded, we find ourfelves unable, in Terms fufficiently strong, to convey to your Majesty a true Sense of our utter Detestation of their diabolical Attempts; however, under these our Resections, we have to console ourfelves in believing that the abhorred Confpiracy was not the Conspiracy of vail Numbers, but of a very few, and those, with a fingle Exception, of the lowest Orders of Men. We most fervently thank Almighty God that their Attempts have been fruf-

HEREAS His Majesty was graciously pleased, by His Royal Proclamation bearing Date the Seventh Day of March last, to promise and declare, that the Bounties of Three Pounds for every Able Seaman, and Two Pounds for every Ordinary Seaman, fit for His Majesty's Service, should be paid in the Manner thereby directed to every fuch Able and Ordinary Seaman, not above the Age of Fifty nor under the Age of Twenty Years, who should, on or before the Thirtieth Day of April then following, enter themselves to serve in His Majesty's Royal Navy, either with the Captains or Lieutenants of His Majesty's Ships, or Officers employed in Tenders, or at Rendezvous on Shore for raising Men for the Service of the Royal Navy: And whereas His Majesty was also graciously pleased, by His said Proclamation, to declare, that all Able-bodied Landmen, not above the Age of Thirty five nor under the Age of Twenty Years, who should so enter themselves as aforesaid, should receive the Sum of Twenty Shillings each Man as His Majesty's Royal Bounty: And whereas His Majesty was also graciously pleased, by His Royal Proclamation bearing equal Date, to promise and declare, that a Reward of Twenty Shillings for every Able and Ordinary Seaman, fit to ferve on board His Majesty's Ships, should be paid to any Person who should discover any Seaman or Seamen, who might conceal him or themselves, fo that such Seaman or Seamen should be taken for His Majesty's Service, on or before the Thirtieth Day of April then next, by any of His Majesty's Sea-Officers employed for raising Men: And whereas the Time limited by the faid Proclamations respectively, for Payment of the said Bounties and Reward, will expire upon the Thirtieth Day of this instant April; and it being judged ex-pedient for His Majesty's Service that the said Bounties and Reward should be continued to be paid for fome Time longer, His Majelty, with the Advice of His Privy Council, doth therefore order, and it is hereby accordingly ordered, that the Time limited for Payment of the faid Bounties and Reward be prolonged and extended from the faid Thirtieth Day of this instant April to the Thirtieth Day of June next inclusive; whereof all Persons concerned are to take Notice and govern themselves accordingly.
