# GENERAL ORDERS.

Horfe Guards, October 29, 1803. IS Royal Highnefs the Commander in Chief has received the King's Command to convey to the feveral Volunteer and Affociated Corps which were reviewed in Hyde Park on the 26th and 28th Inft. His Majetty's higheft Approbation of their Appearance, which has equalled His Majefty's utmoft Expectation.

His Majeily perceives, with heartfelt, Satisfaction, that the Spirit of Loyalty and Patriotifm, on which the Syftem of the Armed Volunteers throughout the Kingdom was originally founded, has rifen with the Exigencies of the Times, and at this Moment forms such a Bulwark to the Conflictution and Liberties of the Country, as will enable us, under the Protection of Providence, to bid Defiance to the unprovoked Malice of our Enemies, and to hurl back with becoming Indignation, the Threats which they have presumed to vent against our Independence, aud even our Existence as a Nation. His Majefty has obferved with peculiar Pleafure that, amongft the unprecedented Exertions which the prefent Circumftances of the Country have called forth, thole of the Capital of His United Kingdom have been eminently confpicuous; the Appearance of its numerous and well-regulated Volunteer Corps, which were reviewed on the 26th and 28th Inft. indicates a Degree of Attention and Emulation, both in Officers and Men, which can proceed only from a deep Senfe of the important Objects for which they have enrolled themfelves, a juft Effimation of the Bleffings We have to long enjoyed, and a firm and manly Determination to defend them like Britons, and tranfmit them unimpaired to our Pofterity.

The Commander in Chief has the higheft Satisfaction in difcharging his Duty, by communicating thefe His Majefty's moft gracious Sentiments, and requefts that the Commanding Officers will have Recourfe to the readieft Means of making the fame known to their refpective Corps.

PRESENT,

'The KING's Most Excellent Majesty in Council. HEREAS Information hath been received that an Infectious Diftemper is now raging in the City of New York, in the State of New York, within the United States of America: And whereas by an Act paffed in the Thirty-ninth and Fortieth Year of His Majelty's Reign, intituled "An Act for erecting a Lazaret on Chetney "Hill, in the County of Kent, and for reduc-" ing into one Act the Laws relating to Qua-" rantine, and for making further Provision " therein:" It is among other Things enacted, that it shall be lawful for His Majesty, by and with the Advice of His Privy Council, by His Paral Proclamation from Time to Thing to do Royal Proclamation, from Time to Time, to declare any Infectious Diftemper, the Communication whereof may be highly dangerous to the Health of His Majelty's Subjects, to be of the Nature of the Plague.

His Majefty, in purfuance of the faid Power, by and with the Advice of His Privy Council, deems it expedient to declare, and doth hereby declare, that the faid Infectious Diftemper is of the Nature of the Plague:

And His Majesty doth therefore hereby order, that all Ships, Vessels, Persons, Goods, Wares, and Merchandizes now arrived, or which may hereafter arrive in any of the Ports of Great Britain, or the Istes of Guernfey, Jerfey, Alderney, Sark, or Man from New York, or any Port within the State of New York, and shall have cleared out from New York, or any Port within the State of New York, fublequent to the Fifteenth Day of August last, (not having any Perfon or Perfons on board the fame actually ill of the faid Fever,) do perform a Quarantine of Fourteen Days at the feveral Places appointed, and according to the Rules prefcribed by His Majefty's Order in Council of the Twentybinth of July One thouland eight hundred, for Per-formance of Quarantine by all Ships and Vef-fels coming from or through the Mediterranean, or from the Weft Barbary on the Atlantic Ocean, and articing with clean Bills of Haulth and arriving with clean Bills of Health; but is

T the Court at St. James's, the 26th of Oc- | cafe any of the Crew or Paffengers on board any fuch Ship or Veffel which shall have cleared out from New York, or any Port within the State of New York fublequent to the faid Fifteenth Day of August, and shall have arrived, or may hereafter arrive in any of the Ports of Great Britain, or the Islands of Guernfey, Jerfey, Alderney, Sark, or Man from New York, or any Port within the State of New York, shall have died of the faid Fever during the Course of the Voyage, the Cloaths, and all perfonal Effects which are fufceptible of Infection, worn by, or belonging to fuch Person, shall be forthwith burned, or sunk in deep Water; and if fuch Cloaths and Effects shall not be fo burned or deftroyed, the faid Ship or Veffel, with the Whole of her Cargo, shall not be permitted to perform Qua-rantine at any Port or Place except at Standgate Creek, and thall be compelled to depart from any other Port or Place at which the fame has arrived, or shall arrive as aforefaid, and shall repair to Standgate Creek, and there perform Quarantine, and not elfewhere: And His Majefty is further pleafed to order, with the Advice aforelaid, and it is hereby ordered, that if it shall appear upon the Arrival of any Ship or Vessel from New York or any Port within the State of New York as aforefaid, that any of the Crew or Passengers belonging to the fame are actually ill of the faid Fever, then fuch Ship or Veffel, and the Perfons, Goods, Wares, and Merchandizes on board the fame, shall not be permitted to perform Quarantine at any Port or Place except Standgate Creek, and shall be com-pelled to depart from any other Port or Place, and to proceed immediately to Standgate Creek in order to perform Quarantine, and shall there per-form Quarantine and not elsewhere : And the Right Honorable the Lords Commissioners of His Majefty's Treafury, the Commissioners or executing the Office of Lord High Admital of Great Bri-tain, the Lord Warden of the Cinque Ports, the Maîter General and the Reft of the Principal Of-ficers of the Ordnance, His Majefty's Secretary at War, and the Governors or Commanders in Chief for the Time being of the faid Isles of Guernfey, Jerley, Alderney, Sark, and Man, are to give the necessary Directions herein as to them may respectively appertain.
