A PROCLAMATION.

GEORGE R.

W HEREAS by an Act, paffed in the Fortythird Year of Our Reign, intituled "An "Act to repeal an Act paffed is the laft Seffion of "Parliament for eftablifting Regulations refpecting "Aliens arriving in this Kingdom, or refident "therein and for eftablifting, until Three Months "after he Ratification of a Definitive Treaty of "Peace, Regulations refpecting Aliens arriving in "this Kingdom, or refiding therein, in certain "Cafes;" We are authorized by Our Royal Proclamation, from Time to Time, to require and command every Alien who now is in, or who fhall hereafter come into, Great Britain, except as therein excepted, to register himfelf or herfelf, and thereupon to obtain Our Royal Licence to refide within this Kingdom, as therein-mentioned : Now We, being defirous of carrying into Execution the Purpofes of the faid Act, do, by this Our Proclamation, by and with the Advice of Our Privy Council, require and command every Alien who fhall be in this Kingdom on the Day of the Date of this Our Proclamation, except as hereinafter excepted, to register himfelf or herfelf, in the Manner hereinafter-mentioned ; that is to fay,

- All Aliens refiding in the City of London thall, within Ten Days from the Publication of this Our Proclamation in the London Gazette, fo register themfelves with the Lord Mayor of the faid City:
- All Aliens reliding in the City and Liberties of Weltminster, or elfewhere within the Bills of Mortality (except the City of London), or refiding within Ten Miles of the City of London, shall, within Ten Days from the Publication of this Our Proclamation in the London Gazette, fo register themselves with the Magistrates at One of the undermentioned Public Offices, in the District of which Office fuch Alien shall then refide; that is to fay, the Police Office Queen-Square, Westminster; Great Marlbro'-Street; Hatton-Garden; Lambeth-Street, Whitechapel; Worship-Street, Shore-

ditch; High-Street, Shadwell; and Union-Hall, southwark:

- All Aliens reliding out of the Dillricts aforefaid, and within any Cities or Corporate Towns, or within the Jurifdiction of the Magistrates of fuch Cities or Corporate Towns respectively, shall, within Fourteen Days from the Publication of this Our Proclamation in the London Gazette, so register themselves with the Mayor or other Chief Magistrate of such Cities or Corporate Towns respectively:
- And all Aliens refiding in other Places in Great Britain fhall, within Eighteen Days from the Publication of this Our Proclamation in the London Gazette, fo register themfelves with fome Magistrate of the County or Place where fuch Aliens respectively shall refide.

And We do further require and command all Aliens who fhall come into Great Britzin, after the Publication of this Our Proclamation in the London Gazette, to regilter themfelves in the Manner hereinafter-mentioned with the Lord Mayor, Mayors, or other Magiftrates as aforefaid, within Two Days after every fuch Alien fhall have arrived within any fuch City, Town, Diftrict, or other Place to which he fhall be allowed to proceed, by Pafiport granted for that Parpofe, except Aliens who are required by Our Proclamation of the Twelfth August laft to land at no other Port than the Ports of Yarmouth, Harwich, Dover, and Southampton, and at Gravefend, whom We hereby require and command to register themfelves in Manner hereinafter-mentioned, at the Alien Office in Crown Street, Weftmintler.

And We do further require and command every Alien, for the Purpofe of obtaining fuch Licence as aforefaid, to deliver, or caufe to be delivered, to the Perfon or Perfons with whom fuch Alien is hereby required to regilter himfelf or herfelf as aforefaid, a full and true Declaration or Account in Weiting of his or her Name, Age, Place of Birth, Rank, Occupation, Profeffion, the Place of Refidence when laft in his or her own Country, together with the laft and principal Place of Refidence before his or her Arrival in this Kingdom, the Name or Names of fome Perfon or Perfons in this Country to whom known, the Reafon or Purpofe for which he or fhe came to this Kingdom, the

Time when, and the Place at which, fuch Alien laft arrived in Great Britain, and where his or her actual Refidence has been fince fuch laft Arrival, and is at the Time of giving in fuch Declaration, which faid Declaration or Account fhall be figned by fuch Alien with his or her Name or Mark.

And We do hereby authorize and appoint the faid Lord Mayor, Mayors, and other Magiftrates as aforefaid refpectively, to receive fuch Accounts as aforefaid, and do require and command them refpectively to caufe the original Account to be transmitted within Two Days to Our Principal Secretary of State for the Home Department, for the Purpofe of fuch Alien obtaining Our Royal Licence to refide within Great Britain from the faid Secretary, whom We do hereby authorize and appoint to grant fuch Licences, or from fuch other Perfon or Perfons who now are, or who fhall from Time to Time be authorized and appointed by Us to grant fuch Licences.

And We do further authorize and require the faid Lord Mayor, Mayors, and other Magiftrates as aforefaid, to whom any fuch Accounts fhall be delivered as aforefaid, to grant under his Hand and Scal to the Alien delivering fuch Account, a provihonal Licence to refide within Great Britain, under fuch Rettrictions as shall appear fit, during the Time that fhall be therein allowed to fuch Alien for obtaining Our Royal Licence as aforefaid.

And We do further declare, That this Our Proclamation shall not extend to require any Alien to obtain such Licence as aforefaid, who shall, before the Publication of this Our Proclamation in the London Gazette, have obtained Our Royal Licence to reside in any Part of this Kingdom.

And We do further direct, That every Alien as aforefaid, upon every Change of Refidence, as well to any Place in the fame City, Town, Diftrict, or Place, as in any other City, Town, Diftrict, or Place, fhall give Four Days previous Notice thereof to the Perfon or Perfons with whom he or fhe has been fo registered, and fhull again register himfelf or herfelf in Manner before-mentioned according to fuch new Refidence, declaring the Refidence from whence he or fhe fo removed

And We do further declare, 'That no Foreign Ambaffador, or other public Minister duly authorized, nor the domeflic Servants of any fuch Foreign Ambaffador, or public Minister registered according to the Directions of the Laws in force for that Purpofe, and being actually attendant upon fuch Ambaffador or Minister; nor any Alien not above the Age of Fourteen Years, shall be deemed within the Meaning and Intent of this Proclamation.

And We do further declare, That all fuch Licences, and provisional Licences, as aforefaid shall be given without Fec or Reward, and shall be subject to no Duty or Charge whatsoever.

And We do further declare and make known, That every Alien who shall be found at large in Great Britain after the Time by this Our Proclamation limited for registering and thereupon obtaining Licences as aforefaid, fuch Aliens not having obtained fuch Licence respectively, and not being exempted as aforefaid, will be liable on Conviction to fuffer Impriforment for any Time not exceeding

SIR, I HAVE the Honor to inform you, that the Boats of His Majefty's Sloop Merlin, under my Command, Yefterday went in Purfuit of, and drove on Shore and totally deftroyed the French Lugger Privateer Les Sept Freres, mounting Two Carriage Guns, besides fmall Arms, and manned with Thirty Men, commanded by the Citizen Pollet; the Boats of the Merlin were commanded by Lieutenant Henry Clement Thompson, who has loft an Arm in the Service of his King and Country during the late War; and to the judicious and feamanlike Conduct of Lieutenant Newton Starck, I am not only indebted for cutting off the Enemy's

Retreat into Calais, but alio for bringing all the | OFFICE FOR TAXES, SOMERSET. Boats on board in Safety after the Service was performed.

The Lugger went on Shore about Half a Mile to the Weltward of Gravelines; Lieutenant Starck anchored the Millbrook within Masket-Shot of her, and in the Evening a heavy Fire was opened upon her from the Shore with fome Field Pieces, which, however, did no Sort of Damage, and I am happy to fay, that on our Side act a Man was hurt.
