BY THE LORDS COMMISSIONERS OF HIS MAJESTY'S TREASURY.

and remain under the Regulations and Directions " of this Act; and the Lord High Treasurer, or the Commissioners of His Majesty's Treasury for " the Time being, or any Three or more of them, " are hereby authorized and empowered, by Writing " under his or their Hand or Hands, to certify and " make known his or their Appropation of fuch Warehouses, which Certificate shall be published " Three Times at least in the London Gazette, and " in Two or more public Morning Newspapers then " usually circulated in London:
