land; the Person so convicted shall, for every Artificer contracted with or seduced, forfeit FIVE HUNDRED POUNDS, and shall suffer Imprisonment in the Common Gaol of the County or Stewartry wherein such Offender shall be convicted for Twelve Calendar Months, and until Forfeiture be paid: And in case of a subsequent Offence of the same Kind, the Persons so again offending shall forfeit, for every Person contracted with or seduced, ONE THOUSAND POUNDS, and shall suffer Imprisonment in the Common Gaol of the County or Stewartry wherein such Offender shall be convicted, for Two Years, and until such Forseiture be paid.

If any Person in Great Britain or Ireland shall put on board any Ship or Boat, not bound directly to some Port in Great Britain or Ireland, or to some other of the Dominions of the Crown of Great Britain, any such Tools or Utensils as are commonly used in, or proper for the Preparing, Working up, or Finishing of the Woollen or Silk Manusactures, or any Part of such Tools, he shall, for every Offence, forfeit all such Tools, or Parts thereof, put on board, and TWO HUNDRED POUNDS, to be recovered by Action of Debt, &c. in any Court of Record at Westminster, or in the Court of Session in Scotland, or at any of the Four Courts in

Dublin respectively, wherein no Essoin, &c. shall be allowed.

It shall be lawful for any Officer of the Customs in Great Britain, or for any Officer of the Revenue in Ireland, to seize and secure, in some of His Majesty's Warehouses, all such Tools or Utensils prohibited to be exported, as such Officer shall sind on board any Vessel not bound directly to some Port in Great Britain or Ireland, or to some other of the Dominions of the Crown of Great Britain; and all Tools so seized shall, after Condemnation, be publicly sold to the best Bidder; and one Moiety of the Produce shall be to the Use of His Majesty, and the other Moiety to the Officer who shall seize and secure the same.

If the Captain of any Vessel in Great Britain or Ireland knowingly permit any of the said Tools, prohibited to be exported, to be put on board his Vessel, he shall, for every such Offence, forfeit ONE HUNDRED POUNDS, to be recovered as the Penalties inslicted upon Persons exporting the Tools; and, if the Vessel belongs to His Majesty, the Captain shall not only forseit ONE HUNDRED POUNDS, but shall also sorseit bis Employment, and be incapable of any Employ-

ment under His Majesty.

If any Officer of the Customs in Great Britain or of the Revenue in Ireland, take, or knowingly suffer to be taken, any Entry outward, or sign any Cocket or Sufferance for the Shipping or Exporting of any of the said Tools, or knowingly suffer the same to be done, he shall forfeit ONE HUNDRED POUNDS, to be recovered as aforesaid, and also forfeit his Office, and be incapable of any Office under His Majesty.

One Moiety of the Forfeitures shall be applied to the Use of His Majesty, and the other Moiety to the Use of the Person who shall sue for the

Statutes 14, 21, 25, and 26 of His present Majesty.

BY these Statutes the like Penalties and For-

feitures as above-mentioned are extended to Persons packing or putting on board any Vessel, not bound directly for some Port in Great Britain or Ireland, any Machine, Engine, Tool, Press, Paper, Utensil, or Implement whatsover, used in or proper for the working or finishing of the Cotton, Steel, or Iron Manufactures of this Kingdom, or any Part or Parts of such Machines or Implements, or any Models or Plans thereof; and all Captains of Ships and other Persons receiving or being in Possession of any such Articles, with an Intent to export the same to Foreign Parts, and all Custom-house Officers suffering an Entry to be made thereof, are respectively liable to the like Penalties as are above-mentioned, in the case of Tools and Utensils, used in the Woollen and Silk Manufactures.

LONDON DOCKS.
By the Lords Commissioners of His Majesty's Treasury.

WHEREAS by an Act passed in the Forty-third Year of His present Majesty's Reigu, intituled "An Act for permitting certain Goods "imported into Great Britain, to be fecured in Warehouse without Payment of Duty:" It is enacted, That it should be lawful for the Importer or Importers, Proprietor or Proprietors, Confignee or Confignees of any of the Goods, Wares, or Merchandizes enumerated or described in the Table thereunto annexed, marked (B), and which shall be legally imported and brought into the Port of London, to lodge and fecure the same under the Joint Locks of the Crown and the London Dock Company, in any Warehouse or Warehouses erected or to be erected, situate within the Premises belonging to the London Dock Company, without Payment at the Time of the first Entry of such Goods, Wares, and Merchandize, of the Duties of Customs or Excise due on the Importation thereof, subject nevertheless to the Rules, Regulations, and Restrictions therein contained; provided that no such Goods, Wares, or Merchandize should be so lodged, or secured, unless and until such Warehouses or other Works belonging, or to belong thereto, should be so far compleated that, in the Judgment of the Lord High Treasurer, or the Commissioners of His Majesty's Treasury for the Time being, or any Three or more of them, the fame shall be fit and proper, in every Re-spect, for the Reception of such Goods, Wares, and Merchandize, and wherein the same might re-spectively be safely and securely deposited, and remain under the Regulations and Directions in the faid Act contained; and the faid Lord High Trea-furer, or Commissioners of His Majesty's Treasury for the Time being, or any Three or more of them, were thereby authorized and empowered, by Writing under his or their Hand, or Hands, to certify and make known his or their Approbation of such Warehouses, which Certificate should be published Three Times, at least, in the London Gazette, and in Two or more public Morning Newspapers usually circulated in London. And whereas the Table marked (B), above referred to, is in the Words sollowing; viz. Table (B)
