NCLOSED I have the Honor of transmitting, for the Information of the Lords Commissioners of the Admiralty, a Letter from Captain Brace, of His Majesty's Ship Virginie, giving an Account of his having on the 9th Instant, in Lat. 46 Deg. 49 Min. N. Long. 10 Deg. 25 Min. W. captured the Spanish Schooner Privates Vengador, mounting Fourteen Guns, and having a Complement of Eighty-two Men.

I understand from Lieutenant Powell, who is arrived in charge of the above Privateer, that she is out Twelve Days from Bourdeaux, and had not made

any Captures during that Period.
