tituled "An Act for regulating the Allowance of " the Drawback, and Payment of the Bounty on "the Exportation of Sugar, and for permitting the Importation of Coffee and Sugar into the " Bahama and Bermuda Islands in foreign Ships," for any of the Periods therein particularly mentioned shall be below Forty seven Shillings the Hundred Weight, and fuch Suspension is thereby required to be published Three Times in the London Gazette.
