A PROCLAMATION,

For diffolving this prefent Parliament, and declaring the Calling of another.

GEORGE R.

HEREAS We think fit, by and with the Advice of Our Privy Council, to dissolve this present Parliament, which stands prorogued to Wednesday the Twenty-ninth Day of this instant October, and which was to be further prorogued on the faid Twenty-ninth Day of this instant October, to Thursday the Twenty-seventh Day of November next: We do therefore publish this Our Royal Proclamation, and do hereby dissolve the faid Parliament accordingly; and the Lords Spiritual and Temporal, and the Knights, Citizens, and Burgeffes, and the Commissioners for Shires and Burghs of the House of Commons, are discharged from their Meeting and Attendance on the said Wednesday the Twentyninth Day of this inflant October, and on the faid Thursday the Twenty-seventh Day of November next. And We being defirous and refolved, as foon as may be, to meet Our People, and to have their Advice in Parliament, do hereby make known to all Our loving Subjects Our Royal Will and Pleafure to call a new Parliament: And do hereby further declare, that, with the Advice of Our Privy Council, We have this Day given Order that Our Chancellor of that Part of Our United Kingdom called Great Britain, and Our Chancellor of Ireland, do respectively forthwith issue out Writs, in due Form and according to Law, for calling a new Par-riament. And We do hereby also, by this Our Royal Proclamation under Our Great Seal of Our United Kingdom, require Writs forthwith to be iffued accordingly by Our faid Chancellors respectively, for causing the Lords Spiritual and Temporal, and Commons, who are to serve in Our faid Parliament, to be duly returned to, and give their Attendance in, Our laid Parliament; which Writs are to be returnable on Monday the Fifteenth Day of December next.

Given at Our Court at the Queen's Palace, the Twenty-fourth Day of October, One thoufand eight hundred and fix, and in the Fortyfaxth Year of Our-Reign.

A PROCLAMATION,

In order to the Electing and Summoning the Sixteen Peers of Scotland.

GEORGE R.

MEREAS We have, in Our Council, thought fit to declare Our Pleafure for summoning and holding a Parliament of Our United Kingdom of Great Britain and Ireland, on Monday the Fif-teenth Day of December next enfuing the Date hereof: In order therefore to the electing and fummoning the Sixteen Peers of Scotland, who are to fit in the House of Peers in the said Parliament; We do, by the Advice of Our Privy Council, iffue forth this Our Royal Proclamation, flrictly charging and commanding all the Peers of Scotland to affemble and meet at Holy Rood House, in Edinburgh, on Thursday the Fourth Day of December next ensuing, between the Hours of Twelve and Two in the Afternoon, to nominate and choose the Sixteen Peers to sit and vote in the House of Peers, in the faid ensuing Parliament, by open Election and Plurality of Voices of the Peers that shall be then prefent, and of the Proxies of such as shall be absent, (fuch Proxies being Peers, and producing a Mandate in Writing, duly figned before Witnesses, and both the Constituent and Proxy being qualified according to Law). And the Lord Clerk Register, or such Two of the Principal Clerks of the Session as shall be appointed by him to officiate in his Name, are hereby respectively required to attend such Meeting, and to administer the Oaths required by Law to be taken there by the faid Peers, and to take their Votes; and immediately after such Election made, and duly examined, to certify the Names of the Sixteen Peers so elected, and sign and attest the same, in the Pre-sence of the said Peers the Electors; and return such Certificate into Our High Court of Chancery of Great Britain. And We do, by this Our Proclamation, strictly command and require the Provost of Edinburgh, and all other the Magistrates of the faid City, to take especial Care to preserve the Peace thereof, during the Time of the said Election; and to prevent all Manner of Riots, Tumults, Disorders, and Violence whatsoever. And We strictly charge and command, that this Our Royal Proclamation be duly published at the Market Cross as Edinburgh, and in all the County Towns of Scotland, Twenty-five Days at least before the Time hereby appointed for the Meeting of the said Peers to prosected to such Election.

Witness Ourself at Westminster, the Twentyfourth Day of October One thousand eight Hundred and six, in the Forty-sixth Year of Our Reign.

As feveral Artificers and Manufacturers, Subjects of Great Britain, have, from Time to Time, gone into Foreign Countries to exercife their several Callings, contrary to the Laws of these Kingdoms, the following Abstracts of Acts of Parliament of Their late Majesties King George the First and Second, and of His present Majesty, for preventing such Practices, are published, for the Information of all Persons who may be ignorant of the Penalties they may incur by Disobedience to them: And it will be observed, that such Penalties likewise extend to those who are any ways concerned or instrumental in the Sending or Enticing Artificers or Manufacturers out of these Kingdoms, or in the Exportation of the Tools and Instruments used by them, as well as to the Artisteers or Manufacturers themselves.

Statute 5 George I. Chap. 27.

IF any Perfon shall contract with, entice, or solicit, any Artificer in Wool, Iron, Steel, Brass, or other Metal, Clock-maker, Watch-maker, or any other Artificer of Great Britain, to go into Foreign Countries out of the King's Dominions, and shall be convicted thereof, upon Indictment or Information in any of the Courts at Westminster, or at the Assizes or Quarter Scsions, he shall be fined any Sum not exceeding ONE HUNDRED POUNDS for the first Offence, and shall be imprisoned Three Months, and till the Fine be paid. And if any Perfon having been once convicted shall offend again, he shall be fined at the Discretion of the Court, and imprisoned Twelve Months, and till the Fine be paid.

If any of the King's Subjects, being such Artificers, shall go into any Country out of His Majesty's Dominions, to exercise or teach the said Trades to Foreigners; and if any of the King's Subjects in any such Foreign Country, exercising any of the said Trades, shall not return into this Realm within Six Months after Warning given by the Ambassador, Minister, or Consul of Great Britain, in the Country where such Artificers shall be or by any Person authorised by such Ambassador, &c. or by one of the Secretaries of State, and from henceforth inhabit within this Realm; such Persons shall be incapable of taking any Legacy, or of being an Executor or Administrator, or of taking any Lands, &c. within this Kingdom, by Descent, Devise, or Purchase, and shall forfeit all Lands,

Goods, &c. within this Kingdom, to His Majesty's fence, forfeit all such Tools, or Parts thereof, put Use, and shall be deemed Alien, and out of His on board, and TWO HUNDRED POUNDS, to

Majesty's Protection.

Upon Complaint made, upon Oath, before any Iustice of Peace, that any Person is endeavouring to seduce any such Artificer, or that any such Artificer hath contracted or is preparing to go out - of His Majesty's Dominions, for the Purposes afore-: faid, fuch Justice may fend his Warrant to bring the Person complained of before him, or before fome other Justice; and if it shall appear by the Oath - of One Witness, or by Confession, that he was guilty of any of the faid Offences, fuch Justice may bind him to appear at the next Affizes or Quarter Seffions: And if fuch Person shall refuse to give Security, the Justice may commit him to Gaol till the next Affizes or Quarter Seffions, and until he shall be delivered by due Course of Law. And if any fuch Artificer shall be convicted, upon Indictment, of any such Promise, Contract, or Preparation to go beyond the Seas, for the Purpole aforesaid, he shall give fuch Security to the King not to depart out of His Majesty's Dominions, as such Court shall think reasonable, and shall be imprisoned till Security .given.

If any of the above Offences shall be committed in Scotland, the same shall be prosecuted in the

· Court of Justiciary or the Circuits there.

Statute 23 George II. Chap. 13.

IF any Person shall contract with, or endeavour to seduce any Artisicer in Wool, Mohair, Cotton, or Silk, or in Iron, Steel, Brass, or other Metal, or any Clock-maker, Watch-maker, or any other Artificer in any other of the Manufactures of Great Britain or Ireland, to go out of this Kingdom or Ireland into any Foreign Country not within the Dominions of the Crown of Great Britain, and shall be convicted, upon Indictment or Information, in the King's Bench at Westminster, or by Indictment at the Assizes or · General Gaol Delivery for the County, wherein fuch Offence shall be committed in England, or by Indictment in the Court of Justiciary or any of the Circuit Courts in Scotland, or by Indictment or Information in the King's Bench at Dublin, if fuch Offence be committed in Ireland; the Person so convicted shall, for every Artificer contracted with or feduced, forfeit FIVE HUNDRED POUNDS, and shall suffer Imprifonment in the Common Gaol of the County or :Stewartry wherein fuch Offender shall be convicted for Twelve Calendar Months, and until Forfeiture be paid: And in case of a subsequent Offence of the fame Kind, the Persons so again offending shall forfeit, for every Person contracted with or seduced, ONE THOUSAND POUNDS, and shall suffer Imprisonment in the Common Gaol of the County or Stewartry wherein fuch Offender shall be convicted, for Two Years, and until such Forfeiture be paid.

If any Person in Great Britain or Ireland shall put on board any Ship or Boat, not bound directly to some Port in Great Britain or Ireland, or to some other of the Dominions of the Crown of Great Britain, any such Tools or Utensils as are commonly nsed in, or proper for the Preparing, Working up, or Finishing of the Woollen or Silk Manusactures, or any Part of such Tools, he shall, for every Of-

fence, forfeit all fuch Tools, or Parts thereof, put on board, and TWO HUNDRED POUNDS, to be recovered by Action of Debt, &c. in any Court of Record at Westminster, or in the Court of Session in Scotland, or at any of the Four Courts in Dublin respectively, wherein no Essoin, &c. shall be allowed.

It shall be lawful for any Officer of the Customs in Great Britain, or for any Officer of the Revenue in Ireland, to seize and secure, in some of His Majetly's Warehouses, all such Tools or Utensils prohibited to be exported, as such Officer shall find on board any Vessel not bound directly to some Port in Great Britain or Ireland, or to some other of the Dominions of the Crown of Great Britain; and all Tools so seized shall, after Condemnation, be publicly fold to the best Bidder; and one Moiety of the Produce shall be to the Use of His Majesty, and the other Moiety to the Officer who shall seize and secure the same.

If the Captain of any Vessel in Great Britain or Ireland knowingly permit any of the said Tools, prohibited to be exported, to be put on board his Vessel, he shall, for every such Ossence, forseit ONE HUNDRED POUNDS, to be recovered as the Penalties inslicted upon Persons exporting the Tools; and, if the Vessel belongs to His Majesty, the Captain shall not only forseit ONE HUNDRED POUNDS, but shall also forseit his Employment, and be incapable of any Employ-

ment under His Majelly.

If any Officer of the Customs in Great Britain or of the Revenue in Ireland, take, or knowingly suffer to be taken, any Entry outward, or fign any Cocket or Sufferance for the Shipping or Exporting of any of the said Tools, or knowingly suffer the same to be done, he shall forfeit ONE HUNDRED POUNDS, to be recovered as aforesaid, and also forfeit his Office, and be incapable of any Office under His Majesty.

One Moiety of the Forfeitures shall be applied to the Use of His Majesty, and the other Moiety to the Use of the Person who shall sue for the

iame.

Statutes 14, 21, 25, and 26 of His present Majesty. BY these Statutes the like Penalties and Forfeitures as above mentioned are extended to Persons packing or putting on board any Vessel, not bound directly for some Port in Great Britain or Ireland, any Macline, Engine, Tool, Press, Paper, Utensil, or Implement whatsoever, used in or proper for the working or sinishing of the Cotton, Steel, or Iron Manusactures of this Kingdom, or any Part or Parts of such Machines or Implements, or any Models or Plans thereof; and all Captains of Ships and other Persons receiving or being in Possession of any such Articles, with an Intent to export the same to Foreign Parts, and all Custom-house Officers suffering an Entry to be made thereof, are respectively liable to the like Penalties as are above-mentioned, in the case of Tools and Utensils used in the Woodlen and Silk Manusactures.

BY THE LORDS COMMISSIONERS OF HIS MAJESTY'S TREASURY.

THEREAS by an Act passed in the last Seffion of Parliament, intituled "An Act for permitting certain Goods imported into Great Britain to be secured in Warehouse, without Payment of Duty," it is (amongst other Things,) enacted as follows: "That it shall be lawful for the Importer or Importers, Proprietor or Proprietors, Confignee or Confignees of any of the Goods, Wares, or Merchandize enumerated or described in the Table hereunto annexed, marked (A), and which shall be legally imported and brought into the Port of London, to lodge and fecure the same under the Joint Locks of the Crown and the Mer-chant in any Warehouse or Warehouses, situated at the Isle of Dogs, and belonging to the West India Dock Company, without Payment at the Time of the first Entry of such Goods, Wares, and Merchandize of the Duties of Cultoms or Excile due on the Importation thereof, subject nevertheless, to the Rules, Regulations, and Reffrictions directed by this Act; provided always, that no fuch Goods, Wares, or Merchandize shall be so lodged or secured unless, and until such Warehouses and other Works belonging, or to belong thereto, shall be so far completed, that in the Judgment of the Lord High Treafurer, or the Commissioners of His Majesty's Treasury for the Time being, or any Three or more of them, the same shall be fit and proper, in every Respect for the Reception of such Goods, Wares, and Merchandize, and wherein the same may respectively be safely and securely deposited, and remain under the Regulations and Directions of this Act; and the Lord High Treasurer or the Commissioners of His Majesty's Treasury for the Time being, or any Three or more of them, are hereby authorized and empowered, by Writing under his or their Hand or Hands, to certify and make known his or their Approbation of fuch Warehouses, which Certificate shall be published Three Times at least, in the London Gazette, and in Two or more public Morning Newspapers, then usually circulated in London."

And whereas by a Certificate under the Hands of Three of the Lords Commissioners of His Ma-jesty's Treasury granted in pursuance of the said Act, on the 16th Day of March 1804, the said Lords Commissioners did certify and make known, that the following Warehouses belonging to the West India Dock Company, were so far completed, that in their Judgment, the same were fit and proper in every Respect, for the Reception of such Goods, Wares, and Merchandize as are enumerated and described in the said Table annexed to the said Act of Parliament, marked (A), and wherein the same might respectively be safely and securely deposited, and remain under the Regulations and Directions

of the faid Act, viz. All those Thirteen Stacks of Warehouses adjoining each other, and situate on the North Side of the large Dock, belonging to the West India Dock Company at the Isle of Dogs, forming the complete Range of Warehouses on the North Side of the faid Dock from the West End to the East End thereof.

We the underligned Lords Commissioners of His Majelty's Treasury, do, in pursuance of the said Act, further certify and make known, that the large Warchouse belonging to the said Company, No. 10, at the East End of the said Dock, is so far completed, that in our Judgment the same is sit and proper for the Reception of fuch Goods, Wares, and Merchandize as are enumerated and described in the faid Table annexed to the faid Act, and wherein the same may respectively be lafely and securely deposited, and remain under the Regulations and Directions of the faid Act; and we do hereby declare our Approbation of the said last-mentioned Warehouse accordingly.
