T the Court at the Queen's Palace, the 19th ] 1 of November 1806,

PRESENT,

The KING's Most Excellent Majesty in Council. W HEREAS the Time limited by His Ma-jefty's Order in Council of the Twenty-firft Day of May laft, for prohibiting the Exportation out of this Kingdom, or carrying Coaftwife, Gun-powder or Salt-Petre, or any Sort of Arms or Ampowder of Sält-Petre, or any Sort of Arms or Am-munition, will expire upon the Sixth Day of De-cember next: And whereas it is judged expe-dient for His Majefty's Service, and the Safety of this Kingdom, that the faid Prohibition fhould be continued for fome Time longer, His Majefty doth therefore; by and with the Advice of His Privy Council, hereby order, require, prohibit, and command, that no Perfon or Perfons whatfo-ever, (excent the Mafter General of the Ordnance ever, (except the Maîter-General of the Ordnance for His Majefty's Service,) do at any Time, during the Space of Six Months, to commence from the faid Sixth Day of December next, prefume to transport into any Parts out of this Kingdom, or carry Coastwife, any Gunpowder or Salt-Petre, or any Sort of Arms or Ammunition, or thip or lade any Gunpowder or Salt-Petre, or any Sort of Arms or Ammunition on board any Ship or Veffel, in order to transporting the fame into any Parts beyond the Seas, or carrying the fame Coaftwife, without Leave or Permiffion in that Behalf first obtained from His or Permiffion in that Behalf first obtained from His-Majefty or His Privy Council, upon Pain of incur-ring and fuffering the respective Forfeitures and Pe-nalties inflicted by an Act paffed in the Twenty-ninth Year of His late Majefty's Reign, initialed "An "Act to empower His Majefty to prohibit the "Exportation of Salt-Petre, and to enforce the "Law for empowering His Majefty to prohibit "the Exportation of Gunpowder, or any Sort of "Arms or Ammunition; and allo to empower " Arms or Ammunition; and also to empower " His Majelty to reftrain the carrying Coaltwile of " Salt Petre, Gunpowder, or any Sort of Arms or " Ammunition:"—And the Right Honorable the Lords Commissioners of His Majesty's Treasury; the Commissioners for executing the Office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Master-General and the. sreft of the principal Officers of the Ordnance, and His Majesty's Secretary at War, are to give the

necessary Directions herein, as to them may respectively appertain. W. Fawkener.
