The KING's Most Excellent Majesty in Council.

THEREAS by an Act, passed in the Twenty-VV eighth Year of the Reign of His present Majesty, intituled "An Act for regulating the Trade between the Subjects of His Majesty's Co-46 Ionies and Plantations in North America and in the West India Islands, and the Countries belong-46 ing to the United States of America, and between "His Majesty's faid Subjects and the Foreign Islands in the West Indies;" it is, amongst other Things, enacted, That it shall and may be lawful for Iis Majesty in Council, by Order or Orders to be issued and published from Time to Time, to authorize, or by Warrant or Warrants under His Sign Manual, to empower the Governor of Newfoundland for the Time being to authorize, in case of Necessity, the Importation into Newfoundland of Bread, Flour, Indian Corn, and Live Stock, from any of the Territories belonging to the faid United States, for the Supply of the Inhabitants and Fishermen of the Island of Newfoundland for the then enfuing Season only; provided always, that such Bread, Flour, Indian Corn, and Live Stock, fo authorized to be imported into the Island of Newfoundland, shall not be imported except in Conformity to fuch Rules, Regulations, and Restrictions as shall be specified in such Order or Orders, Warrant or Warrants respectively; and except by British Subjects, and in British-built Ships owned by His Majesty's Subjects, and navigated according to Law; and whereas it is expedient and necessary, that Provision be made for fully supplying the Inhabitants and Fishermen of the Island of Newfoundland for the ensuing Scason, with Bread, Flour, Pease, Indian Corn, Butter, and Live Stock, His Majelly doth thereupon, by and with the Advice of His Privy Conneil, hereby order and declare, that for the Supply of the Inhabitants and Fishermen of the Island of Newfoundland for the ensuing Scason only, Bread, Flour, Pease, Indian Corn, Butter, and Live Stock may be imported into the Said Island from any of the Territories belonging to the faid United States, by British Subjects, and in British-built Ships owned by His Majesty's Sub-

T the Court at the Queen's Palace, the 28th | jects, and navigated according to Law; and which, within the Space of Nine Months previous to the Time of fuch Importation, have cleared out from fome Port of the United Kingdom of Great Britain and Ireland, or other His Majesty's Dominions in Europe, for which Purpose a Licence shall have been granted by the Commissioners of His Majesty's Customs in England or Scotland, or the Commif-tioners of His Majesty's Revenue in Ireland, or any other Person or Persons who may be duly authorized in that Kingdom respectively, in the Manner and Form hereinafter mentioned; which Licence shall continue and be in Force for Nine Calendar Months, from the Day of the Date upon which such Licence is respectively granted, and no longer; provided that no such Licence as aforesaid, granted after the 30th Day of September next, shall be of any Force or Effect. And His Majesty is hereby further pleafed to order, that the walter or Person having the Charge or Command of any Ship or Veffel to whom fuch Licence shall be granted, shall, upon the Arrival of the said Ship or Vessel at the Port, Harbour, or Place, in the Island of Newfoundland, where he shall discharge such Bread, Flour, Pease, Indian Corn, Butter, and Live Stock, deliver up the faid Licence to the Collector, or other proper Officer of the Customs there, having first indorsed on the Back of such Licence the Marks, Numbers, and Contents of each Package of Bread, Flour, Pease, Indian Corn, Butter, and the Number of Live Stock, under the Penalty of the Forfeiture in the faid Act mentioned; and the Collector or other proper Officer of the Cultoms at Newfoundland, is hereby enjoined and required to give a Certificate to the Mailer or Person having the Charge or Command of fuch Ship or Vessel, of his having received the faid Licence so indorfed as before directed, and to trusfinit the fame to the Commissioners of His Majetty's Cuttoms in England or Scotland, or to the Commissioners of His Majetty's Revenue in Ireland respectively, by whom such Licence was granted. Now be it known, that the faid [Perfon's Name] hath a Licence to lade on board the faid Ship, [Ship's Name] at and from any Port or Place belonging to the United States of America, Bread, Flour, Peafe, Indian Corn, Butter, and Live Stock, the Produce of the faid United States, and no other Article whatever; and to carry the faid Bread, Flour, Peafe, Indian Corn, Butter, and Live Stock to fome Port or Place in the Island of Newfoundland; and on the Arrival of the faid Ship at any Port, Har-bour, or Place of Discharge in Newfoundland, the Master or Person having the Charge or Command of the faid Ship, is required and enjoined to deliver up the faid Licence to the Collector or other proper Officer of His Majesty's Customs there, and to endorse on the Back thereof the Marks, Numbers, and Contents of each Package of Bread, Flour, Peafe, Indian Corn, Butter, and the Number of Live Stock, and shall thereupon receive a Certificate thereof from the faid Collector, or other proper Officer of the Customs.

This Licence to continue in Force for "Calendar Months from the Date hereof.

I HAVE the Honour to acquaint your Lord-Thip, that I have this Day captured a French Cutter, Letter of Marque, Le Chasseur, of Thirtytwo Tons, Two Carriage-Guns, and Thirty-fix Men, commanded by Pr. Callier; Twenty-four Men only were found on board, Twelve having been Sent in Prizes.

His Majesty's Cutter Carrier, at Sea, My LORD, February 20, 187.

I HAVE the Honour to acquaint your Lordship, that having Yesterday chaced Le Chasseur French Cutter Privateer into the Hands of Captain Farquhar, of His Majesty's Ship Ariadne, I was this Morning returning to my Station, accompanied by the Princess Augusta Cutter, when at Nine A.M. Goree bearing S. by E. distant Ten Leagues, we discovered a suspicious Sail on the N. E. Quarter, steering in for the Dutch Coast, to which I immediately gave chace, and at Two P. M. came up with, and captured the French Schooner Privateer Le Ragotin, commanded by Jaques Jappie, mounting Eight Guns, which were thrown overboard in the Chace, with a Complement of Twenty-nine Men; Eight Days from Dunkirk, without having made any Capture, and this being her first Cruize.
