T the Court at the Queen's Palace, the 12th, of August 1807,

PRESENT,

The KING's Most Excellent Majesty in Council.

IS Majesty having been pleased to appoint the Right Honourable James Earl of Malmefbury to be Lord Lieutenant of the County of Southampton, and of the Town of Southampton, and County of the same, his Lordship, this Day, took the Oaths appointed to be taken thereupon, inflead of the Oaths of Allegiance and Supremacy.

An Act for the better Government of the Settlements of Fort Saint George and Bombay; for the Regulation of Public Banks; and for amending for much of an Act, passed in the Thirty-third Year of His present Majesty, as relates to the Periods at which the Civil Servants of the East India Company may be employed in their Service Abroad.

An Act to permit, until the End of the next Seffion of Parliament, the Importation of Swediffi Herrings into Creat Britain.

An Act for discharging from the Claims of the Crown-certain real and perional Edutes belonging to General De Lancey, late Barrack-Mafter-General, and velted in Truftees for Sale.

An Act for maintaining and preferving a Military Canal and Road made from Shorncliff, in the County of Kent, to Cliff End, in the County of Suffex; and for regulating the taking of Rates and Tolls
