passing this Act:

We, the underligned Lords Commissioners of His Majelty's Freasury, pursuant to and in Execution of the Powers vested in us in and by the said Act, do hereby declare that it appears to us to be expedient that the Provisions of the said Act should be extended to Sarsaparilla legally imported or brought into the Port of London, (not being imported by the United Company of Merchants of England trading to the East Indies, or not being imported from the West Indies;) and that fuch Sarsaparilla should be added to the List of Goods, Wares, and Merchandize enumerated and described in the said Table annexed to the faid recited Act marked (E); and that fuch Sarsaparilla should be lodged and secured under the joint Locks of the Crown and the Merchant in such Warehouse or Warehouses as aforesaid, under the Regulations and Directions of the faid Act: And we do further declare, that from and after the Publication of this our Certificate in the London Gazette, conformable to the Directions of the said Act, all and every the Provisions, Regulations, and Restrictions of the said Act shall extend, and be construed to extend, to all such Sarsaparilla in every Respect, in as full and ample a Manner as if the same had been inserted and enumerated in Table (E) annexed to the faid Act at the Time of the passing the fame Act.
