PRESENT,

The KING's Most Excellent Majesty in Council.

HEREAS His Majesty, by His Order in Coa cil of the Eleventh of November last, was pleased to order and declare, that all Trade in Articles which are of the Produce or Manufacture .of France or her Allies, or of any other Country at Way with His Majetty, or from which, although not at War with His Majetty, the british Flag is excluded, or of the Colonies belonging to His Majuly's. Enemies, should be deemed and considered to be unlawful (except as is therein excepted :: And whereas His Majetty, by His further Order in Council of the Twenty fifth of November lait, was pleased to order and declare, that nothing in the aforefaid Order of the Eleventh November contained, should extend to subject to Capture and Confifcation any Articles of the Produce and Manufacture of the faid Countries and Colonies laden on board Britis. Ships, which would not have been full jest to Capture and Confiscation if such Order had kaut been made.

His Majerty, taking the faid Orders into Confideration, is pleafed, by and with the Advice of His Privy Conneil, to order, and it is hereby ordered, that nothing in the faid last-mentioned Order shall extend, or be configured to extend, to authorize British Ships to export and convey any Articles of the Produce or Manufacture of the faid Countries, or Colomies, from Gueraley, Jersey, Man, Cibraliar, Malta. or from any Neutral or Allied Country, to any other Country or Place than to a Port of the United Kingdom, unless such Articles shall have been previously imported into such Places as aforefaid from some Port of the United Kingdom. Esstratt of a Letter from Vice-Admiral Whished, Comnsander in Civief of His Majetty's Ships and Veffels at Cork, to the Hon. W. W. Pole, dated on board His Majesty's Ship Trent, in Cork frarbour, the 29th of March 1808.

BE pleased to acquaint the Lords Commissioners of the Admiralty, that His Majetty's Ship Dryad arrived this Day with a French Privateer which the captured, as feated in Captain Drummond's Letter to me, a Copy of which 'I have the Honour to inclose,

Dryad, at Sea, March 22. 1808. I HAVE great Satisfaction in reporting to you the Capture of the French Brig Privateer-Remain, by His Majelty's Ship under my Command, in Lat. 47° N and Long. 11' W. She has Ports for Eighteen Guns, but only mounts Twelve Siz-Pounders, and Two Twelve-Pounder Carronades; failed from Bourdeaux on the 10th Inflant, with a Complement of Ninety-live Men, the helf of which are Danes. She is a new Vessel, and was on her first. Cruize; coppered, fails very fast, and complete with Provisions and Stores for Three Months. The oaly Capture she has made is a Portuguese Schooner bound to Cork, laden with Salt.
