Shares each. The Corporals of Marines Three Shares each. The Able Seamen, Ordinary Seamen, and Marines, One and a Half Share each. The Landmen, together with Paffengers and other Perfons borne as Supernumeraries, doing Duty and affifting on board, to receive One Share each. Boys of all Deferiptions, Half a Share each.

But it is Our Intention, neverthelefs, that the above Diffribution shall only extend to fuch Captures as shall be made by any Cutter, Schooner, Brig, or Armed Veffel, without any of Our Ships or Veffels of War being prefent, or within Sight of, and adding to the Encouragement of the Captors, and Terror of the Enemy; but in cafe any of Our Ships or Veffels of War shall be present, or in Sight, that then the Officers, Pilots, Petty Officers, and Men on board fuch Cutters, Schooners, Brigs, or Armed Veffels, shall share in the fame Proportion as is allowed to Perfons of the like Rank and Denomination on board of Our Ships and Veffels of War; the Sub-Lieutenant and Master to be confidered as Warrant Officers; and fuch Cutters, Schooners, Brigs, or Armed Veffels shall not, in respect to fuch Captures, convey any Intereft or Share to the Flag-Officer or Officers under whole Orders fuch Cutters, Schooners, Brigs, and Armed Veffels may happen to be . And whereas it is judged expedient, during the prefent Hostilities, to hire into Our Service Armed Veifels, to be employed as Cruizers against the Enemy, which Veffels are the Property of, and their Mafters and Crews are paid by the Owners of whom they are hired, although feveral of them are commanded by Our Commissioned Officers in Our Pay, it is Our further Will and Pleafure that the Neat Produce of all Prizes taken by fuch Hired Armed Veffels, (except as hereinaftermentioned,) shall be for the Benefit of Our Commiffioned Officers in Our Pay, and of the Mafters and Crews on board the faid Hired Armed Veffels at the Time of the Capture ; and that fuch Prizes may be lawfully fold and difpofed of by them and their Agents, after the fame shall have been to Us finally adjudged lawful Prize, and not otherwife; the Diffribution whereof shall be as follows :- The Whole of the Neat Produce being divided into Eight equal Parts,

Our Officer commanding any Hired Armed Veffel, who fhall be actually on board at the taking of any Prize, thall have Two Eighths; but in cafe fuch Hired Armed Veffel fhall be under the Command of a Flag or Flags, the Flag-Officer or Officers being actually on board, or directing or affifting in the Capture, fhall have One Third of the faid Two Eight Parts; the faid One Third of the Two Eighth Parts to be paid to fuch Flag or Flag.Officers in fuch Proportions, and fubject to fuch Regulations, as are hereinaftermentioned. — In cafe there be afting on board fuch Hired Armed Veffel, befides Our Officer i commanding the fame, One or more of Our Commiffioned Sea Licutenants in Our Pay, fuch Lieutenant or Lieutenants shall take One Eighth -One Eighth shall belong to the Master and Mate; of which the Master shall take Two-Thirds, and the Mate One-Third : But in cafe there shall be acting on board fuch Hired Armed Veffel One or more Midshipmen, in that Cafe the Master shall take One-Half of the Eighth, and the other Half shall be divided equally between the Mate and Midshipmen .---The remaining Four Eighth Parts shall belong to, and being divided into Shares, be diffributed among the other Petty Officers, Men, and Boys, in the fame Proportion as hereinbefore directed with refpect to the Division of Prize-Money in Our Ships of War .- And, in the Cafe of Prizes taken by any Hired Armed Veffel not commanded by any of Our Commissioned Officers, One-Eighth shall belong to the Flag-Officers, to be divided as aforefaid, in cafe fuch Hired Armed Veffel shall be under the Command of a Flag .- One-Eighth shall belong to the Master and Mate; of which the Mafter shall take Two-Thirds, and the Mate One-Third .- Four-Eighths shall belong to and be divided among the Petty Officers and Crew in Manner aforefaid .- The Surplus, the Diftribution of which is not herein directed, shall remain at Our Difposal; and, if not disposed of within a Year after final Adjudication, the fame fhall belong and be paid to Greenwich-Hofpital .- And in the Cafe of Prizes taken jointly, by any of Our Ships of War and any Hired Armed Veffel, Our Commissioned Officer or Officers on board such Hired Armed Veffel shall share with Our Commiffioned Officer or Officers of the fame Rank on board Our Ship or Ships of War, being joint Captors; the Master of fuch Hired Armed Veffel shall share with the Warrant Officers; the Mate of fuch Hired Armed Veffel with the Firit Clafs of Petty Officers; and the Seamen, Landmen, and Boys of fuch Hired Armed Veffel with Perfons of the fame Description on board Our faid Ship or Ships of War; fave and except, that, in cafe fuch Hired Armed Veifel shall be commanded by One of Our Commissioned Officers having the Rank of Mafter and Commander, and there shall be none of Our Lieutenants on board; cr in cafe fuch Hired Armed Veffel shall be commanded by the Mafter, in both those Cafes the Master of fuch Hired Armed Vessel shall share with the Lieutenants of Our Ships of War, and the Mate with the Warrant Officers .- And in Cafe any Difficulty shall arise in respect to the faid Distribution, not herein fufficiently provided. for, the fame shall be referred to Our Lords Commissioners of the Admiralty, whose Direction thereupon shall be final, and have the fame Force
