I HAVE the Honour to inform you, that this Morning at Three o'Clock A. M. Lat. 17° 5' N. Long. 93° 13' E. I captured the French Privateer Brig L'Adele, of Two Hundred and Eighty Tons and One Hundred and Forty-three Men, pierced for Eighteen Guns, but mounting only Eight Twelve-Pound Carronades and Two long Twelve-Pounders. She failed from the Isle of France on the 14th of Jast July, and carries Seven Months Water and Provisions for One Hundred and Fifty Men.
