The KING's Most Excellent Majesty in Council.

WHEREAS by an Act, passed in the Forty-eighth Year of His Majesty's Reign, intituled "An Act for further continuing, until Three Months after the Ratification of a Definitive Treaty of Peace, an Act, made in the Forty-fourth Year of His present Majesty, for permitting the Importation into Great Britain of Hides and other Articles in Foreign Ships," it is enacted, that an Act, made in the Forty-fourth Year of His present Majesty, inti-tuled "An Act for permitting, until the Fifth Day of May, One thousand eight hundred and five, the Importation of Hides, Call-Skins, Horns, Tallow, and Wool, (except Cotton Wool,) in Foreign Ships, on Payment of the like Duties, as if imported in British or Irish Ships;" which, by an Act, made in the Forty-fifth Year of His present Majesty, was revived and further continued until the Twenty-fifth Day of March One thousand eight hundred and fix, and extended to Goat-Skins imported in Foreign Ships; and which was further continued by an Act, made in the Forty-seventh Year of His present Majetly, until the Twenty-fifth Day of March, One thousand eight hundred and eight, shall be, and the same is thereby further continued until Three Months after the Ratification of a Definitive Treaty of Peace: And whereas His Majesty was pleafed, by His Order in Council of the Twenty-first Day of September last, pursuant to the Powers velled in His Majelly by the faid Act, to allow, for the Space of Six Months from the Twenty-fitch Day of the faid Month of September, the Imporation in Foreign Ships of any Hides, Pieces of Hides, dreffed or undreffed, Cali-Skins, or Pieces of Calf-Skins, dreffed or undreffed, Horns, or Pieces of Florns, Tailow, and Wool, (except Cotton Wool,) and Goat-Skins, dreffed or undreffed, on the Terms specified in the said Order: And whereas it is judged expedient for His Majesty's Service, that the said Permission should be continued for some Time longer, His Majesty is thereupon pleased, by and with the Advice of His Privy Council, to allow, and doth hereby allow, for the Space of Six Months from

T the Court at the Queen's Palace, the 16th the Twenty-fifth Day of this instant March, the Importation of any Hides, Pieces of Hides, defied or undressed, Calf-Skins, or Pieces of Calf-Skins, dressed or undressed, Calf-Skins, or Pieces of Calf-Skins, dressed or undressed, Horns, or Pieces of Horns, Tallow, and Wool, (except Cotton Wool,) and Goat-Skins, dressed or undressed, in any Foreign Ship or Vessel; and His Majesty doth hereby order, that, on the Arrival at any Port of the United Kingdom of any Foreign Ship or Vessel, with any of the Articles above mentioned Vessel, with any of the Articles above mentioned, the said Goods shall be admitted to Entry on Payment of the same Duties of Customs and Excise as are due and payable on the like Goods when imported in any British or Irish-built Ship or Vessel .-And the Right Honourable the Lords Commis-fioners of His Majesty's Treasury are to give the necessary Directions herein accordingly.
