A T the Council-Chamber Whitehall, the 18th of April 1809,

PRESENT,

The Lords of His Majesty's Most Honourable Privy Council.

HEREAS by an Act, passed in the Fortyfifth Year of His Majesty's Reign, intituled, de An Act for making further Provision for the effecauch Performance of Quarantine," it is among other Things enacted, That it shall and may be lawful for the Lords and others of His Majesty's Privy Council, or any Three or more of them, to make such Order as they shall see necessary and expedient upon any unforeseen Emergency, or in any particular Case or Cases with respect to any Ship or Ships, Vessel or Vessels arriving and having any infectious Difease or Distemper on board, or on board of which any infectious Difease or Distemper may have appeared in the Course of the Voyage, or arriving under any other alarming or fuspicious Circumstances as to Infection, although fuch Ship or Ships, Veffel or Vessels shall not have come from any Place or Places from which His Majesty, His Heirs or Successors, by and with the Advice of His or Their Privy Council, may have adjudged and declared it probable that the Plague, or any fuch infectious .Difease or Distemper may be brought, and also with respect to the Persons, Goods, Wares, and Merchan--dize on board the same; and all such Orders so made by the Lords or others of the Privy Council, or any Three or more of them as aforefaid, shall be -as good, valid, and effectual to all Intents and Purposes (as well with respect to the Commander, Mafter, or other Person having the Charge of any . Such Ship or Vessel, and all other Persons on board the same, as with respect to any other Persons having any Intercourse or Communication with them, and to the Penalties, Forfeitures, and Punishments to which they may respectively become liable) as !

any Order of Orders made by His Majesty, His Heirs or Successions, by and with the Advice of His or Their Priv, Council concerning Quarantine, and the Prevention of Infection as aforefaid, and notified by Proclamation or published in the London Gazette:

And where a Advices have been received, that a dangerous Fe : of a very contagious Description has prevailed in the Ports of Stockholm and Carlscrona, and p. ricularly the latter, and has raged with the most facel Violence during even the Severity of the Winter; and as there mult have been some Danger of the same having spread throughout the Kingdom of Ewiden, it is hereby ordered in Council, That all Ships and Vessels coming from or having touched at the Ports of Stockholm or Carlferona, or any other Port in Sweden, or having received any Person or Persons, Goods, Wares or Mercundize, Packets, Funkages, Baggage, Wearing and a rel, Books, Letters, or any other Articles warner or, from out of any Etch Ship or Veffel, shall, on their Arrival on the Coasts of this Kingdom, 2, of the Isles of Guernsey, Jersey, Alderney, Sark and Diday came to Anchor at fuch Place and Places as have been or shall be appointed by the Commissioners or His Majesty's Customs, within or without the Park to which such Ships or Ve els shall be bound, in order that the State of Health of the Crew are Perfons on board may be dray examined into a d afcertained, prior to fuch Ships and Veffels bein; permitted to enter the Port of their Destination; and that in the mean Time, no Intercourse with any other Ship or Vellel, or Zoat, or with the Shore, shall be permitted, nor any of the Crew or Persons on board such Ships or Veffels be suffered to come or be brought on Chore:

And it is hereby further Ordered, That in case upon such Examination it shall appear to the Super-intendant or other Principal Officer of the Customs employed in the Quarantine Service, that such Ships or Vessels have the same contagious Fever actually

on board, or that any of the Crew or Persons on board have been ill or have died of fuch contagious Fever within the Space of Forty Days prior to the Arrival of fuch Ships or Veffels on the Coasts of this Kingdom, or of the Islands aforesaid, or that in the Event of any Death occasioned by such contagious Fever having taken Place on board at an earlier Period of the Voyage than Forty Days prior to their Arrival on the Coasts of this Kingdom, or of the Islands aforesaid, the Clothes and Bedding, and all Personal Effects susceptible of Infection worn by or belonging to the Persons so deceased were not thrown overboard and funk immediately upon fuch Deceale, or as foon after as possible; or in case it shall appear that such Ships had within the Space of Forty Days, prior to Arrival on the Coasts of this Kingdom, or of the Islands aforefaid, received any Person or Persons, or any of the Articles hereinbefore mentioned, from out of any Ship, Vessel or Boat coming from the Ports of Stockholm and Carlicrona, or any other Port in Sweden, then and in fuch Cafe every fuch Ship and Vessel, with their Cargoes and Persons on board, shall persorm a Quarantine of Fifteen Days (or of fuch further Time as may be afterwards directed by any Order or Orders of Three of more of the Lords or others of His Majesty's Privy Council) at the feveral Places appointed for the Performance of Quarantine by Ships subject and liable thereto, and bound to the faid feveral Ports respectively:

And it is hereby further ordered, That notwithflanding the Ships and Velfels arriving or to arrive from any of the Ports of Sweden, may not be found liable to the Performance of Quarantine as above directed, no Goods, Wares, or Merchandize, enumerated in the First Class of His Majesty's said Order in Council, bearing Date the Fifth of April One thousand eight hundred and five, concerning Quaranting, which may be imported in any of the faid Ships from any of the Ports of Sweden, nor any Packages of Goods, which Packages may confill wholly or in Part of any of the faid Articles fo enumerated, be suffered to be landed or brought on Shore, but shall be taken out of the Ships and Vessels importing the fame, and fent to the usual Place appointed for the Performance of Quarantine, and be there opened and aired for the Space of Fifteen Days, as directed by His Majesty's said Order in Council of the Fifth of April One thousand eight hundred and five, Sec. 13. with respect to Goods, Wares and Merchandizes coming from or through the Mediterranean, or from the West Barbary on the Atlantic Ocean.

Copy of a Letter from Vice-Admiral Sir John Borlafe Warren, Bart. and K.B. Commander in Chief of His Majesty's Ships and Vessels at Halisax, to the Honourable William Wellesley Pole, dated at Bermuda, the 22d February 1809.

SIR,

HAVE the Satisfaction to inclose to you, for their Lordships' Information, the Copy of a Letter from Captain Scott, of His Majesty's Ship Horatio, who neturned here this Day with the French Frigate La Junon, of Forty-four Guns, Eighteen-Pounders, and Three Hundred and Twenty-three Men; captured after a very gallant Action, in which the good Conduct and Skill of Captain Scott, his Officers, and Men, appeared with much Distinction.

His Majesty's Ship Horatio, February 19, 1809.

I HAVE the Honour to acquaint you, that, in performing your Orders, in the Morning of the 10th Instant, in Lat. 19° 50' N. Long. 63' 30' W. standing on the Larboard Tack, Ship's Head South and by East, the Driver Sloop of War under my Orders about Fifteen or Sixteen Miles nearly aftern, at Half-pait Ten A. M. faw a Sail on our Lee Bow, and shortly afterwards another. In the Course of an Hour, we discovered the Lee one evidently to he an Enemy's Frigate, and the other one I took to

be an English Brig of War dodging her.

The Enemy's Frigate on making us out bore right up before the Wind for a short Time, but very soon hauled up again. At Three Quarters past Twelve, we met upon different Tacks and came to close Action, the Horatio wearing under the Enemy's Stern to get upon the same Tack with her. In the early Part of the Action the Country lost the Services of the First Lieutenan: Manley Hall Dixon, being badly wounded, and not long after, I am forry to fay, that I received a fevere Wound in the Shoulder by a Grape Shot, which obliged me to submit to quit the Deck: however, the Service did not fuffer by that Event, as the fucceeding Lieutenant the Honourable George Donglas fought the Ship through the Action in a most gallant Manner, which continued about One Hour and Thirty-five Minutes. The Enemy having from the Beginning pointed their Guns high, we were by this Time a complete Wreck in our Malts, Sails, and Rigging. Notwithstanding the Situation the Enemy was then reduced to, she tried to effect her Escape, which I knew was impossible, from the State of her Rigging, and more particularly as at that Time the Superieur (the Brig I before mentioned) hailed us, and gave us Information that the strange Sail just seem to On the Latona's coming Leeward was the Latona. within Gun Shot of the Enemy and giving her a few Guns, which she returned, and slightly wounded

to on the Starboard Tack, and every Mast went by the board. She proved to be the French Frigate La Junon, of Forty-four Guns, and Three Hundred and Twenty-three Men, commanded by Monf. Augustin Rousseau, a Member of the Legion of Honour; out from the Saints only Four Days, bound to France.

I now detail the Loss and Damages sustained by

His Majesty's Ship under my Command.

The Horatio has suffered but little in her Hull, from the Reason already given, of the Enemy's aiming particularly at our Malls and Rigging, which they effected, having nothing else standing but our lower Masts, much wounded, and completely difmantled, all to our Foresail, and the Rage of our Mainfail.

The Number of Officers, Seamen, and Marines lost on this Occasion to their Country and their Friends, are by no Means confiderable, when compared with the dreadful Lofs of the Enemy, which I shall hereafter relate. The Lofs on board the Horatio confitts of Mr. George Gunter, Midshipman, and Six Seamen, killed; Mr. Andrew Lock, Boatswain, and Twelve Seamen, badly wounded; Lieutenant Richard Blakeney, of the Royal Marines, Mr. Robert King, Mafter's Mate, Six Seamen, and Two Marines, flightly wounded. The Loss of the Enemy, as I have before stated, was all her lower Malts; her Hull most wonderfully cut up, making, in confequence, a great Deal of Water, until the Shot-Holes were stopped

The Loss in killed and wounded amounted to One hundred and thirty. The Captain expired foon after the Action from the Wounds he received.

The Gailantry and good Conduct of the Officers and Ship's Company under my Command, 1 must always remember with Gratitude, and were I to enter into Particulars it would be endlefs.

To Captain Ferrie, who commands the Brig Superieur (one of Sir Alexander Cochrane's Squadron), I feel much indebted for the very gallant Manner he behaved, although I believe he had only Four small Carronades on board; and to Captain Pigot of the Latona I shall ever feel thankful for his Exertions and Activity in creeting Jury Malts, &c. and putting the Prize in a Sea worthy State.

I have much Pleasure in informing you that the Junon appears a very fine Ship, only Three Years old, never having been at Sea before the left France,

about Three Months ago.
