This our most Humble and Hearry acknowledgment of Your Majesties transcendent Grace and Fawour to Your Subjects, as we do most submissively implore Your Majesties Acceptance of, as a Specimen of our most sincere Intentions; so we do with a like Humility and Earnestness, beseech the King of Kings to continue Your Majesties Sacred Life amongst us for many and many years; jesties Sacred Life amongst us for many and many years; that even future Generations may partake of the happy In success of Your Majesties Just and Peaceful Government. So unfeignedly Pray Your Majesties most Humble, Lo, al, and Duriful Subjects and Servants.
