## PRESĖNT,

The Lords of His Majefty's Most Honourable Privy Council.

WHEREAS by an Act paffed in the Fortyeighth Year of the Reign of His prefent Majefty, intituled " An Act for enabling His Majesty to establish a permanent Local Militia Force under certain Reftrictions, for the Defence of the Realm," it was, amongst other Things, enacted, that a permanent Local Militia Force should be raifed in such Counties, or Parts of Counties, as His Majefty should by any Warrant, under His Royal Sign Manual, direct : And whereas it was by the faid Act further enacted, that the faid Force should not in any County, or Part of any County, exceed Six Times the original Quota, or Proportion of original Quota of the Regular Militia: And whereas it was alfo, among other Things, further enacted, that the Warden of the Cinque Ports, Two ancient Towns, and their Members, should carry the faid Act into Execution, within his Jurifdiction, and fhould appoint the Number of Men to be raifed, in purfuance of the faid Act, for each of the faid Ports, Two ancient Towns, and their Liberties, and the feveral Members thereof respectively : And whereas by another Act passed in the Forty-ninth Year of the Reign of His prefent Majelty, it was, amongst other Things, lurther enacted, that it should be lawful for His Majefty's Privy Council to afcertain, fettle, and fix the Quota of Local Militia for the faid Cinque Ports, Two ancient Towns, and their Members, and for that Purpole to require and have all fuch Returns of the Number of Men liable to ferve, and exempt therein, as should be necessary to enable the faid Privy Council to regulate and fix a proper Quota for fuch Local Militia: And whereas Returns have been made to His Majelty's Privy Council of the Number

T the Council-Chamber Whitehall, the 14th | of Men liable to ferve, and exempt in the Cinque Ports, Two ancient Towns, and their Members, and of the Number of Volunteers ferving therein; His Majefty's Privy Council, in purfuance of the faid last mentioned Act of Parliament, and of the Powers and Authorities therein contained, have accordingly alcertained, fettled, and Exed, and do hereby ascertain, settle, and fix the Quota of Local Militia for the faid Cinque Ports, Two ancient Towns, and their Members, at One thousand five hundred, including the Volunteers, to be apportioned among the faid Ports, Two aucient Towns, and their Liberties, and the feveral Members thereof refpectively, according to the Provisions of the faid first recited Act. And His Majefty's Privy Council do order and direct, that this Order be transmitted to the Warden of the Cinque Ports, in order that he may proceed upon the fame, purfuant to the Directions of the faid first recited Act. ## PRESENT,

The KING's Most Excellent Majesty in Council.

HEREAS, by virtue of the Powers velted in His Majelty by fundry Acts of Parliament, His Majelty was pleafed, by His Order in Council, bearing Date the 12th of April lalt, to allow, and did thereby allow, until the Twenty-fifth Day of March One thousand eight hundred and ten, the Importation into any Port or Place of Great Britain, of certain Articles of Provision, in the Manner and under the Conditions therein mentioned; and whereas by an Act, paffed in the prefent Seffion of Parliament, it is enacted, that an Act, made in the Thirty-ninth Year of His prefent Majefly, intituled " An Act for enabling His Majetty to prohibit the Exportation, and permit the Importation of Corn, and for allowing the Importation of other Articles of Provision without Payment of Duty, to continue in Force until Six Weeks after the Commencement of the next Sellion of Parliament," which was continued by an AA of the Thirty-ninth and For-
