Lord High Treasurer, or the Commissioners of His! Majesty's Treasury for the time being, or any three or more of them, the same shall be fit and proper in every respect for the reception of such goods, wares, and merchandize, and wherein the same might respectively be safely and securely lodged, and remain under the regulations and directions in the said Act contained; and the said Lord High Treasurer, or Commissioners of His Majesty's Treasury for the time being, or any three or more of them, were thereby authorized and empowered, in writing under his or their hand or hands; to certify and make known his or their approbation of such waréhouses, which certificate should be published three times at least in the London Gas zette, and in two or more public morning newspapers usually circulated in London : And whereas the table marked (B) above referred to, is in the words following ; viz.
