At jeg i Kraft i den mig overdragne Myndighed, og i Overeensstemmelse med en Forordning af 23de May, samt en Placet af 12de August 1800, haver, efter herom indkommen Ansøgning, tilladt og bevilget, at Executorerne efter afgangne John Howe, nemlig Madame Mary Howe, som Executrix og Edward Stevens, Doctor William Stedman og Thomas Battelle som Executors, maa ved proclama sub pœna præclusi et perpetui silentii, indkalde alle bekendte eller ubekendte Creditorer, efter bemeldte afgangne John Howe og efterlevende Hustrue Mary Howe, boende i Europæiske eller Americanske herredømmer, at fremkomme med deres Krav, og indlevere samt bevisliggjøre deres Fordringer, personligen eller ved deres Fuldmægtige, for benævnte Executrix Mary Howe og Executorer Edward Stevens, William Stedman, og Thomas Battelle forinden expirationen af den nu her bestemte Tid, nemlig, forinden et Aar og Sex Uger, efter at dette proclama er bleven læst i Ovreretterne for Oerne St. Croix, St. Thomas, og St. Jan, og trenté paa hinanden følgende Gange publiceret i "the London Gazette;" og alle saadanne bekendte eller ubekendte Creditorer, som boe paa nogen af de Wertindiske Oer eller Colonier, skal fremkomme med deres Fordringer personligen eller ved deres Fuldmægtige, for benævnte Executrix og Executorer, forinden trede Maanedre fra den dato, da dette proclama er bleven læst i Ovr- og Underretterne paa Oerne St. Croix, St. Thomas og St. Jan, og Efterretning derom, trenté paa hinanden følgende Gange, bleven bekendtgjort i St. Croix Gazette. Og de forhen nævnte Executors, shall endvidere være forpligtet at lade denne Bevilling blive forevist i de Kongelige og Laane Commissionernes Bogholder Contoirer paa besagde Oer, og erhverve Attest om, at saadant er efterkommet; i manglende Fald skal dette Proclama ikke være gjeldende mod nogen af Hans Majestæts Fordringer eller Rettigheder; og have alle vedkommende dette at iagttage og sig derefter at rette.

BY virtue of the authority in me vested; and in conformity with an ordinance of the 23d May, and an edict of the 12th of August 1800, I do hereby make known, that, in compliance with a petition delivered in, I have permitted and granted, that the Executors of the deceased John Howe, viz. Mrs. Mary Howe, as Executrix, and Edward Stevens, Doctor William Stedman, and Thomas Battelle, as Executors, may summon by proclama sub pœna præclusi et perpetui silentii, all the known or unknown Creditors of the said deceased John Howe and surviving Widow Mary Howe, residing in European or American territories, to come forward with their demands, and to enter and prove their claims, in person or by their attorneys, before the said Executrix Mary Howe, and Executors Edward Stevens, William Stedman, and Thomas Battelle, previous to the expiration of the period herein-after limited, that is to say, within one year and six weeks from the period when this proclama shall have been recorded in the Upper Courts of the islands of St. Cruz, St. Thomas, and St. John, and published three times consecutively in the London Gazette; and all such known or unknown Creditors as reside in any of the West India islands or colonies, shall come forward with their demands, and enter and prove their claims in person, or by their attorneys, before the said Executrix and Executors, within three months from the date of this proclama being recorded in the Superior and Inferior Courts of the islands of St. Cruz, St. Thomas, and St. John; and notice thereof being published in the Santa Cruz Gazette three times consecutively. And the aforesaid Executors shall further be bound to cause this grant to be produced in the Royal and the Loan Commissions Book-Keeper's Offices to the said islands, and procure a certificate of this being complied with; in failure of which, this proclama shall not be valid against any claim or prerogatives of His Majesty; and all persons concerned, are to take notice hereof, and to conduct themselves accordingly.
