HEREAS the Parliament stands prorogued to Tuesday the first day of November next, We, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, do hereby publish and de-clare, that the said Parliament shall be further prorogued on the said first day of November to Fuesday the eighth day of said month; and We have given order to the Lord High Chancellor of, that part of the United Kingdom of Great Britain and Ireland called Great Britain, to prepare a Commission for proroguing the same ac-cordingly. And We do further hereby, in the name and on the behalf of His Majesty, and by and with the advice aforesaid, publish and declare, that the said Parliament shall, on the eighth day of November next, be held-and sit for the dispatch of divers ingent and important affairs : And the Lords Spiritual and Temporal, and the Knights, citizens, and Burgesses, and the Commissioners for -Shires and Burghs of the House of Commons, are thereby required and commanded to give their attendance accordingly, at Westminster, on the said eighth day of November next.  $\sim r$

His Royal Highness the Prince Regent has been has been pleased to honour him, in testimony of pleased, in the name and on the behalf of His Ma-Majesty, by letters patent under the great scal of the United Kingdom of Great Britain and Ircland, the confer the honour of Knighthood upon Neil Campbell, Esq. Colonel in the Army, Major in the 54th (or West Norfolk) Regiment of Foot, and Knight of the Imperial Russian Orders of St. Anne

And the Prince Regent being desirous of con-ferring upon the said Sir Neil Campbell, such a further mark of His Majesty's royal favour as may, in an especial manner, evince the sense he entertains of the highly distinguished services performed by that Officer at the conquest of the important colonies of Martinique, Guadaloupe, and their dependencies; at the assault and capture of Ciudad Rodrigo, and at the brilliant engagement on the plains of Salamanca; as also the great zeal and ability manifested by him while attached to the Russian army, in the glorious and ever-memorable campaigns, which have recently terminated in the restoration of peace in Europe, and more especially the signal intrepidity displayed by him in the action fought at Fere Champenoise in France, on the 25th day of March last; His Royal Highness has been pleased to grant unto the said Sir Neil Campbell His Majesty's royal licence and authority, that, to the armorial ensigns of his family, he and his descendants may bear the following honourable augmentation, that is to say, "On a chief a lion passant guardant, grasping in the dexter paw a sword; and on a canton, pendent from a ribbon, a representation of the badge of the Imperial Russian Military Order of St. George," conferred upon the said Sir Neil Campbell by His Majesty the Em-peror of All the Russias; and the following crest of honourable augmentation, that is to say, " Out of a mural crown, a demi lion guardant gutté de sang, grasping a sword as in the arms, and gorged with a ribbon, pendent therefrom a representation of the gold medal conferred upon him for his services at the aforesaid capture of Ciudud Rodrigo and. battle of Salamanca," and in an escrol above, this motto, "Fere Champenoise;" provided the said armorial distinctions be first duly exemplified according to the laws of arms, and recorded in the Heralds' Office :

And His Royal Highness hath been further pleased to command, that the said royal concession and especial mark of His Majesty's favour, be recorded in His College of Arms.

His Royal Highness the Prince Regent hath been pleased, in the name and on the behalf of His Majesty, to give and grant unto the Honourable Alexander Abercromby, 'Colonel in the Army, and Lieutenant-Colonel in the Coldstream Regiment of: Foot Guards; His Majesty's royal licence and permission, that he may accept and wear the insignia of a Knight of the Royal Portuguese Military Order of the Tower and Sword, with which His Royal Highness the Prince Regent of Portugal has been pleased to honour him, in testimony of the high sense which that Prince entertains of the distinguished courage and intrepidity displayed by that Officer in several actions which the enemy in the Fennsula : provided nevertheless; that His, Majesty's said licence and permission doth not authorise, and shall not be deemed or construct to authorise, the assumption of any style, appellation,
