#### ' A PROCLAMATION.

#### GEORGE, P. R.

WHEREAS a Treaty of Peace and Friend-ship, between His Majesty and the United States of America, hath been concluded at Ghent on the twenty-fourth day of December last, and the ratifications thereof have been duly exchanged : in conformity thereunto, We have thought fit, in the name and on the behalf of His Majesty, hereby to command, that the same be published through-out all His Majesty's dominions: And We do declare to all His Majesty's loving subjects Our will and pleasure, that the said Treaty of Peace and Friendship be observed inviolably as well by sea as land, and in all places whatsoever; strictly charging and commanding all His Majesty's loving subjects to take notice thereof, and to conform themselves thereunto accordingly.

Given at the Court at Carkon-House, the seventeenth day of March one thousand eight hundred and fifteen, in the fifty-fifth year of His Majesty's reign.

#### A PROCLAMATION,

Declaring the Cessation of Arms, as well by Sea as Land, agreed upon between His Majesty and the United States of America, and enjoining the observance thereof.

GEORGE, P.R.

HEREAS a Treaty of Peace and Amity, between His Majesty and the United States

fourth day of December last, by the Plenipotenti-aries of His Majesty and the Plenipotentiaries of the United States: And whereas, for the putting an end to the calamities of war, as soon, and as far as may be possible, it hath been agreed between His Majesty and the said United States as follows ; that is to say, that immediately after the ratifica-tions of the said Treaty, friendship should be established between His Majesty and the said United States, by sea and land, in all parts of the world; and, in order to prevent all causes of complaint and dispute which might arise with respect to prizes that might be taken at sea after the said ratifications of the said Treaty, it has also been reciprocally agreed, that all vessels and effects which may be taken after the space of twelve days from the said ratifications, upon all parts of the coasts of North America from the latitude of twenty-three degrees. north to the latitude of fifty degrees north, and as far eastward in the Atlantic Ocean as the thirtysixth degree of west longitude from the meridian of Greenwich, shall be restored on each side; that the time shall be thirty days in all other parts of the Atlantic Ocean north of the Equinoctial Line or Equator, and the same time for the British and Irish Channels, for the Gulf of Mexico, and all parts of the West Indies; forty days for the North Seas, for the Baltie, and for all parts of the Me-diterranean; sixty days for the Atlantic Ocean south of the Equator, as far as the latitude of the Cape of Good Hope; ninety days for every other part of the world south of the Equator; and one hundred and twenty days for all other parts of the world without exception : And whereas the ratifi-cations of the said Treaty were exchanged on the seventeenth day of last month, from which day the several terms abovementioned of twelve days, thirty days, forty days, sixty days, ninety days, and one hundred and twenty days, are to be computed; now, in order that the several epochs fixed as aforesaid, between His Majesty and the said United States, should be generally known and observed, We have thought fit, in the name and on the behalf. of His Majesty, and by and with the advice of His Majesty's Privy Council, to notify the same to His of America, was signed at Ghent on the twenty- | Majesty's loving subjects; and We do hereby, in the name and on the behalf of His Majesty, strictly charge and command all His Majesty's Officers both at sea and land, and all other His Majesty's subjects whatsoever, that they forbear all acts of hostility, either by sea or land, against the United States of America, or the citizens thereof, under the penalty of incurring His Majesty's highest displeasure.

#### A PROCLAMATION.

THEREAS a great number of disorderly persons have, during the three last days, publicly assembled themselves together in a riotous and tumultuous manner, and have been guilty of many violent and criminal acts and proceedings, having attacked the persons and houses of many of His Majesty's loyal subjects in several parts of the eity of Westminster and county of Middlesex, and especially in the evenings and during the nights of the said three days; We, therefore, taking the same into Our most serious consideration, and being fully determined on Our part to use all means in Our power to protect the lives and properties of His Majesty's loyal subjects, to preserve the public

exhort, charge, and command all His Majesty's loyal subjects to give their assistance in discountenancing and suppressing all such criminal acts and proceedings, and to give all information to the Magistrates, by which the disturbers of His Majesty's peace may be brought to punishment : and We do hereby enjoin and require all Justices of the Peace, Sheriffs, Mayors, Bailiffs, Constables, and all other His Majesty's loving subjects, to be aiding and assisting to the utmost of their power, in suppressing such criminal acts and proceedings, and in detecting, apprehending, and bringing to, justice the persons concerned in the same: and for the better detection of any person or persons who were or may be concerned in any such criminal acts and proceedings, We are graciously pleased to promise, that if any person shall discover any other person or persons who, directly or indirectly, was or were, or may be concerned therein, so as that the person or persons discovered may be prosecuted for the same, such discoverer shall have and receive as a reward, upon conviction of such offender or offenders, the sum of ON HUNDRED POUNDS, and also His Majery's gracious pardon for the said offence, in case the person making such discovery shall himself be liable to be prosecuted for the same.

WHEREAS by an Act, passed in the fifty-, third year of His Majesty's reign, cap. 155, it is enacted, that it shall not be lawful for any private person or persons to import any goods, wares, or merchandise, from any port or place within the limits of the East, India Company's charter, except only into such ports of the United., Kingdom of Great Britain and Ireland as shall be. provided with warehouses, together with wet docks or basins, or such other securities as shall, in the judgment of the Lord High Treasurer, or of the Lords Commissioners of the Treasury for the time . being, or any three or more of them, in Great Bri-... tain and Ireland respectively, be fit and proper for... the deposit and safe custody of all such goods, ... wares, and merchandise, as well as for the col-., lection of all duties payable thereon, and shall, have been duly declared so to be, by the Order of., His Majesty in Council, in Great Britain, or, by the Order of the Lord Lieutenant in Council, in, peace, and to bring to condign punishment the Ireland: and whereas the ports of Greenock and port authors of such violences, have thought fit, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, to issue this Proclamation, and thereby strictly to for the collection of all duties payable thereon; His Royal Highness the Prince Regent, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, is thereupon pleased to declare, and it is hereby declared, that the ports of Greenock and port Glasgow are ports fit and proper for the deposit and safe custody of all such goods, wares, and merchandise, as well as for the collection of all duties payable thereon : and the Right Honourable the Lords Commissioners of His Majesty's Treasury are to give the necessary directions herein accordingly.

THEREAS the time limited by the Order of His Royal Highness the Prince Regent in Council of the twenty-third day of July last, for prohibiting the exportation out of this kingdom, or carrying coastwise, gunpowder or salt petre, or carrying coastwise, gunpowder or sait pere, or any sort of arms or ammunition, has ex-pired; and whereas it is judged expedient for His Majesty's service, and the safety of this king-dom, that the said prohibition should be con-tinued for some time longer; His Royal Highness, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, doth, therefore, hereby order, require, council, doth, therefore, hereby order, require, prohibit, and command, that no person or persons whatsoever (except the Master-General of the Ordnance for His Majesty's service) do, at any time during the space of six months (to com-mence from the date of this Order), presume to transport into any parts out of this kingdom, or carry coastwise, any gunpowder or salt petre, or new sort of arms or ammunition or ship or any sort of arms or ammunition, or ship or lade any gunpowder or salt petre, or any sort of arms or ammunition, on board any ship or vessel, in order to transporting the same into any parts beyond the seas, or carrying the same coastwise, without leave or permission in that be-half first obtained from His Majesty, or His Privy Council, upon pain of incurring and suffering the respective forfeitures and penalties inflicted by an Act, passed in the twenty-ninth year of His late Majesty's reign, intituled " An Act to empower "His Majesty to prohibit the exportation of salt " petre, and to enforce the law for empowering "His Majesty to prohibit the exportation of gnn-" powder, or any sort of arms or animunition, " and also to empower His Majesty to restrain the " carrying coastwise of salt petre, gunpowder, or " any sort of arms or ammunition :" But it is His Royal Highness's pleasure, that nothing in this Order contained shall prevent the exportation of any of the articles, specified in the Order in Council of the twentieth of May one thousand eight hundreil and thirteen, to the coast of Africa, under the

#### PRESENT,

His Royal Highness the PRINCE REGENT in Council,

WHEREAS the time limited by the Order of His Royal Highness the Prince Regent in Council of the twenty-third day of July last, prohibiting, in the name and on the behalf of His Majesty, the transporting into any parts out of this kingdom of any pig iron, bar iron, hemp, pitch, tar, rosin, turpentine, anchors, cables, cordage, masts, yards, bowsprits, oars, oakum, or other naval stores, has expired; and whereas it is judged expedient for His Majesty's service, and the safety of this kingdom, that the said prohibition should be continued for some time longer; His Royal Highness the Prince Regent, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, doth therefore hereby order, require, prohibit, and command, that no per-son or persons whosoever do, at any time for the space of six months from the date of this Order, presume to transport into any parts out of this kingdom, any pig iron, bar iron, hemp, pitch, tar, rosin, turpentine, anchors, cables, cordage, masts, yards, bowsprits, oars, oakum, sail-cloth or canvas, or other naval stores (sheet copper excepted), or do ship or lade any pig iron, bar iron, hemp, pitch, tar, rosin, turpentine, anchors, cables, cordage, masts, yards, bowsprits, oars, oakum, sailcloth or canvas, or other naval stores (sheet copperexcepted), on board any ship or vessel, in order to transporting the same into any parts beyond the seas, without leave or permission first being had and obtained from His Majesty or His Privy Conneil, upon pain of incurring the forfeitures inflicted by an Act, passed in the thirty-third year of His Majesty's reign, initialed, "An Act to enable "His Majesty to restrain the exportation of naval " stores, and more effectually to prevent the exportation of salt petre, arms, and ammunition, when prohibited by Proclamation or Order in Council;" But it is nevertheless His Royal Highness's pleasure, that nothing herein contained shall extend, or be construed to extend, to any of His Majesty's ships of war, or any other ships or vessels or boats in the service of His Majesty, or employed or freighted by His Majesty's Board of Ordnance, or by the Commissioners of His Majesty's Navy; nor to prevent any ship or vessel from taking or baving on board such quantities of naval stores as may be necessary for the use of such. conditions contained in the said Order. And the ship or vessel during the course of her intended Right Honourable the Lords Commissioners of voyage, or by licence from the Lord High Admiral

of Great Britain, or the Commissioners of the Admiralty for the time being; nor to the exportation of the said several articles to Ireland, or to His Majesty's yards or garrisons, or to His Majesty's colonies and plantations in America or the West Indies, or to Newfoundland, or to His Majesty's forts and settlements on the coast of Africa, or to the island of Saint Helena, or to the British settlements or factories in the East Indies; provided that, upon the exportation of any of the said articles for the purposes of trade to Ireland, or to His Majesty's yards and garrisons, or to His Majesty's colonies and plantations in America or the West Indies, or to the island of Newfoundland, or to His Majesty's forts and settlements on the coast of Africa, or to the island of Saint Helena, or to the British settlements or factories in the East Indies, the exporters of such articles do first make oath of the true destination of the same to the places for which they shall be entered outwards, before the entry of the same shall be made, and do give full and sufficient security by bond (except as hereinafter excepted), to the satisfaction of the Commissioners of His Majesty's Customs, to carry the said articles to the places for which they are so entered outwards, and for the purposes specified, and none other; and such bond shall not be cancelled or delivered up, until proof be made to the satisfaction of the said Commissioners, by the production, within a time to be fixed by the said Commissioners and specified in the bond, of a certificate or certificates, in such form and manner as shall be directed by the said Commissioners, shewing that the said articles have been all duly landed at the places for which they were entered outwards. But it is His Royal Highness's pleasure, nevertheless, that the following articles, viz. bar iron, white and tarred rope, tallow or mill grease, tarpaulins for waggon covers, pitch, tar, and turpentine, shall be permitted to be exported, upon payment of the proper duties, without bond being entered into by the merchant exporter, to any of the British plantations in the West Indies, or to any of His Majesty's settlements in South America; provided the merchant exporter shall first verify, upon oath, that the articles so exported are intended for the use of a particular plantation or settlement, to be named in the entry outwards, and not for sale, and that the said plantation or settlement has not before been furnished with any supply of the said articles during the same season; and provided also that the exportation of the said articles shall in no case exceed the value of fifty. pounds sterling for any given plantation or settlement, whether by one or more shipments, within the same season : and the Right Honourable the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, and the Lord Warden of the Cinque Ports, are to give the necessary directions herein as to them may respec-tively appertain.
