

On Friday the 18th and Monday the 21st, to Masters, Pursers, and Surgeons, and their Attornies.

After which the list will be recalled the first and third Wednesday in every month, that all persons may then and there attend to receive what may become payable to them, and not only bring with them the affidavit required, touching their not having enjoyed the benefit of any public employment, either at sea or on shore, during the time they are to be paid their half-pay, but also to produce certificates that they have subscribed to the Test; and taken the Oaths of Allegiance required by Act of Parliament, to His present Majesty; and in case any of the said Officers should not be able to attend themselves, but employ Attornies for that purpose, that the said Attornies do produce the like certificates and affidavits from the persons they are employed by.

Where Officers are abroad on leave, their agents are to produce attested copies of such leave, before the half-pay can be paid.

And as by Act of Parliament, passed in the thirty-fifth year of His present Majesty's reign, intituled, "An Act for establishing a more easy and expeditious Method for the Payment of Officers belonging to His Majesty's Navy," it is enacted by the twentieth clause of the said Act, "that if any Commissioned or Warrant Naval Officer who shall be entitled to receive Half-Pay, and shall be desirous to receive and be paid the same at or near the place of his residence, he may apply to the Treasurer of His Majesty's Navy, in London, to have such Half-Pay paid at or near the place of his residence; &c. in the manner pointed out by the said Act;" notice is hereby further given, that the half-pay ending the 30th of June 1815, will commence paying on the 14th instant; and all persons desirous of having their half-pay remitted to them, may apply as above directed.

That the deliveries are to commence on and for the 25th day of September next; that proposals in writing, sealed up and marked "Tender for Army Supplies," will be received at this Office on or before Friday the 25th day of August; but none will be received after twelve o'clock on that day, and, if sent by post, the postage must be paid.

Proposals must be made separately for each county and island, except for the counties comprising North and South Wales, all of which must be included in one tender, as also must the several counties in North Britain; and each proposal must have the letter which is annexed to the tender properly filled up by two persons of known property, engaging to become bound with the party tendering, in the amount stated in the printed particulars, for the due performance of the contract; and no proposal will be noticed unless made on a printed tender, and the prices expressed in words at length; and should it so happen that during the continuance of the contract no troops should be stationed or supplied in the county, the expence of the contract and bond, paid in the first
