

“ and, in his left, his fetters, broken, in allusion to his recent liberation;” the said supporters to be borne by the said Edward Viscount and Baron Exmouth, and by those to whom the said dignities shall descend in virtue of His Majesty's several letters patent of creation; provided these honourable armorial augmentations be first duly exemplified according to the laws of arms, otherwise the said royal licence to be void and of none effect:

And His Royal Highness has further been pleased to order, that this especial mark of the royal favour be registered in His Majesty's College of Arms.

His Royal Highness the Prince Regent has been pleased, in the name and on the behalf of His Majesty, to grant unto Sir Charles Phillips, Knight, Major-General of His Majesty's Forces, His Majesty's royal licence and permission that he may accept and wear the Grand Cross of the Royal Sicilian Order of St. Januarius, with which His Majesty the King of the Two Sicilies hath been pleased to honour him, as a testimony of the high sense that Sovereign entertains of the distinguished services rendered by the said Major-General in the defence of Sicily, and in the expedition to the coast of Naples in 1815:

And His Royal Highness hath been further pleased to command, that the said royal concession and declaration be registered in His Majesty's College of Arms.
