His Royal Highness the PRINCE REGENT in Council.

HEREAS the rules and regulations of His Majesty's Order in Council of the fifth of April one thousand eight hundred and five, touching the performance of quarantine, have been under-stood to apply to all ships or vessels coming last from ports not declared by the said Order liable to infection, if such ships or vessels had, in the course of their voyage, previously touched at, or taken in a cargo at a port declared liable to infection: and whereas no danger to the public health is to be apprehended from a relaxation of the said rule, in respect to such of the said ships or vessels as shall arrive at any port or place in the United Kingdom, or the islands of Guernsey, Jersey, Alderney, Sark, or Man, under the circumstances and according to the provisoes and conditions hereinafter expressed and contained, His Royal Highness the Prince Regent is therefore pleased, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, to order, direct, and ordain, that ships or vessels which having sailed from ports declared liable to infection, or having taken in a cargo or any goods at any port so declared liable to infection, shall afterwards have proceeded from such port to another port not declared liable to infection, and shall last sail from any such last mentioned port, and afterwards arrive from thence, either in ballast or with a cargo taken in at such port not declared liable to infection, at any port or place in the United Kingdom, or the islands of Guernsey, Jersey, Alderney, Sark, or Man; shall not be liable to the performance of quarantine; provided the Master or Commander, or any other person having the charge of any such ship or vessel, shall declare upon oath, that all goods, wares, or merchandize enumerated in the first or second class of His Majesty's aforesaid Order of the fifth of April one thousand eight bundred and five, which may have been received on board any such ship or vessel at any port de- [" continue and extend the provisions of an Act,

Messina, Leghorn, Genoa, or Marseilles.
And the Right Honourable the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Master-General and the rest of the principal Officers of the Ordnance, His Majesty's Secretary at War, and the Governors or Commanders in Chief for the time being of the Isles of Guernsey, Jersey, Alderney, Sark, and Man, are to give the necessary directions herein as to them may respectively appertain.

THEREAS by an Act, passed in the present session of Parliament, intituled "An Act to

of the forty-ninth year of His present Majesty, of for regulating the trade and commerce to and from the Cape of Good Hope, until the fifth day of July one thousand eight hundred and " twenty; and also for regulating the trade of the · Island of Mauritius; His Majesty is authorised, by and with the advice of His Privy Council, by any Order or Orders to be issued from time to time, to give such directions, and make such regulations touching the trade and commerce to and from all islands, colonies, or places, and the territories and dependencies thereof, to His Majesty belonging or, in His possession, in Africa, or Asia to the eastward of the Cape of Good Hope (excepting only the possessions of the East India Company), as to His Majesty, in Council, shall appear most expedient and salutary, any thing contained in an Act, passed in the twelfth year of the reign of His Majesty King Charles the Second, intituled "An Act for the encouraging and increas-" ing of shipping and navigation," or in an Act, passed in the seventh and eighth years of the reign of His Majesty King William the Third, intituled "An Act for preventing frauds, and regulating abuses in the plantation trade," or any other Act or Acts of Parliament now in force, relating to His Majesty's colonies and plantations, or any other Act or Acts of Parliament, law, usage or eustom to the contrary in any wise notwithstanding: and whereas on the night of the twenty-fifth of September last, a dreadful fire broke out in the town of Port Lewis, in the Island of Mauritius, which totally destroyed the chief part of that town, together with a great mass of provisions and merchandise intended for the consumption and trade of its inhabitants, whereby a great number of families were reduced to extreme indigence, and left without a home; in consequence of which dreadful calamity the Governor of the said Island found himself compelled to open the ports of the Island to foreign vessels, in order to afford the speediest relief of which the case would admit, and thereby to save His Majesty's subjects residing in that colony from the greatest extremity of distress; and whereas it is expedient that facilities should in consequence be granted to the trade of the Island of Mauritius, for a limited time, with the view of giving still further relief to its suffering inhabitants; His Royal Highness the Prince Regent, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, is pleased to order, and it is hereby ordered, that all vessels, whether British or foreign vessels belonging to countries in amity with His Majesty, arriving at any port of the Island of Mauritius, or its dependencies, within twelve months from the date of this present Order, from any country in amity with His Majesty, laden with any articles the growth, production, or manufacture of any such country, excepting all articles composed of cotton, iron, steel, or wool of foreign manufacture, shall be permitted to enter and land their cargoes, and dispose of the same, in the said ports; provided always, that such articles, when imported in a foreign ship, shall pay a duty of two per cent. ad valorem, over and above what may be payable upon similar goods when imported in a British ship.

And it is further ordered, that every such vessel, arriving as aforesaid, shall be permitted to export a cargo, consisting of any articles of the growth, produce, or manufacture of the Island of Mauritius, or its dependencies, or of any other articles which shall have been legally imported there; and that all such articles so exported in foreign vessels, shall in like manner be subject to a duty of two per cent. ad valorem, over and above the duties (if any) which shall be payable on similar articles when exported from the Mauritius, or its dependencies, in British vessels.

It is, however, hereby further ordered and declared, that no foreign vessel, allowed by the terms of this Order to export a cargo from the Island of Mauritius, or its dependencies, shall be permitted to export such cargo to any of His Majesty's possessions. But that every British vessel which shall during the continuance of this present Order, have imported a cargo into any port of the said Island of Mauritius, or its dependencies, either from the United Kingdom, or from any other place, shall be permitted to carry back a return cargo, consisting of the articles aforesaid, to any place whatever, either belonging to His Majesty, or to any state in amity with His Majesty. And the Right Honourable the Lords Commissioners of His Majesty's Treasury, and the Lords Commissioners of the Admiralty, are to give the necessary directions herein as to them may respectively appertain.

A PROCLAMATION.

GEORGE, P. R.

HEREAS by an Act, passed in the fifty-sixth year of His Majesty's reign, intituled "An Act to provide for a new silver coinage, and "to regulate the currency of the gold and silver "coin of this realm," the Master and Worker of His Majesty's Mint, in London, was authorised and empowered to coin, or cause to be coined, silver bullion into silver coins, consisting of crowns, half-crowns, shillings, and sixpences, of the standard of eleven ounces and two penny weights of fine silver, and eighteen penny weights alloy to the pound troy, and in weight after the rate of sixty-six shillings to the pound troy:

And whereas, in virtue of the powers so given, a coinage of half-crowns, shillings, and sixpences, at the rate of sixty-six shillings to the pound troy, and of the standard of fineness above-mentioned; every such half-crown piece having for the obverse impression the head of His Majesty, with the inscription "Georgius III. Dei Gratia," and the date of the year; and for the reverse, the ensigns armorial of the United Kingdom, contained in a shield surrounded by the Garter, bearing the motto "Honi soit qui mal y pense," and the collar of the Garter, with the inscription

" Britanniarum Rex Fid: Def:" with a newly invented graining on the edge of the piece; every such shilling and six penny piece having for the obverse impression the head of His Majesty, with the inscription "Geor. III. D. G. Britt. Rex, F. D." and the date of the year, and for the reverse, the ensigns armorial of the United Kingdom, contained in a shield surrounded by the Garter, bearing the motto "Honi soit q mal y pense," with a newly invented graining on the edge of the piece, has been completed, part of which has been de-livered for the use of His Majesty's subjects, and the remainder thereof is now ready to be delivered for the use of His Majesty's subjects; We have therefore, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, thought fit to issue this Proclamation; and We do hereby ordain, declare, and command, that the said pieces of silver money shall, from and after the day of the date of this Our Proclamation, be current and lawful money of the kingdom of Great Britain and Ireland, and shall pass and be received as current and lawful money of the said kingdom; that is to say, such half-crown pieces as of the value of two shillings and six pence; such shilling pieces as of the value of one shilling; and such six penny pieces as of the value of six pence, in all payments and transactions of

A PROCLAMATION.

GEORGE, P. R.

WHEREAS an Act was passed in the fiftysixth year of His Majesty's reign, intituled " An Act to provide for a new silver coinage, and " to regulate the currency of the gold and silver coin of this realm;" and whereas in pursuance of the said Act, great quantities of new silver coin have been delivered in exchange for old silver coin, current before the passing of the said Act, and further quantities are now ready to be delivered for the use of His Majesty's subjects, and it has been represented to us that some old silver coin may still remain in circulation, and we have thought it expedient that no such old silver coin of this realm should continue to be current in payment at any time after the date of this Proclamation; We have therefore, in the name and on the behalf of His Majesty, and by and with the advice of His Ma-jesty's Privy Council, thought fit to issue this Proclamation: and we do hereby ordain, declare, and command, that no piece or pieces of old silver coin of this realm, current at any time before the passing

of the said Act, shall pass or be current in any payment whatsoever, within the United Kingdom of Great Britain and Ireland, at any time after the date of this Proclamation: and We do hereby strictly prohibit and forbid all and every person or persons whomsoever, from and after the date of this Proclamation, to receive or utter in payment any piece or pieces of the said old silver coin: and We do hereby strictly require and command all His Majesty's loving subjects strictly to conform to the orders hereby given, and to the directions and regulations enacted and required by the said Act of Parliament with respect to the cutting, breaking, or defacing of all such pieces of the said old silver coin as shall be of less value than the denominations thereof shall respectively import: and We being desirous as much as in Us lies to give ease to His Majesty's subjects, and to prevent their sustaining any loss or inconvenience on account of the currency of old silver coin being prohibited as aforesaid, do hereby, in the name and on the behalf of His Majesty, authorise, command, and require the officers of His Majesty's Mint, for the space of three calendar months after the date of this Proclamation, to receive by tale only all such old silver coin of the realm, current at any time before the passing of the said Act, which shall be brought by any person or persons whomsoever into His Majesty's Mint, or to any place to be appointed for that purpose by the Master and Worker of His Majesty's Mint, and which shall be of or above the several weights following, that is to say, all crown pieces which shall be of or above the weight of eighteen pennyweights, four grains, troy; all halfcrown pieces which shall be of or above the weight of nine penny weights, two grains, troy; all shillings. which shall be of or above the weight of three pennyweights, fifteen grains troy; and all sixpenny pieces which shall be of or above the weight of one pennyweight, nineteen grains, troy; and to deliver. out of the said Mint to every person bringing in and delivering such old silver coins, a sum in new silver coins equal to the amount of the silver coins so brought by any such person or persons as aforesaid, according to the respective denominations of such silver coins.

THE following Address has been presented to His Royal Highness the Prince Regent; which Address His Royal Highness was pleased to receive very graciously:

To His Royal Highness George Prince of Wales, REGENT of the United Kingdom of Great Britain and Ireland.

WE, His Majesty's dutiful and loyal subjects, the Master, Officers, and Brethren of the Lodge of Concord of Free and Accepted Masons, at Ilfracombe, in the County of Devon, in Lodge assem-

Ibed, beg leave to approach your Royal Highness with our sincere and heartfelt congratulations, that the late scandalous and dastardly outrage on your royal person proved abortive.

But it has not proved merely abortive, it has afforded an opportunity to the large majority of your venerable father's faithful, loyal, and welldisposed subjects, to demonstrate their personal attachment to your Royal Highness.

Your Royal Highness, from the knowledge you have of the rules which govern our Society, is aware that we meddle not in political discussions; but, as individuals, we anticipated that the voice of the country would long ago have unamiously and exultingly declared that the glorious career of your Royal Highness's Councils, followed up by prudence and valour, by glorious achievements and complete success, as they were unequalled in the history of this or perhaps any nation, so they were entitled to the unqualified gratitude of your royal father's subjects and the civilized world.

We have therefore been filled with sorrow and indignation that the tide of popular approbation and applause, which would otherwise have succeeded, has been checked and prevented by unprincipled agitators, who have availed themselves of the unproductiveness of a season (which, it may be feared, has proceeded from the great unthankfulness manifested for so many former and signal marks of Divine protection), to spread discord and disaffection among those who, but for their infamous arts, would have been grateful to their rulers for the prosperity they were endeavouring to procure them, and submission to Him from whom alike success in war and plenty in peace, from whose blessing and protection, security abroad and comfort at home must proceed.

We reflect with the deepest and most indelible gratitute, that your Royal Highness ruled over our Fraternity, until the whole nation was confided to your rule, and we humbly and earnestly beg your Royal Highness to be assured, that the sentiments of affection which we are bound and sworn to possess for your person, as an individual of our Society, are most willingly and most loyally extended to your sacred person, as the representative of our beloved Sovereign; and much as we lament that any body of Englishmen, however small, should have given occasion to the ebullition of indignant feeling which flows from all parts of the empire on the occasion we presume to address you, we again exult that it has given an opportunity to the nation to evince, that all that is respectable in property, in intellect, and in virtue, are sincerely and firmly attached to your Royal Person and your Royal House, grateful for the manifold benefits they have derived therefrom, looking for alleviation at present, and anticipating in future every blessing, which, devotion to your country, love to your people, and a benevolent and good heart can vestow; and if the charity, which is inculcated in our Order, prevents us from judging those who instigated the late daring insult to your sacred person, and other popular and disgraceful commotions, to be actuated by the most unworthy motives, we can have no hesitation in the other alternative, to pronounce them to be victims of the grossest delusion. WE, His Majesty's dutiful and loyal subjects, the Mayor, Recorder, Justices, Bailiffs, and Capital Burgesses, and the Burgesses and Inhabitants of the Borough of Newcastle-under-Lyme, in the County of Stafford, humbly beg leave to approach your Royal Highness, and to express, amidst the general indignation, our reprobation and abhorrence of the flagitious and infamous attack made upon your Royal Highness's person, when returning from the performance of the duties of your high station in the House of Lords, on the opening of the present session of Parliament.
