N pursuance of the directions of an Act, passed in the thirty-seventh year of the reign of His present Majesty King George the Third, intituled "An Act for confirming and continuing, for a "limited time, the restriction contained in the "Minute of Council, of the 26th of February "1797, on payments of cash by the Bank;" and also of the several Acts since passed, for continuing and amending the same;

I do hereby direct, that there be inserted forthwith in the London Gazette, the following notice from the Governor and Company of the Bank of England, dated the 12th day of March 1818,

"That, on and after the 19th day of March instant, the Bank will be ready to issue to each
of the Bankers in London, current silver coin
of the realm to the amount of twenty thousand
pounds, in exchange for Bank notes, provided
application be made for the same before the 5th
day of July next."
