

OFFICE OF COMMISSIONERS FOR CLAIMS ON FRANCE.

London, 19th July 1821.

THE Commissioners appointed to carry into effect several Conventions for liquidating Claims of British Subjects and others against the Government of France, in pursuance of the 18th section of the Act passed for the above purpose, in the fifty-ninth year of the reign of His late Majesty King George the Third, did notify, on the 19th of January last, that they had liquidated and rejected 591 Claims since the passing of the aforesaid Act of Parliament; and they do farther, in pursuance of the said Act, give notice that, between the said 19th of January last, and the date hereof, they have liquidated as under:
