And whereas, in pursuance of the said powers, His late Majesty was pleased, by His Order in Council of the seventeenth of September one thousand eight hundred and hinderen, to direct and appoint that the bounty money awarded for the arrest of any person for newspire awarded convicted rest of any person for persons, arrested, convicted and committed to prison, according to the provision of the laws above recited, by any officer or officers, non-commissioned officers, petty officers, seamen, or privates of His Majesty's army, navy, or marines, on acting under the orders of the Lord High Admiral, or of the Commissioners for executing the office of Lord High Admiral of the United Kingdom of Great Britain and Ireland, shall be divided and distributed amongst such officers, noncommissioned officers, petty officers, seamen, or privates of His Majesty's army, navy, or marines, or acting under the orders of the Lord High Admiral, or of the Commissioners for executing the office of the Lord High Admiral of the United Kingdom of Great Britain and Ireland as aforesaid, according to the rules and regulations directed and provided by His late Majesty's Order in Council of the fourteenth of October one thousand eight hundred and sixteen, for the distribution of the shares of any such seizures as are, or shall, by virtue of any Acts relating to the trade and revenues of His Majesty's dominions, be payable to and amongst the commanders, officers, and crews of His Majesty's ships or vessels of war:

And whereas it is expedient that the said rules and regulations shall be in part altered, viz. so far as they relate to seizures made on shore by persons acting under the orders of the Lord High Admiral, or of the Commissioners for executing the office of the Lord High Admiral of the United Kingdom of Great Britain and Ireland, and that in lieu thereof other rules and regulations should be directed and appointed for the distribution of the reward granted in such case or cases: His Majesty is pleased, by and with the advice of His Privy Council, to order that the said Order in Council of the seventeenth of September one thousand eight hundred and nineteen be henceforth revoked, so far as relates to sums awarded for seizures made on shore by persons under the orders of the Lord High Admiral, or the Commissioners for executing the office of Lord High Admiral of the United Kingdom of Great Britain and Ireland, and no further; and the same is hereby so far reyoked, saving only as to sums awarded for seizures made prior to the date hereof, which shall be distributed according to the former Order:

appoint that all sums awarded, saving as above excepted seizures made, prior to the date hereof, by the Commissioners of Customs or Excise in Eng-land, Scotland and Ifeland, to persons under the orders of the Lord High Admiral, or the Commissioners for executing the office of Lord High Admiral of the United Kingdom of Great Britain and Ireland, for the arrest on shore of any person or persons for a breach of the laws as above described, shall be paid in the following proportions, to and for the benefit of the person or persons who shall not be the person of the pers actually make the arrest, viz.

PRESENT,

The KING's Most Excellent Majesty in Council.

HEREAS by an Act, passed in the fifty-sixth year of His late Majesty's reign, cap. 38, intituled "An Act to empower His Majesty to suspend the ballot or enrolment for the local militia," it is enacted, that it shall be lawful for this Majesty, by any Order in Council, to direct that no ballot or enrolment for the local militia chall take place; but that such hallot and enrolment shall take place; but that such ballot and enrol-ment shall remain and continue suspended for the period specified in any such Order of Council, and from time to time, by any like Order or Orders in Council, to continue such suspension so long as His Majesty shall deem the same expedient, any thing in any Act or Acts of Parliament to the contrary notwithstanding; and whereas by an Order in Council, made the seventh of June last, it was ordered by His Majesty in Council, that no ballot or enrolment for the local militia And His Majesty is further pleased to direct and from the twenty-seventh of June last, but that
