THE following Address, having been transmitted to Viscount Sidmouth, one of His Mejesty's Principal Secretaries of State, by the Provest of Paisley, has been presented by His Lordship to the King, and most graciously received:

To the KING's Most Gracious Majesty.

May it please your Majesty,

WE, your Majesty's most faithful and loyal subjects, the Provost, Magistrates, and Council of Paisley, most respectfully beg leave thus to renew our assurance of unaltered regard for your Majesty's Person and Family, and of undiminished attachment to the happy Constitution of our country.

We most sincerely congratulate your Majesty on your safe return from recent visitation of Irish and Continental, dominions; and have perused, with extreme satisfaction, the accounts of loyalty and affection every where manifested in your Majesty's

We anxiously hope, that ancient Caledonia will, in turn, experience like demonstration of royal favour; and that our county of Renfrew, long the residence of royalty, and the venerable remains of our Monastery, "founded by your Majesty's most noble progenitors, and where the bodies of some of your royal ancestors are deposited," may not be deemed unworthy of your Majesty's attention and regard.

We pray that the throne of the United Kingdom may ever remain unshaken, and that your Majesty and august Family may long sway the sceptre over a loyal, religious, and prosperous people.
