THE following Addresses, having been transmitted to the Right Honourable Robert Peel, one of His Majesty's Principal Secretaries of State, by the several persons whose names are respectively subjoined to each Address, were presented by him to His Majesty, who was pleased to receive the same very graciously:

To the KING's Most Gracious Majesty.

May it please your Majesty,

WE, your Majesty's loyal and affectionate subjects, the Lord Provost, Magistrates, and Council of the City of Edinburgh, beg to approach your Majesty's Throne with sentiments of the most profound respect and sincere condolence.

In that afflictive dispensation with which it has pleased an all-wise Providence to visit your Majesty and your Royal House, we deeply sympathize.

In His Royal Highness the Duke of York your Majesty has sustained the loss of a brother, to whom, from the earliest years, your Majesty bore the warmest attachment, which, on the part of His Royal Highness, was met by a most cordial and sincere return—an attachment, by which the character of both was mutually illustrated and endeared to the community at large.

But the death of His Royal Highness is far from being an event exclusively affecting your Majesty. In the person of His Royal Highness the nation has to lament the death of one of her greatest and best benefactors—of an individual, the condescending urbanity and affection of whose character endeared him to all who were honoured by his personal intercourse, and whose public life has been the instrument of the most substantial and permanent blessings.

As a general in the field, His Royal Highness, on the most trying circumstances, displayed a combination of vigilant intelligence and personal valour, which reflect the highest honour on his character—and while he thus ably discharged the more special duties of a Commander, his kind nature prompted him to relieve the miseries of the private soldier, and to make the hardships of war a pleasure to those who endured them.

But it is to his character as Commander-in-Chief of the Army, that we must look for the most splendid testimony to His Royal Highness. His services

in this high and arduous station form a monument of glory on which future ages will look with admiration, and bless the memory of him who reared it.

When His Royal Highness was first appointed to this important department, the army was in a state of comparative inefficiency. Under his auspicious management the aspect of our military force soon changed, and the British army, like the British navy, stands pre-eminent in the world. And to the immortal honour of His Royal Highness be it said, that while he made physical means thus available for producing results so important, he imparted that moral energy to the army which forms the great bulwark of our military, as it does of our national power. While the results, too, of His Royal Highness' exertions were thus great, the mode of arriving at them is not less worthy of praise. It is matter of notoriety to all military men, with what unwearied assiduity, with what obliging condescension, and with what impartial judgment, His Royal Highness uniformly discharged all the duties of his high office. To him the meanest sentinel had the same access as the highest in rank; his petition was listened to with equal attention, and granted with equal readiness.

The noble institutions founded by His Royal Highness, and cherished by his care, for the education of youth destined for the army—for the relief of the maimed and veteran soldier, and the protection of the widows and orphans of the fallen, are monuments at once of the charities of his heart and the comprehensiveness of his mind.

Truly may it be said of His Royal Highness the Duke of York, that in him Britain has lost the regenerator of her military tactics, and the British soldier his best friend.

That Almighty God may bless your Majesty, and comfort and support you under this severe affliction; that He may prosper and prolong your reign over a loyal and a happy people, are the fervent prayers of, may it please your Majesty, your Majesty's most loyal and affectionate subjects, the Lord Provost, Magistrates, and Council of the City of Edinburgh.

To His Most Excellent Majesty George the Fourth, of the United Kingdom of Great Britain and Ireland, KING.

The humble Address of His Majesty's most loyal and dutiful subjects, the Lord Provost, Magistrates and other Members of the Town Council of the City of Perth, in Scotland, in Council assembled.

AS it is only in the time of public danger or of private distress, that assurances of attachment and the voice of sympathy are truly appreciated, and afford their soothing and healing influences to the wounded feelings of the heart, we, your Majesty's most loyal and dutiful subjects, humbly solicit permission to offer to your Majesty at this time, our sincere and heartfelt assurances how deeply we sympathize in the irreparable loss which your Majesty and the country at large have sustained, in the death of your august Brother, the Duke of York and Albany.

His loss, as a brother endeared to your Majesty by the strongest ties of fraternal affection, we feel can never be supplied, and our most sanguine anticipations can hardly lead us to expect that abilities will be easily found to fill the distinguished public situation he held, not only with so eminent advantage to the State, but so as to secure the reverence and esteem of the whole army, and the sincere affection of every loyal subject, an affection founded not more on his zeal and ability as Commander-in-Chief of the land forces of these realms, than on his firm and upright conduct as a statesman, his steady adherence to the principles of the British Constitution, and the fostering patronage which he bestowed upon so many of those charitable institutions, which shed a lustre on the character of our country and on human nature; virtues which will make his loss long and deeply regretted.

It would justly be deemed presumptuous in us, were we to attempt to enlarge upon the invaluable benefits which His late Royal Highness, by his long, unremitting and unwearied services, bestowed upon his country; but on one point, we trust, your Majesty will graciously permit us to express our feelings, and we are confident the united feelings of your subjects: when Britain, in one of the most momentous contests in which this nation was ever engaged, had justified her well-earned renown as invincible on the ocean, and found no foe to withstand her on its wide bosom; it was then that the talents and labours of His Royal Highness, coming in aid of the wisdom of your Majesty's councils, enabled this country to prove to the world, that British valour is equally matchless on either element; that in a just cause a free and loyal people must ultimately prove victorious; and, under Providence, insured that success to your Majesty's arms which restored peace once more to Europe. But those who best know the able and conscientious manner in which His late Royal Highness performed the arduous duties of his situation as Commander-in-Chief, can alone justly appreciate the value of his services to his king, to his country, and to mankind at large.

While humbly soliciting permission to express our sincere sympathy with your Majesty on this melancholy occasion, be pleased to permit us also to

renew our assurances of our devoted and inviolable attachment to your Majesty's Person, Family and Government, and our most ardent wishes and prayers to Divine Providence, that you may be long spared to meet the increasing affection of your subjects, and be enabled by Him to continue to dispense those numerous and invaluable blessings, which they have so unceasingly enjoyed under your truly paternal reign.

openly and publicly notified and declared in this Court, in pursuance of the said Statute, viz.

GEORGE, R.

Whereas by an Act, passed in the session of Parliament holden in the third year of our reign, intituled "An Act to repeal an Act, of the first and second year of His present Majesty, for facilitating the dispatch of business in the Court of King's-Bench, and to make further provisions in lieu thereof," it is, amongst other things, enacted, that from and after the passing of the said Act, it shall and may be lawful to and for Us, Our heirs and successors, and We and They are thereby authorised, from time to time, as to Us or Them shall seem meet, by Warrant under Our or Their Sign Manual, directed to the Judges of Our said Court, to direct and require the Judges of Our said Court, or any two or more of them, to meet at Serjeants-Inn-Hall, Westminster-Hall, or some other convenient place to be by them appointed, on such and so many days in the vacation or interval between any Terms as to us, Our heirs and successors, shall seem fit and proper, for the dispatch of such matters, as at the end of the Term mentioned in such Warrant may be depending in Our said Court, whether on the Crown or Plea side thereof; and whereas We have been given to understand, that numerous matters are now depending in Our said Court, which cannot be dispatched during this present Hilary Term, and which ought to be dispatched with all convenient speed; now, therefore, We do hereby, in pursuance of the said Act, direct and require you the Lord Chief Justice, and he other Judges of our said Court before us, or any two or more of you, to meet at Serjeants-Inn-Hall, Westminster-Hall, or some other convenient place to be by you appointed according to the said Act, on Tuesday the thirteenth day of February now next coming, and from thence daily until and on Friday the 23d day of the same month of February, and also on Wednesday the twenty-fifth day of April next following, and from thence daily until and on Tuesday the first day of May next, if the state of the business shall appear to you to make it requisite so to do, for the dispatch of such matters as may be depending in Our said Court at the end of the present Hilary Term, whether on the Crown or Plea side thereof; provided always, that if the attendance of any one of you at the session of Oyer and Terminer and Gaol Delivery for the county of Middlesex, or at any such session on any Circuit, shall be found requisite, during any part of the time herein mentioned, and another of you shall also, during such attendance, be sitting for the trial of causes at Nisi Prius, then it shall be in the discretion of the remaining two of you either to meet or not to meet, in obedience hereto, according to the nature of the business that may be likely to come before you during such attendance.
