HEREAS by an Act, passed in the fifty-sixth year of His late Majesty's reign, cap. 38, intituled "An Act to empower His Majesty to suspend "the ballot or enrolment for the local militia," it is enacted, that it shall be lawful for His Majesty, by any Order in Council, to direct that no ballot or enrolment for the local militia shall take place, but that such ballot and enrolment shall remain and continue suspended for the period specified in any such Order in Council, and from time to time by any like Order or Orders in Council, to continue such suspension so long as His Majesty shall deem the same expedient, any thing in any Act or Acts of Parliament to the contrary notwithstanding; and whereas by an Order in Council, made the twelfth day of July one thousand eight hundred and twenty-six,

it was ordered by His Majesty in Council, that no ballot or enrolment for the local militia should take place for the space of one year from the sixteenth of July one thousand eight hundred and twenty-six, but that the ballot should remain and continue suspended for the space of one year from the said sixteenth of July; and whereas it is deemed expedient to continue such suspension of the ballot and enrolment for the local militia for the space of one year from and after the sixteenth day of July in this year; it is, therefore, ordered by His Majesty, by and with the advice of His Privy Council, that no ballot or enrolment for the local militia do take place for the space of one year from and after the sixteenth day of July in this year, but that the ballot or enrolment for the local militia do remain and continue suspended for the space of one year from and after the sixteenth day of July next.

WHEREAS the time limited by His Majesty's Order in Council, of the twentieth November last, for prohibiting the exportation of gun-powder or salt-petre, or any sort of arms or ammunition, to any port or place on the Coast of Africa (except to any ports or places within the Streights of Gibraltar), has expired; and whereas it is judged expedient that the said prohibition should be continued for some time longer; His Majesty, by and with the advice of His Privy Council, doth therefore hereby order, require, and command, that no person or persons whatsoever (except the Master-General of the Ordnance for His Majesty's Service), do, at any time during the space of six months (to commence from the date of this Order), presume to transport any gun-powder or salt-petre, or any sort of arms or ammunition, to any port or place on the Coast of 1538

powder or salt-petre, or any sort of arms or ammu-nition, on board any ship or vessel, for the transporting of the same into any such ports or places on the Coast of Africa (except as above excepted), without leave or permission in that behalf, first ob-tained from His Majesty or His Privy Council, upon pain of incurring and suffering the respective forfeitures and penalties imposed in that behalf by an Act, passed in the sixth year of His present Majesty's reign, intituled "An Act for the general " regulation of the Customs:

And the Right Honourable the Lords Com-missioners of His Majesty's Treasury, the Lord High Admiral, the Lord Warden of the Cinque Ports, the Master-General and the rest of the Principal Officers of the Ordnance, and His Majestv's Secretary at War, are to give the necessary directions herein as to them may respectively appertain.

THEREAS certain dues and duties are payable to His Majesty within the islands of Guernsey, Jersey, Alderney, and Sark, upon the anchorage of foreign ships, vessels, and hoats arriv-ing at and casting anchor within the ports, roads, and havens of the said islands, commonly called anchorage dues; and which anchorage dues are not payable by or in respect of British ships, vessels, or boats arriving at and casting anchor within the said ports, roads, and havens; and whereas by certain Treaties or Conventions of Commerce made and concluded by His Majesty with His Most Christian Majesty the King of France, bearing date the twenty-sixth day of January one thousand, eight hundred and twenty-six; and with His Majesty the King of Denmark, bearing date the sixteenth day of June one thousand eight hundred and twenty-four; and with His Majesty the King of Prussia, bearing date the second day of April one thousand eight hundred and twenty-four; and with His Majesty as King of Hanover, bearing date the twelfth day of June one thousand eight hundred and twentyfour; and with His Majesty the King of Sweden and Norway, bearing date the eighteenth day of March one thousand eight hundred and twenty-six; and with the United States of America, bearing date the third day of July one thousand eight hundred and fifteen; and with the Free Hanseatic Republics, bearing date the twenty-ninth day of September one thousand' eight hundred and twenty-five; and with the State of Columbia, bearing date the eighteenth day of April one thousand eight hundred and twentytive; and with the United Provinces of Rio de la Plata, hearing date the second day of February one thousand eight hundred and twenty-five, it is, amongst other things, agreed, that during the continuance of such Treaties respectively, vessels of and belonging to the subjects of the before-mentioned | The KING's Most Excellent Majesty in Council.

foreign Sovereigns and States, entering or departing from the ports of the United Kingdom of Great Britain and Ireland, shall not be subject to any other or higher duties or charges whatever than are or shall be levied on British vessels entering or departing from such ports; His Majesty, being desirous to carry the said Treaties into full execution and effect, is pleased, with the advice of His Privy Council, to order, and it is hereby ordered, that during the continuance of the before-mentioned Treaties or Conventions of Commerce respectively, and so long as the same shall respectively remain in force, the before-mentioned anchorage dues heretofore levied or claimed in the said islands of Jersey, Guernsey, Alderney, and Sark, on ships, vessels, and boats of or belonging to the subjects of His Most Christian Majesty, or of His Majesty the King of Denmark, or of His Majesty the King of Prussia, or of His Majesty as King of Hanover, or of His Majesty the King of Sweden and Norway, or of the United States of Anferica, or of the Free Hanseatic Republics, or of the State of Columbia, or of the United Provinces of Rio de la Plata, shall be and the same are hereby repealed, abolished, and remitted, any law, custom, or usage, now or at any time heretofore in force in the said islands, or any of them, to the contrary notwithstanding; provided always, that nothing in this present Order contained shall extend, or be construed to extend, to any ships, vessels, or boats of or belonging to the subjects of the United Provinces of Rio de la Plata, not being of the burthen of above one hundred and twenty: tons, such ships, vessels, or boats not being included within the said Treaty with the said United Pro-vinces, of the second of February one thousand eight hundred and twenty-five: and it is further ordered, that the said anchorage dues shall in like manner be and the same are hereby repealed, abolished, and remitted in favour of the ships, vessels, and boats of or belonging to the subjects of any other foreign State or Power with whom His Majesty shall hereafter enter into and conclude any such Treaty as aforesaid; and that such repeal, abolition, and remission shall take effect when and sosoon as the conclusion of any such future Treaty shall be signified to the Governor or Lieutenant-Governor of the said islands respectively, by His-Majesty through one of His Majesty's Principal Secretaries of State; and all Governors, Lieutenant-Governors, and other Officers, civil and military, and all other His Majesty's subjects-within the said islands, are to take notice hereof and to govern themselves accordingly:

**R** ULES, Orders, and Regulations for the preservation of His Majesty's Moorings, and for the mooring, anchoring, and placing of all private ships of war, transports, and all other private and merchant ships and vessels, lighters, barges, boats, aud other craft whatsoever, in the navigable River of Thames, and near to the docks, dock-yards, arsenals, wharfs, and moorings belonging to His Majesty therein, for the purpose of keeping the same free and open, and for ensuring a free and safe passage to and from the same respectively; made and established pursuant to an Act of Parliament, made and passed in the fifty-fourth year of the reign of His late Majesty King George the Third, chapter 159, intituled " An Act for the better regulation of the several ports, harbours, roadsteads, sounds, channels; bays, and navigable rivers in the United Kingdom; and of His Majesty's docks, dock-yards, arsenals, wharfs, moorings, and stores therein; and for repealing several Acts passed for that purpose."

Art. I. It is hereby ordered, that no private ship of war or transport, nor any private or merchant thip or vessel, steam-vessel, lighter, barge, boat, or other craft whatever, shall be moored, anchored, or placed within the boundaries or limits following, that is to say:

#### DEPTFORD.

Within sixty fathoms from any part of the south western shore of the said River, between the north end of the wharf of His Majesty's Victualling-yard at Deptford, and a spot on the same shore, situate at the distance of forty fathon's below the lower side of the entrance of Deptford Creek,

Note.-This regulation is not meant to extend to transports, convict-ships, and other vessels having occasion to load and unload at His Majesty's Dockyard and Victualling-yard; all which ships and vessels may for those purposes, under the superintendence of the Officers of those Yards, continue to make use of the moorings which they have been accus--tomed to use.

#### WOOLWICH.

Nor within seventy fathoms from any part of the south shore of the said River, between Long's Wharf, otherwise called Trinity Wharf (which is situate above His Majesty's Dock-yard at Woolwich), and a spot called the Grove, at the eastern extremity of the same Dock-yard.

Nor within one hundred fathoms from any part of the same shore between the western boundary of the wharf of the Royal Arsenal, at Water-lane, Woolwich, and the entrance of the canal or basin at the eastern extremity of the said Arsenal.

#### GREENHITUE.

Nor within seventy fathoms from any part of the shore, commencing at the west end of Ingress Park, and terminating at the New Jetty, recently erected at the lower end of the said Park.

Art. II. It is further ordered, that no private ship of war or transport, nor any other private merchant ship or vessel, steam-vessel, lighter, barge, boat, or other craft shall be moored, anchored, or placed within the distance of forty fathoms from the centre of any of His Majesty's moorings in any part of the said River, from the Nore upwards.

Art. III. And whereas a practice has prevailed of ships and vessels of a light draught of water, unnecessarily coming to anchor in the fair way or mid channel, and in the fair stream of the tide, to the great inconvenience of the public and of the navi-gation of the River, and frequently to the danger of ships of a larger draught and requiring deeper water;

It is, therefore, further ordered, that no ship, vessel, boat, or other craft of any description, being light, or which shall draw less than eight feet of water, shall anchor or moor in the mid channel or

fair stream of the tide, in any part of the said River, so that all merchant ships and vessels of burden and of larger draught, as well as His Majesty's ships and vessels, may have free passage up and down the said River without obstruction.

And lastly, in order to prevent the danger which may arise to His Majcsty's ships and stores from fire, it is ordered, that no ship or vessel, steamvessel, boat, barge, or other craft, having any furnace, forge, or fire on board thereof, shall be moored, anchored, or placed within the distance of fifty. fathoms from the centre of any of His Majesty's moorings; nor shall any ship or vessel whatever, boat, barge, or other craft be breamed, repaired, or fitted with engine gear, afloat in any part of the said River or shore thereof, within a like distance of fifty fathoms from the centre of any of His Majesty's moorings, and from His Majesty's dock-yards, arsenals, wharfs, and premises respectively.
