**T**HE following Address, having been transmitted to the Right Honourable William Sturges Bourne, one of His Majesty's Principal Secretaries of State, by the Earl of Aylesford, was presented by him to His Majesty, who was pleased to receive the same very graciously:

To the KING's Most Excellent Majesty.

SIRE,

WE, the undersigned Archdeacon and Clergy of the Archdeaconry of Coventry, having witnessed the efforts repeatedly made of late years to procure further indulgences for persons professing the Roman Catholic religion, and contemplating with much solicitude the probability of those efforts being speedily renewed, and of their being moreover supported by many of the present Administration, consider it our bounden duty earnestly to implore your Majesty, according to your Majesty's most gratifying and gracious declaration, to continue to protect with a watchful jealousy the safeguards of our Protestant Constitution in Church and State, and to reject with unbending firmness each and every measure calculated to weaken or remove them.

Greatly as we believe the Church of Rome to err in matters of faith, yet are we glad to see her in the full possession of religious toleration in the uninterrupted enjoyment of conscience and of public worship; but satisfied as we are by her councils, by history, and by experience, that her tenets are inimical to the existing mild ascendancy of our Church, and subversive of civil and religious liberty, we deprecate a repeal of those wise and salutary laws which at present preclude your Majesty's Roman Catholic subjects from the exercise of legislative power.

We have ventured, Sire, thus humbly and candidly to convey to your Majesty, at this eventful period, our sentiments upon this most important subject, which we view not merely as a political but as a religious subject.

With our united prayers to the Allwise Disposer of Events, that your Majesty may long continue to reign over us as the Defender of our Faith, of those principles which, under the blessing of Divine Providence, placed your august Family upon the Throne

of these realms, we subscribe ourselves your Majesty's most loyal, dutiful, and devoted servants and subjects.
