WHEREAS it hath been humbly represented unto the King, that, on the 11th day of September last, Mr. James Booth and several other persons, who had dined together at an inn or public-house, kept by William Kay, and known by the name of "Naylor's-Green," in the township of Tottington-lower-end, in the parish of Bury, in the county of Lancaster, were almost immediately after dinner seized with sickness and vomiting; that the said James Booth died on the following day; and that his death was subsequently discovered to have been occasioned by arsenic, a quantity of which there is every reason to believe had been thrown into the vessel wherein a pudding, of which he had partaken, had been boiled;

His Majesty, for the better apprehending and bringing to justice the persons concerned in the felony before mentioned, is hereby pleased to promise His most gracious pardon to any one of them (except the person who actually threw the arsenic into the vessel as aforesaid) who shall discover his accomplice or accomplices therein, so that he, she, or they may be apprehended and convicted thereof.
