REGULATIONS TO BE OBSERVED AT THE KING'S LEVERS, AT ST. JAMES'S PALACE.

The Noblemen and Gentlemen who propose to attend the Levee to be held on Wednesday next the 28th instant, are requested to bring with them two cards with their names thereon written, one to be left with the King's Page in attendance in the Presence-Chamber, and the other to be delivered to the Lord in Waiting, who will announce the name to His Majesty. And those Gentlemen who are to be presented are hereby informed, it is absolutely necessary that their names, with the name of the Gentleman who is to present them (not the Lord in Waiting), should be sent in to the Lord Chamberlain's-Office, before twelve o'clock on Monday next, in order that they may be submitted for the King's approbation, it being His Majesty's command, that no presentation shall hereafter take

place at the Levee, but in conformity with the above regulations.

The state apartments will not be open for the reception of company coming to Court, until half past one o'clock.

Those Gentlemen who are to be presented at the Levee, on Wednesday the 4th of August next, are to send their names to the Lord Chamberlain's-Office, according to above regulations, before twelve o'clock on Monday the 2d of August.

A PROCLAMATION.

For dissolving this present Parliament and declaring the calling of another.

WILLIAM, R.

HEREAS We have thought fit, by and with the advice of Our Privy Council, to dissolve this present Parliament, which stands prorogued to Tuesday the tenth day of August next: We do for that end publish this Our Royal Proclamation, and do hereby dissolve the said Parliament accordingly; and the Lords Spiritual and Temporal, and the Knights, Citizens, and Burgesses, and the Commissioners for shires and burghs, of the House of Commons are discharged from their meeting and attendance on the said Tuesday the tenth day of August next and We, being desirous and resolved, as soon as may be, to

meet Our people, and to have their advice in Parliament, do hereby make known to all Our loving subjects Our Royal will and pleasure to call a new Parliament: and do hereby further declare, that, with the advice of Our Privy Council, We have given order that Our Chancellor of that part of Our United Kingdom called Great Britain, and Our Chancellor of Ireland, do respectively, upon notice thereof, forthwith issue out writs in due form, and according to law, for calling a new Parliament: and We do hereby also, by this Our Royal Proclamation under Our Great Seal of Our United Kingdom, require writs forthwith to be issued accordingly by Our said Chancellors respectively, for causing the Lords Spiritual and Temporal and Commons, who are to serve in the said Parliament, to be duly returned to and give their attendance in Our said Parliament; which writs are to be returnable on Tuesday the fourteenth day of September next.

A PROCLAMATION,

In order to the electing and summoning the Sixteen

Peers of Scotland.

WILLIAM, R.

7 HEREAS We have in Our Council thought fit to declare Our pleasure, for summoning and holding a Parliament of Our United Kingdom of Great Britain and Ireland, on Tuesday the fourteenth day of September next ensuing the date hereof; in order, therefore, to the electing and summoning the Sixteen Peers of Scotland, who are to sit in the House of Peers in the said Parliament: We do, by the advice of Our Privy Council, issue forth this Our Royal Proclamation, strictly charging and commanding all the Peers of Scotland to assemble and meet at Holyrood-House, in Edinburgh, on Thursday the second day of September next ensuing, between the hours of twelve and two in the afternoon, to nominate and choose the sixteen Peers, to sit and vote in the House of Peers in the said ensuing Parliament, by open election and plurality of voices of the Peers that shall be then present; and of the proxies of such as shall be absent (such proxies being Peers, and producing a mandate in writing,

duly signed before witnesses, and both constituent and proxy being qualified according to law), and the Lord Clerk Register, or such two of the Principal Clerks of the Session as shall be appointed by him to officiate in his name, are hereby respectively required to attend such meeting, and to administer the oaths required by law to be taken there by the said Peers, and to take their votes; and immediately after such election made and duly examined, to certify the names of the Sixteen Peers so elected, and sign and attest the same in the presence of the said Peers the electors, and return such certificate into Our High Court of Chancery of Great Britain. And We do, by this Our Proclamation, strictly command and require the Provost of Edinburgh, and all other the Magistrates of the said city, to take especial care to preserve the peace thereof, during the time of the said election, and to prevent all manner of riots, tumults, disorders, and violence whatsoever. And We strictly charge and command that this Our Royal Proclamation be duly published at the Market+, Cross at Edinburgh, and in all the county towns of Scotland, twenty-five days, at least, before the time hereby appointed for the meeting of the said Peers to proceed to such election.

Witness Ourself at Westminster, this twentyfourth day of July one thousand eight hundred and thirty, and in the first year of Our reign.

Public Acts received toe Royal Assent, the 23d, July 1830.

N Act for raising the sum of thirteen millions six hundred and seven thousand six hundred pounds, by Exchequer Bills, for the service of the year one thousand eight hundred and thirty.

An Act to apply the sum of one million five hundred thousand pounds, out of the Consolidated Fund, to the service of the year one thousand eight hundred and thirty, and to appropriate the supplies granted in this session of Parliament.

An Act to allow, before the fifth day of July one thousand eight hundred and thirty-one, sugar to be delivered out of warehouse to be refined.

An Act for reducing into one Act all such forgeries as shall henceforth be punished with death, and for otherwise amending the laws relative to forgery.

An Act for the more effectual administration of justice in England and Wales.

An Act for regulating the receipt and future appropriation of fees and emoluments receivable by officers of the superior courts of common law.

An Act for consolidating and amending the laws relating to property belonging to infants, femes covert, idiots, lunatics, and persons of unsound mind.

An Act for amending the laws respecting convey-.

ances and transfers of estates, and funds vested in trustees and mortgagees, and for enabling courts of equity to give effect to their decrees and orders in certain cases.

An Act to repeal so much of an Act of the sixtieth year of His late Majesty King George the Third, for the more effectual prevention and punishment of blasphemous and seditious libels, as relates to the sentence of banishment for the second offence, and to provide some further remedy against the abuse of publishing libels

An Act for uniting the benefits of jury trial in civil causes with the ordinary jurisdiction of the Court of Session, and for making certain other alterations and reductions in the judicial establish-

ments of Scotland.

An Act for correcting mistaken references to Acts of His late Majesty in Acts passed during the present session of Parliament.

An Act to permit the general sale of beer and cyder by retail in England.

An Act for the relief of the sufferers by the insolvency of Gilbert Ricketts, Esq. tormerly Registrar of the Supreme Court of Judicature, at Madras.

An Act for the more effectual protection of mail contractors, stage coach proprietors, and other common carriers for hire, against the loss of, or injury to, parcels or packages delivered to them for conveyance or custody, the value and contents of which shall not be declared to them by the owners thereof.

. An Act to regulate the applotment of county rates

and cesses in Ireland in certain cases.

An Act to prevent bribery and corruption in the election of burgesses to serve in Parliament for the

borough of East Retford.

An Act for endowing the parish church of Newborough, in the county of Northampton, and three chapels, called Portland Chapel, Oxford Chapel, and Welbeck Chapel, situate in the parish of St. Maryle-bone, in the county of Middlesex, and also a chapel erected on Sunk Island, in the river Humber.

An Act to alter and amend several Acts for the improvement of the roads from London to Holyhead, and from London to Liverpool, and for the further improvement of the said roads.

And one private Act.

HIS day, the Lord Bishop of London, and the Dean and Chapter of St. Paul's, with a Deputation of the Clergy, waited upon His Majesty to present to His Majesty the following Address, which His Majesty was graciously pleased to receive on the Throne:

To the KING's Most Excellent Majesty.

Most Gracious Sovereign,

WE, your Majesty's most dutiful subjects, the Bishop of London, the Dean and Chapter of Saint Paul's, and the Clergy of London and Westminster, humbly request permission to approach your Majesty with the expression of our sincere condolence on the death of our late revered Sovereign, and with the assurance of our loyal and devoted attachment to your Majety's Person and Government.

Under the sorrow occasioned by so severe a domestic, as well as national calamity, your Majesty has the coaso ation of reflecting, that the confidence and affection with which your Majesty was ever regarded by that lamented Monarch, were repaid by the most cordial attachment, the most undeviating loyalty, and the most dutiful obedience. And your Majesty's subjects are consoled under the loss which they have sustained, by a confident belief that the same principles and feelings which influenced your Majesty's conduct as a Brother, and a subject, will continue to animate your Royal breast as the Ruler and Father of your people.

As persons entrusted with the sacred charge of instructing the people in the truths and duties of our holy religion, and convinced that, upon the influence of that religion, the real prosperity of this country must depend, we have learned with the most heartfelt joy and gratitude your Majesty's gracious declaration of attachment to the established Church, and of your Majesty's determination to protect and main-

tain it

Persuaded as we are that your Majesty's countenance and favour will never be withdrawn from us as long as we are faithful to our trust, we humbly beg leave to assure your Majesty that, as the servants of Him who came to establish the reign of peace upon earth, it will be our constant endeavour to inculcate upon the members of our Church the duties of loyalty to their Sovereign, obedience to the laws, and charity towards all men, as parts of the allegiance which they owe to Him who is the King of kings, and Lord of lords.

We humbly pray that, under his favour and protection, your Majesty may long be spared to enjoy, in the society of our most gracious and amiable Queen, the blessings of domestic felicity, and to promote both the spiritual and temporal prosperity of your Majesty's subjects, reigning in the affections of a loyal and united people, and rejoicing in the increase of true religion and virtue.

To which Address His Majesty was pleased to return the following most gracious Answer:

" I thank you most cordially for this loyal and dutiful Address, for your condolence with me on the death of my lamented Brother, and for the assurance of your affectionate interest in the happiness of myself, and of the Queen, my beloved Consort.

"You may rely upon my steady attachment to the established Church, and upon my anxious endeavours to maintain its privileges, and to extend its legitimate

influence.

"In those endeavours I shall be encouraged and stimulated by many motives: by a deep sense of duty, by a firm belief in the great truths of our holy Religion, and by the obligations of those solemn engagements which I shall be called upon to contract in the face of my people.

"You can prefer no surer claim upon my favour and protection than the faithful execution of that sacred trust which is committed to your charge, and the continuance of your unceasing exertions in the common cause of truth, virtue, and religion." St. James's Pulace, July 21, 1880.

A CHAPTER of the Most Noble Order of the Garter having been summoned this day, the following Knights Companions, in their mantles and collars, assembled in the Entrée-room, viz.

Their Royal Highnesses the Dukes of Cumberland, Sussex, and Gloucester, His Royal Highness the Prince of Saxe Coburg, the Earl of Westmorland, the Marquess Camden, the Duke of Rutland, the Earl of Hardwicke, the Duke of Beaufort, the Earl of Lonsdale, the Duke of Wellington, the Earl Bathurst, the Duke of Buckingham, the Marquess of Hertford, the Duke of Dorset, the Duke of Leeds, the Duke of Devonshire, and the Duke of Richmond, attended by the under-named Officers of the Order, in their mantles, chains, and badges, viz. the Lord Bishop of Winchester, Prelate of the Order; the Honourable and Reverend the Dean of Windsor, Register of the Order; Sir George Nayler, Knight, Garter Principal King of Arms; and Sir Thomas Tyrwhitt, Knight, Gentleman Usher of the . Black Rod.

At six o'clock, the Knights Companions were called over by Garter, and, with the Officers of the Order, proceeded into the presence of the Sovereign, in the Throne-room.

The Sovereign being seated on the Throne, and the Knights Companions having taken their respective places, the Prelate of the Order, by His Majesty's command, read a new Statute, declaring His Serene Highness Bernard Reigning Duke of Saxe-Meiningen, Brother of Her most Excellent Majesty the Queen, a Knight of the Most Noble Order of the Garter.

The Prelate then signified to the Chapter the Sovereign's royal will and pleasure, that a lineal descendant of His Majesty King George the Second should, in pursuance of the Statute in that behalf made, be elected into the said Most Noble Order.

The Knights Companions then proceeded to the election, and the suffrages having been collected by the Prelate, were by his Lordship presented to the Sovereign, who was pleased to command him to declare, and he accordingly declared, that His Majesty William, by the Grace of God, King of Wurtemberg, had been duly elected a Knight of the

Most Noble Order of the Garter.
The King of Wurtemberg was thereupon conducted from the private apartment of the Sovereign in the Chapter-room, between their Royal Highnesses the Dukes of Cumberland and Sussex, the two Senior Knights Companions present, preceded by Garter (bearing the ensigns of the Order upon a crimson velvet cushion) and by Black Rod.
On entering the Chapter-room, His Majesty was

received by the Sovereign and Knights Companions standing, and placed in a chair of state on the right hand of the Sovereign.

The Sovereign was then graciously pleased to announce to the King of Wurtemberg that His Majesty had been duly elected a Knight of the

Most Noble Order of the Garter.

Garter on his knee presenting the Garter to the Sovereign, His Majesty, assisted by their Royal Highnesses the Dukes of Cumberland and Susses, buckled it on the left leg of the King of Wurtenberg, the Prelate pronouncing the usual admonition.

Garter next presented, in like manner, the ribband with the George, and the Sovereign, assisted as before, put the same over the shoulder of the King of Wurtemberg, the Prelate pronouncing the admonition.

The Sovereign thereupon gave the accollade to the King of Wurtemberg, and His Majesty also received the congratulations of each of the Knights Companions present.

The chapter being ended, the Knights Companions were again called over by Garter, and with the Officers of the Order, retired from the presence of the Sovereign with the usual reverences.

The Sovereign and His Majesty the King of Wurtemberg were then conducted to the private apartment of the Sovereign.

WHEREAS by an Act, passed in the 58th year of the reign of His late Majesty King George the Third, intituled "An Act for building and promoting the building of additional churches in populous parishes," it is amongst other things enacted, "that in every case in which the Commissioners appointed for carrying into execution the nurroses of the said Act, shall be of onlying the purposes of the said Act, shall be of opinion. that it will be expedient to divide any parish info-two or more distinct and separate parishes, for all ecclesiastical purposes whatever, it shall be lawful for the said Commissioners, with the consent of the Bishop of the diocese in which such parish is locally situated, signified under his hand and seal, to apply to the patron or patrons of the church of such parish. for his or their consent to make such divisions, and for such patron or patrons to signify his or their consent thereto, under his or their hand and seal, and the said Commissioners shall, upon the consent of the said patron or patrons so signified, represent the whole matter to His Majesty in Council, and shall state in such representation the bounds by which it is proposed, with such consent as aforesaid, to divide such parish, together with the relative and respective proportions of glebe lands, tithes, moduses, or other endowments, which will by such division arise and accrue and remain and be within each of such respective divisions, and also the relative proportions: of the estimated amount of the value or produce of

fees, oblations, offerings, or other ecclesiastical dues or profits, which may arise and accrue within each of such respective divisions; and if thereupon His Majesty in Council shall think fit to direct such divisions to be made, such Order of His Majesty in Council shall be valid and good in law for the purpose of effecting such division; provided always, that no such division of any parish into distinct parishes shall completely take effect until after the death, resignation, or other avoidance of the existing incumbent of the parish to be divided;" and whereas by the said Act it is further enacted, " that in any case in which the said Commissioners shall be of opinion that it is not expedient to divide any populous parish, or extra parochial place, into such complete separate and distinct parishes as aforesaid, but that it is expedient to divide the same into such ecclesiastical districts as they, with the consent of the Bishop, signified under his hand and seal, may deem necessary, for the purpose of affording accommodation for the attending divine service, according to the rites of the United Church of England and Ireland, to persons residing therein, in the churches and parochial chapels already built, or in additional churches or chapels to be built therein, and as may appear to such Commissioners to be convenient for the enabling the spiritual person or persons who may serve such churches or chapels to perform all ecclesiastical duties within the districts attached to such respective churches and chapels, and for the due ecclesiastical superintendance of such district, and the preservation and improvement of the religious and moral habits of the persons residing therein; the said Commissioners shall represent such opinion to His Majesty in Council, and shall state in such representation the bounds by which such districts are proposed to be described; and if, thereupon, His Majesty in Council shall think fit to direct such divisions to be made, such Order of His Majesty in Council shall be valid and good in law for the purpose of effecting such division:" and whereas by an Act, passed in the 59th year of the reign of His late Majesty King George the Third, intituled " An Act to amend and render more effectual an Act, passed in the last session of Parliament, for building, and promoting the building, of additional churches in populous parishes," and by another Act, passed in the 7th and 8th years of the reign of His late Majesty, intituled "An Act to amend the Acts for building and promoting the building, of additional churches in populous parishes," further provisions are made for carrying such divisions into effect: and whereas the said Commissioners have made a representation to His Majesty in Council, stating that, in the year 1821, when the last census was taken, the parish of St. George, Hanover-square, in the county of Middlesex, and diocese of London, contained a population of 46384 persons, which has since considerably increased; that the parish church of the said parish affords accommodation for 1200 persons only; that the said Commissioners have caused three new chapels to be erected in the said parish, which afford accommodation to 4847 persons, including 2251 free seats appropriated to the use of the poor; that the said chapels have been consecrated, and divine service is regularly performed therein; that the said Commissioners further
