NOTICE is hereby given, that His Majesty will hold a Levee at St. James's-Palace, on Wednesday next the 3d of November, and on the following Wednesday (the 10th of November), each day at two o'clock.

RECULATIONS TO BE OBSERVED AT THE KING'S LEVEES, AT ST. JAMES'S-PALACE.

The Noblemen and Gentlemen who propose to attend the Levee to be held on Wednesday next the 3d of November, are requested to bring with them two cards with their names thereon written, one to be left with the King's Page in attendance in the Presence-Chamber, and the other to be delivered to the Lord in Waiting, who will announce the name to His Majesty. And those Gentlemen who are to be presented are hereby informed, it is absolutely necessary that their names, with the name of the Gentleman who is to present them (not the Lord in Waiting), should be sent in to the Lord Chamberlain's-Office, before twelve o'clock on Monday next the 1st of November, in order that they may be submitted for the King's approbation, it being His Majesty's command, that no presentation shall hereafter be made at the Levee, but in conformity with the above regulations.

The state apartments will not be open for the reception of company coming to Court, until half past one o'clock.

Those Gentlemen who are to be presented at the Levee, on Wednesday the 10th of November next, are to send their names to the Lord Chamberlain's-Office, according to the above regulations, before twelve o'clock on Monday the 8th of November.

THIS day the Lord Mayor of the City of Dublin, with a Deputation from that City, waited upon His Majesty to present to His Majesty the following Address, which His Majesty was graciously pleased to receive on the Throne :

To the KING's Most Excellent Majesty.

Sire,

WE, the Lord Mayor, Sheriffs, Commons, and Citizens of your Majesty's antient and loyal city of Dublin, approach your Majesty with every sentiment of respect and veneration.

We join in the universal sympathy of the nation, and cordially condole with your Majesty upon the severe affliction which has befallen your Majesty, in common with all classes of society, in the death of our late revered and beloved Monarch. His Majesty governed the United Kingdom during one of the most eventful and brilliant periods of British History. He entered upon his high functions amidst the glories of a war which has established this empire in the highest rank of nations; a long and salutary peace shed a milder lustre upon his latter years, and now that he hath finished his course of earthly splendour, we trust in the mercy of Almighty God that he has through a Saviour's merits exchanged his temporal Crown for one eternal in the heavens.

We beseech your Majesty to accept our most dutiful congratulations upon your auspicious accession to the Throne of these Realms; we have to assure your Majesty that we carefully cherish the principles of attachment and fidelity to the Royal Person, Crown, and Dignity which have from time immemorial distinguished our Corporation, and entirely confiding, Sire, in your Majesty's most gracious declaration, that you will maintain the reformed religion established by law, and protect the tights and liberties of your subjects; we earnestly pray the King of Kings to grant your Majesty health and long life to reign over an enlightened, a free, and a happy people.

In testimony whereof, we have caused the common seal of said city to be hereunto affixed, this 23d day of July 1830.

To the KING's Most Excellent Majesty.

Most Gracious Sovereign,

WE, your Majesty's most dutiful and loyal subjects, the Ministers and Elders of the General Assembly of the Church of Scotland, met in the Commission, beg leave, with every sentiment of high respect and warm attachment, to condole with your Majesty on the lamented death of our late illustrious and beloved Sovereign; an event which has placed these United Kingdoms in the deepest mourning, and has also drawn forth warm regret and sympathy from other Nations.

Looking back on the memorable and splendid events of the late reign, on the wisdom and firmness, under very trying circumstances, for which it will long continue to be distinguished, together with the love of moderation and peace which was eminently conspicuous down to its close; we also cordially cherish the recollection of our late Sovercign's respect for, and of his gracious bounty towards, the religious institutions of his kingdom; his munificent patronage of science and literature, and of the arts, which have thrown a lustre over his reign; and the fervency of those prayers which were put up for a life so precious and so endeared to his people during his last sufferings. While we desire humbly to submit to the uncrring will of God, we now beg leave to present our warmest and most respectful congratulations on the accession of your Majesty to the Throne of these kingdoms. We are grateful to God for his goodness to this highly-favoured and great nation, in raising up a Sovereign whose avowed and declared purposes are in such perfect accordance with the dearest wishes and best interests of his people; as well as with the mild paternal spirit of that government which, under your Majesty's revered ancestors, has been so greatly blessed to these united kingdoms. We cannot think without profound veneration of that race of Princes who have long swayed the sceptre of these realms on principles friendly to civil and religious liberty, and who have been the constitutional supporters, and the conscientious defenders of the Protestart reformed Churches established by law, not merely as bulwarks for the support of the Throne, but also for the maintenance of the high interests of true religion, associated with that righteousness which exalteth a nation.

Cordially attached as we are, and as the Church of Scotland which we represent has ever been, to your Majesty's revered illustrious House, and fully relying on that solemn constitutional pledge which your Majesty has been pleased to give, for maintaining inviolably the rights and privileges of the Church of Scotland, and the invaluable blessings of the Protestant faith in these United Kingdoms; we will perform with delight that high duty, which we deem sacred, of cherishing in the hearts of an enlightened and religious people, a spirit of respect and loyalty towards your Majesty, and of grateful attachment to your Royal House.

That the God and Father of our Lord and Saviour Jesus Christ may long preserve and abundantly bless your Majesty's life and reign, and that the divine grace and blessing may rest on the head of your Royal Consort, the Queen, whom Providence hath given to aftord a pattern of every conjugal and princely virtue; also, that the blessings of heaven may descend on all the Members of the Royal Family, is the united, most fervent, and affectionate prayer of your Majesty's most faithful, most loyal, and dutiful subjects, the Ministers and Elders of the General Assembly of the Church of Scotland.

Madam,

WE, the Members of the "Ladies Society for Manchester and its Neighbourhood, in aid of the cause of Negro Emancipation," respectfully approach your Majesty with sincere congratulations on your accession to the Throne of these realms as Queen Consort.

Ardently attached to your Majesty and to our beloved Monarch, we are truly thankful to Almighty God for having raised up a King whose delight is in his people; and for having endowed your Majesty with those excellencies which so pre-eminently qualify your Majesty to promote the happiness of our Sovereign and his people.

Participating by birthright in all the privileges of our excellent Constitution, protected equally from insult and injury by wise and salutary laws, the character of British Women is conspicuously raised. As wives and daughters, being the companions and not the slaves of men, with affections reciprocal and free, and possessing an influence in society unseen yet acknowledged, we feel ourselves involved in a more than common share of moral responsibility.

We would not unnecessarily excite painful feelings in your Majesty's benevolent mind, but we deem it our duty to implore the attention of your Majesty to the sufferings of the injured Africans and their degraded offspring. As British subjects, and as the professed disciples of Him who said, "Blessed are the merciful, for they shall obtain mercy;" and taught by our religion, that " righteousness exalteth a nation, but sin is a reproach to any people;" we cannot but regard the state of our slave colonies, and the condition of their population, with shame, horror, and dismay. Nearly one million of our fellow creatures, possessing immortal souls, enslaved for no crime, are oppressed with worse than Egyptian bondage, rated as chattels, driven as beasts, branded as criminals. Females, wives, and mothers, writhe beneath the lash of their cruel task-masters; children are torn from their parents, wives from their husbands, while the tie of conjugal affection, and the piteous cries of the children avail not with their oppressors. Thus, beings formed of the same blood as ourselves, exposed to the same infirmities of human nature, affected by the same fears, susceptible of the same hopes, redeemed by the same Saviour, and destined to the same eternity of blessedness or woe, are denied by men, bearing the Christian name, the common sympathies of life and the consolations of religion.

We will not disguise from your Majesty, that slavery is an accursed thing, which, so long as it continues, must render this country highly criminal in the sight of a righteous God, and is a stain on the national character of the deepest dye.

Our earnest prayer is, that God will influence the heart of His Majesty to take into his consideration the immediate abolition of slavery throughout his ample dominions.

Presuming on your Majesty's known condescension, we have ventured to solicit your Majesty's attention to the cause of suffering humanity; humbly beseeching your Majesty to present the prayer of this our address to our Gracious Sovereign, that it may obtain his favourable regard.

WHEREAS it hath been humbly represented unto the King, that, early on the morning of Friday the 22d day of October instant, a farmhouse, stable, and several out-buildings, together with a barn, containing a quantity of wheat, the property of Mr. Knight, of Borden, near Sittingbourne, in the county of Kent, were wilfully and maliciously set on fire and destroyed by some evil-disposed person or persons unknown;
