REGULATIONS TO BE OBSERVED AT THE KING'S LEVEF, AT ST. JAMES'S-PALACE.

The Noblemen and Gentlemen who propose to attend the Levee to be held on Wednesday next the 10th instant, are requested to bring with them two · cards with their names thereon written, one to be left with the King's Page in attendance in the Presence-Chamber, and the other to be delivered to · the Lord in Waiting, who will announce the name to His Majesty. And those Gentlemen who are to be presented are hereby informed, it is absolutely necessary that their names, with the name of the Gentleman who is to present them (not the Lord in Waiting), should be sent in to the Lord Cham-. berlain's-Office, before twelve o'clock on Monday next the 8th instant, in order that they may be submitted for the King's approbation; it being His Majesty's command, that no presentation shall hereafter be made at the Lever, but in conformity with the

above regulations; and further, that no person shall be admitted, on any pretence whatever, who has not been so presented.

It is particularly requested, that Gentlemen who are to be presented at the Levee will have their names *distinctly* written upon the card delivered to the Lord in Waiting, in order that there may be no mistake in announcing them to the King.

The state apartments will not be open for the reception of company coming to Court, until half past one o'clock.

HEREAS by an Act, passed in the sixth year of the reign of His late Majesty King George the Fourth, intituled "An Act to regulate the trade "of the British possessions abroad," it is, amongst other things, enacted, that certain ports, therein particularly mentioned, in the island of Januaica, and in the provinces of Nova Scotia, Canada, and New Brunswick, and in the island of Barbadoes, shall be free warehousing ports for the purposes of the said Act; and it is further enacted, that it shall be lawful

for His Majesty in Council, from time to time, to appoint any port in His Majesty's possessions in America to be a free warehousing port for the purposes of the said Act; and that every such port, so appointed by His Majesty, shall be a free warehousing port under the said Act, as if appointed by the same, in as full and ample a manner in all respects as any of the ports thereinbefore mentioned are free warehousing ports appointed by the said Act:

And whereas His Majesty doth deem it expedient, that the port of Sydney, in the island of Cape Breton, should be appointed a free warehousing port for the purposes of the said Act, His Majesty doth therefore, by and with the advice of His Privy Council, and in pursuance and exercise of the powers in him vested in and by the said Act of Parliament, order and appoint, that the said port of Sydney, in the island of Cape Breton, shall be a free warehousing port for the purposes of the said Act:

And the Right Honourable the Lords Commissioners of His Majesty's Treasury, and the Right Honourable Sir George Murray, one of His Majesty's Principal Secretaries of State, are to give the necessary directions herein as to them may respectively appertain. Jas. Buller.

PRESENT,

The KING's Most Excellent Majesty in Council.

THEREAS by a certain Act of Parliament, passed in the sixth year of the reign of His late Majesty King George the Fourth, intituled "An Act to " regulate the trade of the British possessions abroad," after reciting, that " by the Law of Navigation foreign " ships are permitted to import into any of the " British possessions abroad, from the countries to " which they belong, goods, the produce of those " countries, and to export goods from such posses-" sions to be carried to any foreign country what-" ever, and that it is expedient that such permission " should be subject to certain conditions," it is, therefore, enacted, " that the privileges thereby granted to " foreign ships shall be limited to the ships of those " countries which, having colonial possessions, shall " grant the like privileges of trading with those " possessions to British ships, or which, not having " colonial possessions, shall place the commerce " and navigation of this country, and of its posses-" sions abroad, upon the footing of the most favoured " nation, unless His Majesty, by His Order in " Council, shall in any case deem it expedient to " grant the whole or any of such privileges to the " ships of any foreign country, although the con-" ditions aforesaid shall not in all respects be fulfilled " by such foreign country:"

And whereas by a certain Order of His said late Majesty in Council, bearing date the twenty-seventh day of July one thousand eight hundred and twentysix, after reciting that the conditions mentioned and referred to in the said Act of Parliament had not in all respects been fulfilled by the Government of the United States of America, and that therefore the privileges so granted as aforesaid by the law of navigation to foreign ships, could not lawfully be exercised or enjoyed by the ships of the United States aforesaid, unless His Majesty, by His Order in Council, should grant the whole or any of such priviliges to the ships of the United States aforesaid : His said late Majesty did, in pursuance of the powers in Him vested by the said Act, grant the privileges aforesaid to the ships of the said United States; but did thereby provide and declare, that such privileges should absolutely cease and determine in His Majesty's possessions in the West Indies and South America, and in certain other of His Majesty's possessions abroad, upon and from certain days in the said Order for that purpose appointed, and which are long since passed :

And whereas by a certain other Order of His said late Majesty in Council, bearing date the sixteenth of July one thousand eight hundred and twenty-seven, the said last mentioned Order was confirmed : And whereas in pursuance of the Acts of Parliament in that behalf made and provided, His said late Majesty, by a certain Order in Council, bearing date the twenty-first day of July one thousand eight hundred and twenty-three, and by the said Order in Council, bearing date the twenty-seventh day of July one thousand eight hundred and twenty six, was pleased to Order that there should be charged on all vessels of the said United States, which should enter any of the ports of His Majesty's possessions in the West Indies or America, with articles of the growth, produce, or manufacture of the said States, certain duties of tonnage and of customs therein particularly specified :

And whereas it hath been made to appear to His Majesty in Council, that the restrictions heretofore imposed by the laws of the United States aforesaid upon British vessels, navigated between the said States and His Majesty's possessions in the West

Indies and America, have been repealed, and that the discriminating duties of tonnage and of customs, heretofore imposed by the laws of the said United States, upon British vessels and their cargoes entering the ports of the said States from His Majesty's said possessions, have also been repealed, and that the ports of the United States are now open to British vessels and their cargoes coming from His Majesty's possessions aforesaid, His Majesty doth, therefore, with the advice of His Privy Council, and in pursuance and exercise of the powers so vested in Him as aforesaid by the said Act so passed in the sixth year of the reign of His said late Majesty, or by any other Act or Acts of Parliament, declare, that the said recited Orders in Council of the twenty-first day of July one thousand eight hundred and twenty-three, and of the twenty-seventh day of July one thousand eight hundred and twenty-six, and the said Order in Council of the sixteenth day of July one thousand eight hundred and twenty-seven (so far as such last mentioned Order relates to the said United States), shall be, and the same are, hereby respectively revoked:

And His Majesty doth further, by the advice aforesaid, and in pursuance of the powers aforesaid, declare that the ships of and belonging to the said United States of America, may import from the United States aforesaid into the British possessions abroad, goods the produce of those States, and may export goods from the British possessions abroad to be carried to any foreign country whatever.

THIS day His Grace the Archbishop of Canterbury, with a Deputation from the Clergy of the Province of Canterbury, waited upon His Majesty to present to His Majesty the following Address, which His Majesty was graciously pleased to receive on the Throne :

To the KING's Most Excellent Majesty.

Most Gracious Sovereign,

WE, your Majesty's dutiful subjects, the Archbishop and Bishops and Clergy of the Province of Canterbury, in Convocation assembled, most humbly desire permission to approach your Majesty with hearty assurances of our affection and loyalty, and congratulations on your Majesty's accession to the Throne of this Realm.

At the same time we entreat your Majesty to accept the expression of our sincere condolence on the demise of the late King, whose adherence to the sound constitutional principles hereditary in his illustrious family, was on all occasions evinced by the mildness and equity of his government, his regard to the rights of his subjects, and his attachment to our ancient institutions in church and state.

Having been accustomed to look up for protection to the King, as being, under God, the chief defender of our Apostolic faith, we gladly embrace this opportunity of expressing our gratitude for the assurances which your Majesty has repeatedly been pleased to give of belief in the doctrines and concern for the interests of our holy religion, of respect for the ordinances of the church, determination to uphold her rights, and favourable disposition towards her ministers.

Nor can we advert without lively satisfaction to the proclamation issued by your Majesty, declaring your Roval purpose and resolution to discountenance and punish all manner of vice, profaneness, and immorality, and to distinguish persons of piety and virtue by marks of your Royal favour.

The confidence inspired by the déclaration of your Majesty's sentiments on these important points, is farther increased, when we reflect on the exemplary virtues of the illustrious partner of your Thrane. In contemplating this bright pattern of femenine excellence in the person of Her Majesty, we are led to anticipate the happiest consequences from its effects on the character of her sex, more especially in that elevated rank, where it is most exposed to observation, and has the greatest influence on society.

To these circumstances we attach the highest importance, whether we consider the attacks so frequently made on the faith, the discipline, and the government of the church, which never stood more in need of support and protection than at the present time, or the disregard to the commandments of God, and the laws of the land, which we fear is rapidly spreading, with unspeakable injury, to the principles of the whole population, and more espe-cially of the young and ignorant. In regard, Sir, to this latter point, we are satisfied that, if all persons of rank and authority would shew by their conduct a sincere respect for religion, their example would greatly contribute to the general reformation of manners, as well by its immediate influence on public opinion, as by its tendency to promote the due execution of the laws against open impiety and profligacy, the dissemination of licentious publications, and the profanation of the Lord's day.

Yet, Sir, we are sensible that the maintenance of true religion and virtue,' so essential to social order, and the happiness of all classes, must principally depend on the clergy, on the soundness of their faith, the efficacy of their teaching, and the holiness of their lives : and we should esteem ourselves wholly unworthy of the privileges assured to the church, with a view to the general good, if we ceased to labour with assiduous zeal in the performance of our sacred duties. It will, therefore, be our constant endeavour, not only to instruct, reprove, and exhort with all diligence and earnestness in the ordinary exercise of our ministry, but to assist in the diffusion of truth, the advancement of piety, the discouragement of enthusiasm, and the reformation of vice, wherever our influence extends. And whilst, as in duty bound, we stand forward in defence of the faith, and the refutation of erroneous doctrines, we shall strive to regulate our temper and conduct by the laws of Christian charity respecting the motives of honest opponents, replying with meekness and gentleness to adversaries of a different character, and allowing liberty of conscience to all men

If Sir, there are any among us, who have disgraced their holy profession by scandalous neglect of their duties, or offences against morality, we can truly affirm that their conduct is regarded with grief and abhorrence by the great body of the clergy; and we look forward with satisfaction to the result of the enquiry, now in progress under your Majesty's sanction, into the state of the ecclesiastical law, in the confidence that effectual provision will be made for the speedy correction of such enormities in f ture.

In conclusion, we venture to assure your Majesty, that as well in our collective capacity, as in our several stations in the church, we shall invariably make it our object, so to perform our duties as to deserve the protection of our Sovereign, and the approbation of all good men. And we trust that, through the blessing of the Almighty on our labours, this kingdom may be for ever preserved from those visitations of God's displeasure, which are, sooner or later, occasioned by the decay of picty and corrup-tion of morals. We may, then, with all humility hope for acceptance, when we offer up our prayers on behalf of your Majesty, that the spirit of wisdom and strength, through whom Kings reign, and Princes decree justice, may direct and prosper your Majesty's counsels, and dispose the hearts of your people to willing obedience, from a sense of religious obligation, veneration for lawful authority, and gratitude for the blessings enjoyed under your Majesty's paternal government.

To which Address His Majesty was pleased to return the following most gracious Answer :

" I cordially thank you for this loyal and dutiful Address.

"The sentiments which it expresses, and the assurance which it conveys, of your affectionate attachment to my Person, and to that of my beloved Consort the Queen, are most acceptable to me, and most gratifying to my feelings.

"You may rely on my constant favour and protection, and on my zealous co operation in all your efforts to promote the great cause of piety, of morality, and religious truth.³¹

"I consider the Established Church one of the main defences of the civil and religious liberties of my people,—and I an bound by the firmest conviction of their importance, as well as by the most solemn engagements, to support and defend the rights and privileges of the church."

To the KING's Most Excellent Majesty.

WE, the President, Vice-Presidents, Directors, and Guardians of the Caledonian Assylum, incorporated by Act of Parliament, for supporting and educating the Children of Soldiers, Sailors and Marines, Natives of Scotland, who have died or been disabled in the service of their country, and of Indigent Scotch. Parents resident in London, not entitled to Parochial Relief, approach the Throne penetrated with the most profound grief for the loss which the country and your Majesty's illustrious Family have sustained by the death of our late most gracious Sovereign. To the memory of a Prince who was endeared to his people, who proved himself the patron of art, the friend of science, and the promoter of literature,: we would here offer our grateful tribute of respect. The generous interest which he was pleased to express in our institution, and the munificent patronage with which he honoured it, shall ever live in our remembrance.

But, while we deeply deplore his loss, and most sincerely participate in the sorrow which fills every bosom throughout the United Kingdoms, we are consoled with the cheering conviction, that the sovereignty of these realms has devolved on a Prince animated with truly British feelings, ardent in the cause of humanity, zealous for our country's weal, and impressed with a deep and sacred reverence for the principles of our free and glorious constitution.

While, with sentiments of the warmest affection and loyalty, we congratulate your Majesty on your accession to the Crown of these Kingdoms, we hail the event with gladdening anticipations, in the firm persuasion that the comfort, the prosperity, the rights, and the happiness of every class of your Majesty's subjects will be to your Majesty objects of truly paternal solicitude.

The objects for which the Caledonian Asylum was established, under the auspices of your Royal Predecessors, and the active concurrence and munificent assistance of several of your illustrious Brothers, will, we humbly trust, meet the approbation of your Majesty's benevolent heart; and we indulge a sanguine hope that your Majesty will not consider this institution unworthy of your Royal countenance, and that your Majes y will be graciously pleased to sanction it by permitting your Royal Name to be inserted in the records of the Corporation as Patron of the Caledonian Asylum, an honour which would undoubtedly promote the welfare and advance the prosperity of the charity.

That your Majesty, to whose counsels the Great Arbiter of the Universe has committed the destinies of , this mighty empire, may long sway the sceptre over a free, happy, and united people, is the fervent prayer of your Majesty's most devoted and loyal subjects.
