NOTICE is hereby given, that His Majesty will hold a Levee at St James's-Palace, on Wednesday the 24th instant, at two o'clock.

REGULATIONS TO BE OBSERVED AT THE KING'S LEVEE, AT ST. JAMES'S-PALACE.

The Noblemen and Gentlemen who propose to attend the Levee to be held on Wednesday the 24th instant, are requested to bring with them two cards with their names thereon written, one to be left with the King's Page in attendance in the Presence-Chamber, and the other to be delivered to the Lord in Waiting, who will announce the name to His Majesty. And those Gentlemen who are to be presented are hereby informed, it is absolutely necessary that their names, with the name of the Gentleman who is to present them (not the Lord in Waiting), should be sent in to the Lord Chamberlain's-Office, before twelve o'clock on Monday next the 22d instant, in order that they may be submitted for the King's approbation; *it being His Majesty's command, that no presentation shall hereafter be made at the Levee, but in conformity with the above regulations; and further, that no person shall be admitted, on any pretence whatever, who has not been so presented.*

It is particularly requested, that Gentlemen who are to be presented at the Levee will have their names *distinctly* written upon the card delivered to the Lord in Waiting, in order that there may be no mistake in announcing them to the King.

The state apartments will not be open for the reception of company coming to Court, until half past one o'clock.

Most Gracious Sovereign,

We are now assured that the patronage of our Fraternity will still remain in the hands of the Sovereign of these Realms; and we are graciously permitted to hail your Majesty as the Patron and Protector of the Craft.

Our sense of duty to your Majesty's sacred Person, our zeal for the best interests of Masonry, and our anxiety for the welfare of our common country, alike demand from us our sincere and heartfelt congratulations upon your Majesty's accession to the Throne of your Ancestors. The gracious declaration made by your Majesty in Council on ascending the Throne of these Realms, fills our minds with joy, and inspires us with firm confidence that your Majesty, in reigning over a people, loyal from principle, as well as from affection, to your Royal Person, will be influenced by the rule of government which distinguished the reign of your Majesty's revered Father and illustrious Brother. The dutiful and loyal Address of the Noblemen, Freeholders, Justices of the Peace, and Commissioners of Supply of the County of Linlithgow.

May it please your Majesty.

WE, your Majesty's most dutiful and loyal subjects, the Noblemen, Freeholders, Justices of the Peace, and Commissioners of Supply of the County of Linlithgow, beg leave to approach your Majesty's Throne, with mingled sentiments of sorrow and congratulation, on the recent events which have so deeply interested the feelings of this country, and of its extensive dependencies.

We condole with your Majesty on the demise of our late Most Gracious Sovereign, George the Fourth, a Monarch under whose Regency and Reign, the Empire attained a glory in war more brilliant and splendid than any that had ever been recorded in the annals of this kingdom; and the latter years of whose prosperous rule were occupied in realizing the blessings of peace, by the improvement of our laws, and by the most liberal patronage of learning and the arts.
